**COMMANDERY ENDOWED MEMBERSHIP PAYMENT PLAN**

- ✓ Installments of \$100.00 may be made to the Grand Commandery. Endowed membership will become effective on the 1<sup>st</sup> of January of the second year after the final installment is made.

**LIFE MEMBERSHIP COST**

- ✓ The cost of an Endowed Membership is **\$500.00.**
- ✓ The fee shall be forwarded to the Grand Recorder no later than December 31.
