MISSOURI PRIORY NO. 17 KNIGHTS OF THE YORK CROSS OF HONOUR

Minutes, July 16, 2022

Following the 6:30 a.m. breakfast at the Capital Plaza Hotel, the meeting was opened at 7:15 a.m. with the following officers present:

The opening prayer was offered by Knight Dale R. Roller, there were a total of 50 members and guests in attendance.

Eminent Prior Snyder introduced several distinguished guests: Knight Timothy P. Israel of Oklahoma Priory No. 9; Knight Corey F. Curtiss – Eminent Prior of Michigan Priory No. 22; Knight Rusty M. Ludlum, Past Prior of Missouri Priory No. 17 who now resides in Florida; Knight Joseph J. Anderson – Eminent Prior of Minnesota Priory No. 24; and Knight John L. Logan – Past Prior of Oklahoma Priory No. 9, District 12 Representative and official representative of Most Eminent Glen A. Cook, Grand Master General of the Convent General of the Knights York Cross of Honor.

The minutes of the July 17, 2021 minutes were read and approved as amended. (Amended Aaron Trent Moreland's name to Kirby Trent Moreland)

Eminent Prior Snyder called for the election of candidates. Registrar pro-tem Sample reported that the name of Christian Michael Jessen was withdrawn by the Proposer. It was additionally announced the Candidate Jeffrey Lee Knight was being proposed for dual membership as he is already a member of Illinois Priory No. 11 (I believe). The list of proposed candidates as amended were elected to membership.

Eminent Prior Snyder called for the report of the Nominating Committee. Knight Sample provided the report, recommending advancement of the line of officers, recommending Knight Kevin B. Sample as Registrar, and recommending Knight Harold F. Coots as Harold. The motion was made and seconded to accept the Nomination Committee report, was unanimously approved.

There was discussion regarding the July 16 annual meeting in Jefferson City, specifically regarding the lecturers. The following were selected: Lodge – Stanton T. Brown; Chapter – Robert W. Schlichter; Council – Todd A. Schulze; and Commandery – Michael C. Rohman.

Not positive about the subject of conversation, but it was reported that Knight Eldon L. Cobb was deceased (verified deceased on 2/15/2019 in MMS).

There was discussion regarding coins. It was moved by Knight Day and seconded by Knight Riepe that we authorize up to \$1,000.00 for coins to be struck, with the distribution as was approved last year, half to the Missouri Lodge of Research Foundation and half to the Norris Cotton Cancer Center. Motion was approved.

Knighting Certificates were presented to those in attendance. Knight Harry Lee Tripp, Jr. was presented with his Grand Commandery quadrant jewel.

Knight John L. Logan, District 12 Representative and official representative of Most Eminent Glen A. Cook, Grand Master General of the Convent General of the Knights York Cross of Honor presented remarks. Of note, he suggested that Missouri Priory No. 17 consider annual donations for Norris Cotton Cancer Center, and he indicated his appreciation for our candidate election process.

The Registrar pro-tem reminded the By-Laws and Audit Committee of their need to report at the Annual meeting.

No further business remaining, the Priory was closed in short form at 7:45 a.m.
