I wish to thank all of the Sir Knights who have allowed me to serve this year as your Grand Commander. It has truly been the honor of my lifetime to serve in this capacity and I will never forget your kindness that you have showed me while advancing in the Grand Commandery line. I also want to thank my wife, Janet, and daughter, Stephanie, for their love and support during this adventure.

NECROLOGY

During the 2020-2021 reporting year, our Grand Commandery has had 114 Sir Knights lay down their swords and join their Master in Heaven. Among the 114 were two Right Eminent Past Grand Commanders. Sir Knight Harold Jewell Richardson (1997-1998) who passed away on October 7, 2020 and Sir Knight Marvin Walter Frost (2006-2007) who passed away on October 27, 2020.

Let us pay our respect to our departed Sir Knights. Our memorial service will be led by Sir Knight David D. Powell, Eminent Grand Prelate.

GENERAL ORDERS

For the 2020-2021 term, I issued 4 General Orders for the reasons given below.

- **General Order No.1** – Restricting Templar meetings to virtual only.
- **General Order No. 2** – Grand Commandery Membership Committee continuation from 2019-2020 year with the same Chairman and members.
- **General Order No. 3** – Phased reopening of Templar meetings guidelines and prohibiting Phase Two openings.
- **General Order No. 4** – Allowing Phase Two openings.

DISPENSATIONS GRANTED

For the 2020-2021 term, the following dispensations were granted.

- **Ascalon Commandery No.16:** to continue to meet in the DeMolay Room in the Scottish Rite Cathedral as their temporary meeting location - Granted.

- **Ascalon Commandery No. 16:** to hold an open installation of the new officers at a public meeting place and not at their temporary meeting place which is not suitable to perform the ceremony of installation - Granted.
- **St. Johns Commandery No.20:** to temporarily relocate their regularly stated meeting place until a new permanent meeting location is selected and approved - Granted.

DISPENSATIONS GRANTED

For the 2020-2021 term, the following dispensations were rejected.

- **Oriental Commandery No. 35:** to meet on the first Friday of odd numbered months of the year beginning March 5, 2021 until the Commandery can amend its by-laws. The Laws and Regulations make no provision for a Commandery to temporarily change the meeting time for their regular stated conclave.

BY-LAW AMENDMENTS

For the 2020-2021 term, the following amendments were approved.

- **Palestine Commandery No.16:** to amend ARTICLE VI, Section 2. DUES from annual dues of \$40.00 to \$20.00.
- **Ely Commandery No.22:** to amend Article V Fees and Dues, Section 12. Dues to read "The annual dues of this Commandery shall be \$20.00, plus Grand Commandery per capita and fees, rounded up to the next whole dollar amount, payable in advance on the first day of January and shall become delinquent if not paid on the first day of July following. Dues may be remitted for 50 years of membership."

DECISIONS

For the 20220-2021 term, the following decisions were made.

DeMolay Commandery No.3 Annual Return dispute

DeMolay Commandery disputes a knighting fee and per capita fees on two SK's from 2019 Annual Return. They had asked for an extension to the filing deadline to have time to settle the dispute. The Grand Recorder suggested a payment plan which would give them time to sort through the matter. DeMolay rejected the payment plan, deducted the disputed amount from the annual return and physically delivered the annual return to the Grand York Rite office. The Grand

Recorder attached a \$50 late fee to the annual return. The Grand Recorder answered the dispute stating that the two Sir Knights were suspended in 2019 and that no per capita was charged for them and that the knighting fee in question may have already been paid, but not accounted for correctly and offered suggestions as to where they might find proof of payment in previous years. DeMolay is asking for relief of the \$55.40 in fees and the \$50 late fee for a total of \$105.40. DeMolay submitted a copy of the MMS Activity Report that lists records modified by date.

Decision

Since 2016 it has been the duty of the recorder or IT person of each Commandery to make adjustments to the records of their members and specifically make sure that before December 31st of each year that the MMS records reflect the Sir Knights that are in good standing with their Commandery. It is not the duty of the Grand Recorder to adjust these records for per capita payments. However, if a recorder is having problems making the adjustments, the Grand York Rite office will help on a case by case basis, but they can not make adjustments after December 31st for that year's per capita. The Grand Commandery must follow the Grand Encampment rules which are why the Grand Chapter and Grand Council can do things that the Grand Commandery is unable to do. Furthermore, a review of the MMS records shows that these two knights were not on the list of knights that was used to base the 2019 per capita. Given the situation, I can not waive the \$45.40 portion of the disputed fees and they are still due and payable to the Grand Commandery. As to the knighting fee of \$10, I waive that fee and have directed the Grand Recorder to issue a \$10 credit to your next annual return. In the matter of the \$50 dollar late fee, complete annual returns are due by the due date. I find no provisions in the Laws and Regulations that allows an extension. The Grand Recorder offered a payment plan which would act as an extension, but it was not used by DeMolay. Because DeMolay submitted the annual return on time, but not with the correct payment amount, they were assessed a late fee. Under normal circumstances, I would let the late fee stand, but since this matter was not dealt with in a timely manner, I waived the late fee.

St. Johns Commandery No.20 – Masonic York Rite Temple Association building sale issue

In March 2021, I was made aware that the Masonic York Rite Temple Association had sold the temple building and that St. John's Commandery No.20 was needing a dispensation to meet at a new location. Nearly on the same day, I was notified that the Eminent Commander of St. Johns Commandery in behalf of the Commandery had joined into a lawsuit to stop the sale of the building. I received minutes of a virtual meeting held in June 2020 where the members voted to sell the building and gave the Eminent Commander the authority to vote at the temple board meeting. This information was conveyed to the Templar Jurisprudence Committee for their review and guidance.

I was informed that, at the regular stated conclave on March 29, 2021, the Commandery voted against the lawsuit and instructed the Eminent Commander to remove St. John's Commandery from the lawsuit and he indicated he would.

On May 10, 2021, I received information that there were no changes made in the litigation against the Masonic York Rite Temple Board. I notified the Chairman of the Templar Jurisprudence Committee of this development. On May 14, 2021, I received from the Templar Jurisprudence Committee a copy of the voluntary dismissal filed in behalf of St. Johns Commandery. As such, I was not required to make a decision in this matter.

CHARTERS

For the 2020-2021 Term, the following Charters were surrendered or revoked.

- **July 2, 2020:** Mountain Grove Commandery No. 66 surrendered their charter.

TIME CAPSULE

On May 14, 2021, I traveled to Branson, Missouri in order to inspect the time capsule. I found the site and structure to be in good shape and well maintained.

REGIONAL CONCLAVES

Due to the COVID-19 pandemic, all in-person gatherings were canceled including our usual regional conclaves. After discussing this issue with the line officers we decided to conduct four regional conclaves virtually by WebEx. These conclaves were held on October 3, 2020, October 24, 2020, November 14, 2020, and December 5, 2020. The presentations and presenters were the same for each conclave. I would like to acknowledge and thank the following presenters for their time and dedication in making these regional conclaves a big success: SK

Kevin B. Sample, SK Russell S. Hanson (PGC), SK Donald L. Trabue (PGC), SK Gregory J. Walker, and SK Bobbie E. White.

BRIGHT KNIGHT PROGRAM

The Bright Knight Program was developed by SK Michael C. Rohman during SK Clark A. McLemore's year as Grand Commander and made its debut in the latter part of 2020. The Bright Knight Program is presented monthly by SK Rohman and has been well received by those who have attended it.

In an effort to keep the Grand Line Officers informed about issues within the Grand Commandery, I continued the monthly Grand Officers virtual WebEx meetings.

- 2.** I recommend the continuation of monthly meetings of the Regional Grand Commanders to allow discussions of important matters and to allow the Regional

Grand Commanders to inform the Grand Commander and Grand Commandery Officers about what needs to be addressed in their regions.

3. I recommend that at least two in person meetings should be held with the Grand Officers and the Regional Grand Commanders to instruct the Regional Grand Commanders in the proper manner in which Commanderies may open their conclaves. There are bound to be problems in conducting these rituals because of the pandemic recess.

CONCLUSION

In closing, I want to thank all of the Sir Knights for the respect that they have shown to me and the office of Grand Commander. May God bless you and keep you safe.

PROPOSAL TO AMEND THE **LAWS AND REGULATIONS** OF THE GRAND COMMANDERY OF KNIGHTS TEMPLAR OF THE STATE OF MISSOURI TO READ AS FOLLOWS:

ARTICLE II - The Grand Officers, Section 27. The Grand Commander.

The Grand Commander shall have the following specific powers and duties, but the enumeration shall not be deemed a limitation thereof:

M. Appoint an auditor examiner, who shall immediately prior to the annual conclave examine and audit review the accounts and vouchers of the Grand Recorder and Grand Treasurer and certify the facts as found, to the Grand Commandery. The Grand Commander shall perform such other duties as the

nature of his station may require, or the ceremonies of the Grand Commandery may require. (Amended ??/??/??)

In the event of disability of either the Grand Treasurer or Grand Recorder, he will direct the Finance Committee (see Sec. 36(d)) to retain a qualified auditor examiner not previously involved who shall expeditiously perform a complete audit examination of all pertinent records. PROPOSAL TO AMEND THE **LAWS AND REGULATIONS** OF THE GRAND COMMANDERY OF KNIGHTS TEMPLAR OF THE STATE OF MISSOURI TO READ AS FOLLOWS:

ARTICLE VI - Chartered Commanderies, Section 117. Annual Reports and Per Capita Payment.

On or before December 31 each year, Commandery Recorders will submit to the Grand Recorder a complete list of remissions for their Commandery to include the member's full name and type of remission in accordance with **Section 171. Members May Not be Exempted.** On or before February 1 each year the previous reporting year along with a per capita bill for the calculated fees due the Grand Commandery. The bill will include appropriate fees and credits. Fees shall consist of Knighting Fees, Per Capita and any outstanding balances from the previous year's return. Credits shall consist of approved Remissions and Endowed Memberships as verified by the Grand Recorder, along with any overpayments from the previous year's return. A Financial Report Form and an Annual Audit Inquiry and Examination Committee Form (see **Section 119. Annual Audit Examination of Commanderies.**) will also be included as part of the Annual Return. Each Commandery shall forward to the Grand Recorder on or before March 1st in each year all forms and a check or money order for the per capita payment, based on the annual statistical report and per capita bill provided by the Grand Recorder, and due from said Commandery, and a copy of the latest IRS Form 990 or a copy of the acceptance of the electronic submission of a Form 990N. The fiscal year of the Grand Commandery shall end May 31st of each year, and all accounts shall be closed on that date. A commandery failing to file a complete return as provided herein and to forward per capita payment by March 1st subjects itself to a fine of fifty dollars (\$50.00). Any Commandery that does not submit a complete annual return to the Grand Recorder's office not later than thirty (30) days prior to the Annual Conclave of the Grand Commandery shall

forfeit all rights and privileges to representation and voting at the Annual Conclave. (Amended 6/9/17, 6/9/18, ??/??/??)

Item No. 1C

PROPOSAL TO AMEND THE **LAWS AND REGULATIONS** OF THE GRAND COMMANDERY OF KNIGHTS TEMPLAR OF THE STATE OF MISSOURI TO READ AS FOLLOWS:

ARTICLE VI - Chartered Commanderies, Section 119. Annual Audit Examination of Commanderies.

Each commandery under the jurisdiction of this Grand Commandery shall on or before the 1st day of March of each year make, on standard forms furnished by the Grand Recorder, a financial report and an ~~audit~~ examination report of the books, finances and property of the commandery and transmit by mail a copy of same to the Grand Recorder. ARTICLE XX - Instruction, Inspection, and Regional Activities, Section 224. Authority of Inspection Officer.

The Officer shall have authority to inspect (including audits Inquiries and Examinations, rituals, and investments) each commandery in his Region. Inspection should be made between the time officers of constituent commanderies are installed and the conclave of the Grand Commandery; provided that if for reason satisfactory to the Grand Commander, the proxy, preferably a Grand or Past Grand Officer, to act for said Inspecting Officer. On conclusion of the inspections the Inspecting Officer shall immediately prepare and forward to the Grand Commander a report upon the Region as a whole. (Amended ??/??/??)

~~Whenever a member shall fail~~ fails to pay his dues at the time when the same become delinquent ~~on or before March 1 of each year~~ the Recorder ~~recorder~~ shall must notify him the member in writing of such his delinquency by delivering to him, or causing to be delivered by a Knight, a bill for such indebtedness, or by mailing the same in a sealed envelope addressed to him at his present or last known place of residence ~~on or before March 11~~. ~~Should the delinquent refuse or fail~~ If, after notice, the member fails to pay his dues within twenty days after the issuance of such notice, it shall be the duty of the Recorder to notify the Commander of such failure, who shall, at the next stated conclave of the commandery, order a notice to be given the delinquent by the Recorder, requiring him to appear at a specified subsequent stated conclave, to show cause why he should not be suspended for non-payments of dues ~~on or before April 1~~, he is automatically suspended for non-payment of dues. The suspension should be recorded by the recorder in the minutes of the first meeting of the Commandery thereafter.

Such notice shall be served by the Recorder by delivering, or causing to be delivered by a Knight, to the delinquent a copy of the same, or by mailing it to him in a sealed envelope addressed to him at his present or last known place of residence at least ten days prior to the time he is to appear.

Should the delinquent fail to appear, his dues still remain unpaid, or the same be not remitted for good cause, or the time of payment extended, by a majority

~~vote of the members present, the Commander, upon proof of notice and the fact of arrearage, shall put the question: "Shall Sir _____ be suspended for non-payment of his dues?" which shall be determined by a paper ballot or vote of the commandery; and if a majority of those present vote "yes", the Commander shall declare the Knight suspended until his dues are paid. The delinquents may be balloted on or voted on by the commandery individually or collectively.~~

STATEMENT OF PURPOSE: A Sir Knight's dues should be paid by December 31st of each year. The length of time a Sir Knight has to pay his dues is longer than necessary. Shortening the time to pay dues will make the Recorder's job easier, and give each Commandery better control over their finances and budgets, and matches Grand Lodge of Missouri dues payment bylaws. REPORT OF FINANCE AND ACCOUNTS COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

The Finance and Accounts committee participated in the multiple financial review WebEx meetings held by the Grand Commandery Officers during the fiscal year. The Grand Recorder provided instruction on how the General Fund financial records on the Grand York Rite DropBox cloud storage system were kept. The committee was given full view-only access to all 2019-2020 and 2020-2021 General Fund financial records. A financial review of the Grand Recorder's records was an item on agenda of the July 2020 (reviewed June 2020 records), November 2020 (reviewed July 2020 - September 2020 records), January 2021

(reviewed October 2020 - December 2020 records), April 2021 (reviewed January 2021 - March 2021 records), and May 2021 (reviewed April 2021 records). The committee is satisfied that the Grand Recorder and the Grand Treasurer are doing an exceptional job handling the monies and maintaining the financial records of the Grand Commandery.

The committee reviewed and discussed the investment strategy of the Grand Treasurer. While the Grand Treasurer had begun to be bit more aggressive in making investments, the issues with the investment environment caused by the COVID-19 impact slowed implementation of the overall investment strategy. The committee continued to urge the Grand Treasurer to be more aggressive in making investments.

With the assistance of the Grand Recorder and the Grand Treasurer, the committee prepared a proposed budget for the ensuring year. The committee met with the Grand Line Officers and secured their approval of the proposed budget. The committee is pleased to report that the proposed budget shows a surplus due to the \$6.00 increase from 2019 as well as a slight reduction in expenses over last year's budget.

It should be noted that last year's \$10.00 per capita increase will not be received by the Grand Commandery until next year.

The committee continued to review the next 5-year projections of membership, income, and expenses. Those projections show our per capita paying membership continuing to decline.

The budget is subject to change if the proper requesting procedures are followed and with the approval of the Finance and Accounts committee.

REPORT OF GRAND RECORDER

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

As my tenth and final year as your Grand Recorder draws to a close, I believe that Debbie and I have smoothed out the workload of the job. The division of labor between Sir Knight Kevin B. Sample, Grand Secretary of the Grand Chapter and Grand Recorder of the Grand Council, continues to move the operation of the office forward. Debbie, Kevin, and I are continuing to resolve legacy issues as well as to cope with the constant flow of information into the Grand York Rite Office.

This past year we have continued to realize the full impact of our efforts to modernize the operation of the office. Debbie continues to be instrumental in dealing with the day to day operations of the office. The MGYR web site continues to be maintained under the care of Sir Knight Donald MacCormick,

MGYR Web Master. Bringing the Grand York Rite of Missouri into the 21st Century continues to be our constant theme.

I am anxious to pass the job of Grand Recorder to someone else. It is my hope that the Sir Knight chosen to be the next Grand Recorder will be my trainee, Sir Knight Roger D. Fleeer, PGC. We have been working together for about three years and I believe he is ready and willing to take on the job. Please keep in mind that Roger is being added to the Grand York Rite business plan. I will still be working for the Grand Commandery with Roger to make sure everything gets done. I will also still be working for the Grand York Rite in my regular role as part of the business plan. It is my hope that this transition will be very smooth.

One question that comes up in association with relinquishing the Grand Recorder's job to someone else concerns Debbie. Debbie plans to stay on as the Executive Assistant for a couple of years. It is her intent to transition the office to a new Executive Assistant after the 2024 Grand Sessions.

The Grand Commandery has completed its fifth year using the current annual reporting system. The 2020 Annual Reports and Per Capita Bills were based on the Missouri membership data in MMS, information from the Grand Commandery records, and information from the Commanderies.

The 2020 Annual Returns are more completely reviewed and analyzed in the Report from the Committee on Returns of Commanderies and your attention is directed to that report in the preliminary proceedings.

Overall, the response this year was very good. Only one of our twenty-nine Missouri Commanderies failed to file a 2020 Annual Return and pay their 2020 Per Capita Bill. One Commandery short paid their per capita bill. Six Commanderies paid their per capita bill late. However, one of the six late paying Commanderies improperly paid the late fee instead of following instructions that all late fees would be charged on their 2021 Per Capita Bill. Not following instructions causes more work for the Grand Recorder. The unpaid per capita for the rest of the Commanderies will be added to their 2021 Per Capita Bills. The Grand Commandery is currently \$831.60 short of collecting the \$37,557.60 owed to it by the Commanderies.

The Grand Commandery of Missouri saw no overall growth in membership during calendar year 2020. The following Commanderies receive an honorable mention for having no net loss reported: Emmanuel Commandery No. 7, Ivanhoe Commandery No. 8, Palestine Commandery No. 17, Constantine Commandery No. 27, and Malta Commandery No. 72. Cape Girardeau Commandery No. 55

added one Sir Knight as indicated on their 2020 Annual Report. They started out with 54 members, added one, and finished the year with 55 members – a growth of 2%. In conformity with Standing Resolution No. 10 of the Laws and Regulations of the Grand Commandery of Missouri, we acknowledge their accomplishment with the Grand Commandery Growth Award.

It is sad to report that the Grand Commandery of Missouri lost one Commandery during calendar year 2020. The Charter of Mountain Grove Commandery No. 66 was arrested on July 2, 2020 after a valiant battle to remain a viable Commandery.

Two years ago, ARTICLE XXIII, Masonic Membership Solutions (MMS) was added to the Laws and Regulations of the Grand Commandery of Missouri. Section 236 Commandery Recorder Responsibilities, paragraph D, specified that "Recorders and IT Representatives shall log into MMS no less than monthly to maintain access credentials and to make any approved membership changes." Based on user login statistics from MMS for June 2020 through May 2021, the following Commanderies were in violation of Section 236: No Logins – Ascalon Commandery No. 16; Did Not Login Every Month – Excalibar Commandery No. 5 (missed 5 months), Liberty Commandery No. 6 (missed 1 month), Emmanuel Commandery No. 7 (missed 3 months), O'Sullivan Commandery No. 15 (missed 2 months), Palestine Commandery No. 17 (missed 2 months), Godfrey de Bouillon Commandery No. 24 (missed 8 months), Constantine Commandery No. 27 (missed 2 months), Prince of Peace Commandery No. 29 (missed 2 months), Jasper Commandery No. 31 (missed 2 months), Oriental Commandery No. 35 (missed 2 months), Bethany Commandery No. 42 (missed 2 months), St. Elmo Commandery No. 43 (missed 1 month), Cape Girardeau Commandery No. 55 (missed 1 month), DeSoto Commandery No. 56 (missed 1 month), Neosho Commandery No. 57 (missed 5 months), Rolla Commandery No. 59 (missed 1 month), Poplar Bluff Commandery No. 67 (missed 4 months), and Malta Commandery No. 72 (missed 9 months). Eleven Commanderies were in full compliance with Section 236 during the year: DeMolay Commandery No. 3, .Hugh de Payens Commandery No. 4, Ivanhoe Commandery No. 8, Kansas City Commandery No. 10, St. Graal Commandery No. 12, St. John's Commandery No. 20, Ely Commandery No. 22, Constantine Commandery No. 27, Lebanon Commandery No. 33, Ascension Commandery No. 39, and Westport Commandery No. 68.

In conclusion, Debbie and I thank everyone for their continued support. While Debbie cannot do everything that Kevin and I can do, she has truly become the

Executive Assistant. We are all committed to and are striving for improved operations in the ensuing year.

REPORT OF HOSPITALER COMMITTEE

- Ely Commandery No. 22 held a virtual conclave on the evening of December 10, 2020, during which they read the Grand Commandery/Grand Encampment Christmas Messages;
- Prince of Peace Commandery No. 29 read the Grand Commandery/Grand Encampment Christmas Messages during a virtual meeting;
- Oriental Commandery No. 35, due to COVID-19 restrictions still being in place, celebrated Christmas with their families in their own manner; and
- Ascension Commandery No. 39 read the Grand Commandery/Grand Encampment Christmas Messages during a virtual meeting.

The following Commanderies reported no activity due to the COVID-19 pandemic:

- Cape Girardeau Commandery No. 55,
- DeSoto Commandery No. 56, and
- Neosho Commandery No. 57.

The following Commandery reported Easter Observance Activity:

- Hugh De Payens Commandery No. 4 shared the Grand Commandery Easter Message with its members.

The Bright Knight Program implemented in 2020 has met its intended purpose and continues to bring Sir Knights together at a time when the COVID-19 pandemic has literally put a stop to gatherings. The Grand Commander has recommended that the Bright Knight program be continued for another year. Attendees have been presented with a wide variety of topics ranging from Templar history and the politics of ancient Rome to the nuances of translation for words found in the scripture.

The Bright Knight Program WebEx format has allowed Sir Knights from the far corners of the State of Missouri to come together and meet from the safety of their homes during this global pandemic.

REPORT OF RETURNS OF COMMANDERIES COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

The committee has reviewed the 2020 Annual Returns from the Missouri Commanderies and have prepared the following observations. The committee found that twenty-eight of the twenty-nine Commanderies in Missouri submitted a 2020 Annual Return (97%).

Commanderies That Failed To File A 2019 Annual Return

Constantine Commandery No. 27 failed to submit a 2020 Annual Return. This Commandery is in violation of **ARTICLE VI, Chartered Commanderies, Section 117, Annual Reports and Per Capita Payment** which states in part "... Any Commandery that does not submit a complete annual return to the Grand Recorder's office not later than thirty (30) days prior to the Annual Conclave of the Grand Commandery shall forfeit all rights and privileges to representation and voting at the Annual Conclave." and **Section 119, Annual Audit of Commanderies** which states "Each commandery under the jurisdiction of this Grand Commandery shall on or before the 1st day of March of each year make, on standard forms furnished by the Grand Recorder, a financial report and an audit of the books, finances and property of the commandery and transmit by mail a copy of same to the Grand Recorder."

Commanderies That Filed A 2019 Annual Return

Of the twenty-eight Commanderies that submitted 2020 Annual Returns, seventeen were handwritten (61%) and eleven were typed (39%). Of the Commanderies that submitted 2020 Annual Returns, twenty-two were received prior to or on the March 1st deadline (79%) and six were received after the March 1st deadline (21%). The Commanderies that filed late were Excalibar Commandery No. 5, Ivanhoe Commandery No. 8, Escalon Commandery No. 16, Lebanon Commandery No. 33, Westport Commandery No. 68, and Malta Commandery No. 72. Of the twenty-eight Commanderies that paid their 2020 Per Capita Bill, one intentionally short paid their bill (Prince of Peace Commandery No. 29). One Commandery that paid late included the late fee in their Per Capita Bill check contrary to the instructions from the Grand Recorder that all late fees would be charged on the 2021 Annual Report and Per Capita Bill (Lebanon Commandery No. 33).

Issues With The 2019 Annual Returns

The Grand Recorder's letters of November 20, 2020, December 2, 2020, and January 11, 2021; clearly stated (several times) that a complete 2020 Annual Return was a check for the 2020 per capita payment, the completed information form, the completed financial report form, the completed annual audit committee report form, and a copy of the latest IRS Form 990 or a copy of the acceptance of the electronic submission of an IRS Form 990N (e-Postcard). Of the twenty-eight Commanderies that submitted 2020 Annual Returns, thirteen were found to be complete (46%) and fifteen were found to have issues (54%). Of the fifteen Commandery 2020 Annual Returns that had issues: one Commandery had an incomplete Financial report form and did not perform an audit. In addition, all fifteen Commanderies had 990 issues (discussed below in the IRS 990/990-N (e-postcard) Compliance section of this report).

Godfrey de Bouillon Commandery No. 24 submitted an incomplete Financial report form. They failed to provide information about their 2019 ending bank balance, their 2020 ending bank balance, the value of their real estate, the value of their paraphernalia, and the value of their indebtedness. They may have been indicating zero values for these items by leaving them blank which is not acceptable. They need to clearly indicate the value of these items even if the value is zero. However, more importantly they failed to perform the audit and are in violation of **ARTICLE VI, Chartered Commanderies, Section 119, Annual Audit of Commanderies**. The committee understands that this

Commandery may be consolidating under the Charter of another Commandery before the end of the year, so it may be unnecessary to take any action. However, if they fail to consolidate, the committee recommends that this Commandery be investigated and corrective actions taken.

IRS 990/990-N (e-postcard) Compliance

Of the twenty-eight Commanderies that submitted 2020 Annual Returns, thirteen provided evidence of a filed IRS 990/990-N (e-Postcard) during 2020 (46%) and fifteen had various 990 issues (54%).

Four Commanderies failed to provide a copy of the latest IRS Form 990 or a copy of the acceptance of the electronic submission of an IRS Form 990N (e-Postcard): Excalibar Commandery No. 5, Emmanuel Commandery No. 7, Lebanon Commandery No. 33, and Westport Commandery No. 68. The committee recommends that these four Commanderies be investigated and corrective actions taken.

Six Commanderies provided what they believed to be proper evidence of filing a 990, but what was provided did not, in fact, show evidence of an accepted 990: Hugh De Payens Commandery No. 4, Jasper Commandery No. 31, Oriental Commandery No. 35, Cape Girardeau Commandery No. 55, Rolla Commandery No. 59, and Poplar Bluff Commandery No. 67. The committee strongly recommends these six Commanderies pay more attention to what they are doing and provide the proper evidence of acceptance of the electronic submission of an IRS Form 990N (e-Postcard).

One Commandery provided a copy of their 990-EZ, but it was not signed or dated plus no evidence was provided that it had been mailed to the IRS: Ascalon Commandery No. 16. The committee recommends that this Commandery provide better evidence of filing their 990-EZ.

Three Commanderies did not provide a copy of the latest IRS Form 990 or a copy of the acceptance of the electronic submission of an IRS Form 990N (e-Postcard), but indicated that they were working to recover their filing status: Godfrey de Bouillon Commandery No. 24, Bethany Commandery No. 42, and Malta Commandery No. 72. The committee recommends that these three Commanderies be investigated and corrective actions taken.

One Commandery provided evidence that their IRS Form 990N (e-Postcard) had been rejected and were working with the Grand Treasurer to determine what went wrong: Neosho Commandery No. 57. The committee recommends that this Commandery be investigated and corrective actions taken.

Financial Health Evaluation

Overall, the majority of Missouri’s Commanderies are in good financial shape. One Commandery reported that they had a very low amount of money in their bank account at the end of the reporting year. Also, one Commandery (as mentioned earlier) failed to properly complete the financial reporting form.

The majority of Missouri’s Commanderies provided a value for their paraphernalia. A number of Commanderies reported that the value of their paraphernalia was zero (they entered zero, they just entered a “unknown”, or they left the question blank) indicating one of the following possible cases: they have no paraphernalia, their paraphernalia is unusable and worthless, or their paraphernalia is usable but they failed to attempt to place a value on it. A few Commanderies valued their paraphernalia at below \$500 which the committee believes is below replacement value. Several Commanderies valued their paraphernalia at \$2,000 or more which is much more reasonable.

All of Missouri’s Commanderies that provided an Annual Return reported information about their annual dues. The annual dues information provided was found, for some Commanderies, to be inconsistent with **ARTICLE XI, Dues, Section 170. Amount, How Determined** which states “The annual dues of members of a commandery shall not be less than ten dollars (\$10.00) plus Grand Commandery per capita and fees.” The Grand Recorder’s June 16, 2020 letter explained the per capita increase passed during the 2020 Annual Conclave. He stated, “The minimum Commandery member dues is \$48.60 (\$10.00 + \$29.50 + \$0.10 + \$9.00). ... The member dues that your Commandery charges could be higher if your local dues are more than \$10.00.” Based on the reported data here is an analysis of the annual dues reported by the Commanderies.

The committee understands that the annual dues data provided by the Commanderies may be inaccurate because the person completing the form did not pay attention to the instruction immediately below that question (Local dues plus Grand Commandery per capita plus any fees and/or assessments). However, the committee recommends that all Commanderies review the dues structure outlined in their Commandery by-laws to determine if it needs to be updated. The majority of Missouri's Commanderies reported that their Recorder and Treasurer were not bonded. Six Commanderies reported that their Recorder and Treasurer were bonded. The majority of Commanderies reported that they had more than one person on the signature card for the Commandery's bank account. Two Commanderies reported that they only had one name on the signature card for the Commandery's bank account which the committee feels is a very dangerous situation. All of Missouri's Commanderies reported that they had an embossing or imprinting Commandery seal.

Commanderies That Have Forfeited All Rights And Privileges

The following Commanderies have forfeited all rights and privileges to representation and voting at the 2021 Annual Conclave: Godfrey de Bouillon

Commandery No. 24 (due to an incomplete 2020 Annual Return) and Constantine Commandery No. 27 (due to failure to submit any 2020 Annual Return). There are fourteen other Commanderies that should also be listed due to an incomplete 2020 Annual Returns for 990 issues, but the committee feels that more time is needed to allow the Commanderies to correct their record keeping issues and for the Grand Commandery to review the more non-compliant Commanderies and take appropriate actions.

REPORT OF TRIENNIAL COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,
 The Grand Encampment's Triennial Conclave is the premier event in today's world of Knights Templary. It is held only once every three years. This is the year! The 68th Triennial Conclave of the Grand Encampment of Knights Templar hosted by Sir Knight Jeffery N. Nelson, Most Eminent Grand Master, will be held on the 14th through the 18th of August 2021 in Minneapolis, Minnesota at the Marriott City Center.

The voting members of the Grand Encampment include Missouri's Grand Commandery Dias Officers as well as our living Past Grand Commanders. Conclave and hotel registration forms are available on the Grand Encampment's web site. The 2021 Registration fee is \$275.00 (\$300.00 after June 1st) and

includes two tickets for the Sunday Grand Master's Reception and two tickets to Tuesday Grand Master's Banquet. The Knights Templar Ladies Luncheon on Monday is a separate fee of \$40.00. Hotel rooms at the Marriott start at \$179.00 per night.

ARTICLE III Committees, Section 36, Paragraph G, states that the Missouri Triennial Committee "shall consist of two Past Grand Commanders and a Grand Officer who in due course will be eligible to attend the next triennial conclave as a representative of this Grand Commandery, to be appointed at the annual conclave following the triennial conclave of the Grand Encampment of the United States and who shall serve for three years. The committee shall have charge of hotel reservations, entertainments and arrangements for the Grand Commandery at the Grand Encampment and shall submit an itemized report of receipts and expenditures."

As per **Article XV Miscellaneous, Section 205 Triennial Fund and Section 206 The Triennial Fund**, the fund is supported annually by a General Fund transfer of twenty-five cents per member on the rolls as of 31 December of the preceding year.

REPORT OF AUDIT COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

The Audit committee participated in the monthly Grand Officer WebEx meetings held during the 2019-2020 reporting year. A financial review of the Grand Recorder's records was an item on agenda of the July 2020 (reviewed June 2020 records), November 2020 (reviewed July 2020 - September 2020 records), January 2021 (reviewed October 2020 - December 2020 records), April 2021 (reviewed January 2021 - March 2021 records), and May 2021 (reviewed April 2021 records). The Grand Recorder provided instruction as to how the General Fund financial records on the Grand York Rite DropBox cloud storage system were maintained. The committee was given full read-only access to all

2019-2020 and 2020-2021 General Fund financial records. This process allows for quarterly (real-time) review of the transactions of the Grand Recorder rather than trying to reconstruct them a year later.

The Audit Committee believes that it has thoroughly reviewed the records of the Grand Recorder and found no discrepancies or mishandling of any of the funds appropriated to him. All monies were received and properly deposited or dispensed in accordance with the Grand Commandery Laws and Regulations.

We commend the Grand Recorder for an excellent records management system and his superb attention to the details of handling the financial records of the Grand Commandery.

On May 15, 2021, the committee was given the complete financial records of the Grand Treasurer for the 2019-2020 fiscal year and the 2020-2021 year to date records. Although we did not audit the 2020-2021 reports, it was an excellent opportunity to do some comparative analysis, specifically with regard to investments. On August 21, 2019 the Finance Committee, Investment Committee and the Grand Commander instructed the Grand Treasurer to take a more aggressive approach with his investment strategy. In September through December 2019, monies from the General Fund, General Fund Special Account and Endowed Membership Fund were invested in American Balanced and American Income funds. Although there was a slight loss due to the market turn in early 2020, the current rate of return for 2020-2021 is over 30% for both funds. We recommend the Investment Committee stay on top these investments and develop an official Grand Commandery Investment Policy/Strategy since none exists and instruct the Grand Treasurer to invest accordingly.

There was not enough time for the whole committee to do a detailed review of the Grand Treasurer's records, however a cursory review of the records and bank statements found no discrepancies or mishandling of any funds appropriated to him. All monies from the Grand Recorder were properly recorded and accounted for and all expenditures are accurately reported and accounted for. The committee recommends a more detailed financial review with the Grand Treasurer during the next year to revisit the 2019-2020 and 2020-2021 financial records.

We commend the Grand Treasurer for excellent records management and his superb attention to the details of handling the financial assets of the Grand Commandery. One recommendation is that the Grand Treasurer keep and maintain all financial records in a shared cloud storage assessable by the Grand

Recorder and the Finance Committee to insure against potential computer/file loss or corruption.

REPORT OF INVESTMENTS COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

All Grand Commandery Funds are currently invested in and/or through banking institutions in Jefferson City. All bank accounts are interest bearing, with no service charges, and with amounts being maintained at less than \$250,000.00 in any one banking institution. Investments in common stock or equal securities are in nationally known corporations traded on the New York Stock Exchange (American Balanced Fund and American Income Fund) and are being maintained at less than 50% of the total value of the Grand Commandery Funds.

Interest bearing investments have been in a combination of interest bearing money market accounts and Certificates of Deposit. Current interest rates have limited these monies from being invested in long-term certificates.

The strategy of investing in common stock or equal securities, as above noted, has been occurring over the past year and will continue to transition as monetary conditions warrant. Also, in concurrence with the Finance Committee, it has been agreed that future earnings from the General Fund (Special Account) will be automatically transferred to the General Fund. Hopefully, these strategies will reduce future needs for per capita increases.

REPORT OF MEMBERSHIP COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

Continuing with General Order No.5 issued by SK Jeffrey N. Nelson, Most Eminent Grand Master of the Grand Encampment of Knights Templar, this Order has, as its directive, "Membership Development as Priority One." The Order lists several items that each Grand Commandery must follow and implement, including:

1. Creation of a Membership Committee and Membership Chair,
2. Creation of a Membership Committee and Membership Chair in every constituent Commandery within that Grand Commandery,
3. Implementation of Grand Encampment membership development initiatives by the constituent Commandery membership committees, and
4. Reporting of activities by constituent Commanderies to the Grand Commandery Membership Committee, who then reports to the Grand Encampment Membership Committee/Department Commander.

SK Nelson stated that Recruiting new members was obvious to the growth needed for sustainability, but just as important was Retention. It is encouraged that every Sir Knight who takes a demit, or fails to pay his dues and is suspended as a result, be given a survey to gain more insight as to why the member lost interest or how the Commandery could better meet the needs of its members. A copy of that survey can be obtained from the Grand Commandery Membership committee, or the Grand Recorder of the Grand Commandery.

Regular reports continue to be submitted to the Grand Encampment Membership Committee. We now have an official schedule of two reporting periods per year: first half (January thru June) and second half (July thru December). The Committee Chairman asked for the second half 2020 reports to be sent in by November 15, 2020, so that the first half report could be sent to the Southwest Department Commandery by December 1, 2020. The Committee Chairman asked for the first half 2021 reports to be sent in by May 15, 2021, so that the first half report could be sent by June 1, 2021 to the Southwest Department Commander. This ensured that SK Cooper had two full reports sent to the Grand Encampment during his year as Grand Commander, further demonstrating compliance by the Grand Commandery of Missouri. This pattern will likely continue for all future Grand Commanders.

Of the 29 Commanderies, only 7 sent in the required second half reports for 2020. As of the writing of this report, we are currently collecting reports for the first half of 2021. No data has yet been received for that report. Constituent Commanderies that have never submitted a required report since 2019 and are not in compliance with 2020-2021 Grand Commandery General Order No.2 and Grand Encampment General Order No.5 are: Excalibur Commandery No. 5, Palestine Commandery No. 17, Prince of Peace Commandery No. 29, St. Elmo Commandery No. 43, Cape Girardeau Commandery No. 55, Poplar Bluff Commandery No. 67, Westport Commandery No. 68, and Malta Commandery No. 72.

Overall, as of the writing of this report, the Grand Commandery of Missouri currently has 1,620 members. This is a decrease of 52 since July 2020. This is due to a loss of members through death, suspension, and demission. That number is startling, but let us remember that no Orders could be conferred during the COVID-19 pandemic.

There should have been no new Knightings in the second half of 2020, but seven Commanderies reported one new Knighting each. There were 33 deaths reported in the second half of 2020. In regards to Retention, 49 members were suspended, only 27 members were reinstated, and 12 members were issued a demit this past year. Finally, 8 members were affiliated. We must have in place a system to check on our current members to ensure we keep our membership interested and involved.

We all know that 2020 was a year unlike anything most, if not all, of us have ever seen. And, we hope we will never see anything like it again. This committee believes that the drop in membership would not have been so drastic if

Commanderies could have been able to continue the work. But, steps had to be taken for safety and we cannot dwell on the "what ifs." We must press forward, taking advantage of recruitment tools such as "That Fervency and Zeal," "The Peculiar Stone," and the Grand Commandery of Missouri/Missouri Grand York Rite presentation for Symbolic Lodges, all of which are available from the Grand Commandery Membership Committee.
