# **RECCOMENDATIONS**

Sir Knights, the back-office operations presented me with unexpected challenges, that stretched my skill set. I have not experienced the need to sharpen the proverbial saw in a long time. These issues necessitated that I do exactly that. Without getting too deep into how the sausage is made I would like to offer some advice to my advancing line.

- Read and internalize the Constitution Statutes and Decisions of the Grand Encampment, and Laws and Regulations of the Grand Commandery of Missouri before you need to, and you will need to.
- 2. Regarding the management of interpersonal relationships, I have a reading list to share that helped me navigate these challenges. You will find yourself in roles ranging from The Boss, The Negotiator, The Servant, The Administrator, The Coach, and many more.

- 3. You will face your greatest adversary, and his name is Hubris. Personal Hubris, and Institutional Hubris. In the words of the Sir Knight Kevin B. Sample, sometimes it's difficult to get the toothpaste back in the tube once emotions are ignited.
- 4. Lastly, you will need to handle difficult personalities. Bearing in mind that the difficult personality maybe yourself depending upon the issue being worked.

Having seen the operations of the Grand Commandery as the Grand Commander for the first time, I would like to offer an opinion or two on what I feel could be opportunities for improvement.

- Business Continuity The challenges that faced the office of the Grand Treasurer have made it clear to me that having any Grand Commandery records on paper at only one location creates a single point of failure for loss (fire damage, water damage, passing of an officer, etc) and represents an unacceptable risk to our business continuity (ability to operate).
- Visibility/Organizational Agility Your Grand Officers and Committees decision-making abilities are significantly impeded without visibility of records. Paper in a box in a storage facility is not readily visible.
- Disaster Recovery This element eliminates the single point of failure from bullet point one and addresses the hacked laptop challenges that have plagued us for years. If we are adequately backed up hardware failure is irrelevant.
- **Governance/Transparency** When information is compartmentalized in silos, proper governance can be obscured. All monies, financial instruments, and financial obligations that have an association to the Grand Commandery of Knights Templar of the State of Missouri should be managed in accordance with both the Constitution Statutes and Decisions of the Grand Encampment and the Laws and Regulations of the Grand Commandery of Missouri, **OR** the Laws and Regulations of the Grand Commandery of Missouri should be revised to reflect how we operate. Monies should not be disbursed to proxy organizations unless it is in accordance with the Laws and Regulations that govern the process.

Regarding my opinions for improvement, it is easy to infer that these are "Grand Problems," and that is neither the case, nor is it the intent to slight any person past, present, or serving. It is however the intent to call out processes that could lead us into harm's way in the future. Sir Knights, we have been and are very fortunate to have the officers that we do. We may not always be this lucky and I would like to see protections that safeguard us if we were to hit an unexpected human resources issue. Stepping off my soapbox for a moment, I coach my employees to offer solutions to any problem that they elevate. In the same manner I would like to propose the following ideas for your consideration intended to address the concerns expressed.

- Document Management Development of a comprehensive document management strategy that defines our records requirements, back up capabilities, retention schedules, and digital protections. We are currently about 50% digital but do not have an official document management strategy that addresses business continuity requirements and disaster recovery needs.
- 2. **Investment Strategy** We are making strides on this point as we have proposed legislation intended to address this. Successful execution of this strategy will depend on the visibility of our financial positions so that your officers and committees can access the data points needed to make informed decisions. (One of the reasons for my SWAT Teams.)
- Governance/Transparency There were a couple of instances this
  year when I was engaged in financial obligations. Maintaining images of
  these contracts in a digital repository would have greatly improved the
  efficiency of the problem resolution process.

#### CONCLUSION

Sir Knights, 2022-2023 was a year of notable transition and transformation. I am pleased to report that we have managed through some very significant work efforts. We have a new venue for our Annual Conclave. We have worked to ensure continuity in the duties and records of a Grand Officer transition. The financials for the preceding years have been aggregated and reported on the floor. All three represent major work efforts.

I have had the pleasure of renewing support for our Youth groups after a brief absence. The heads of the York Rite Bodies have travelled the State together promoting York Rite Masonry. Including, but not limited to, getting lost while trying to find the York Rite Memorial which just so happens to be in a gas station parking lot. I am also humbled to have served under the guidance of a great line within the Grand Lodge of Missouri.

I would also like to thank my Aide de Camp, Sir Knight Harold F. Coots, and his lovely Lady Lisa for putting up with me and for providing invaluable feedback such as, "You do realize its Super Bowl Sunday don't you" or "What do you mean that you left your check book in your car and need me to pay for your dinner." Also, for the response to my 2 am weeknight text messages when I needed advice. On a serious note, Sir Knight Coots tireless support for Templary is truly unsurpassed.

Sir Knights, your efforts supporting the Holy Land Pilgrimage are truly appreciated and should bear fruit in the very near future! I can't think of a better way to honor the One we serve than to send eligible chaplains to walk in His footsteps.
