Item No. 1

Proposal to amend the **Laws And Regulations** of the Grand Commandery of Knights Templar of the State of Missouri to read as follows:

ARTICLE I - The Grand Commandery, Section 13. Change of Time and Place Due to Emergency.

<u>A.</u> In case of an emergency, epidemic, or other occasion or circumstance making it advisable or expedient, the Grand Commander, with the written consent of the Deputy Grand Commander, the Grand Generalissimo, the Grand Captain General, or any two such officers, may change the place and/or time of holding the next Annual Conclave of the Grand Commandery. (Amended ??/??)

B. In the event of extraordinary circumstances, the Grand Commandery of Missouri may conduct a Stated Annual Conclave or a Special Grand Conclave by electronic means. A virtual meeting shall be held by means of teleconference or webcast, provided that the necessary facilities are widely available to the members of the Grand Commandery and the Annual or Grand Conclave shall be conducted in full compliance with the requirements of Sections 37 through 39 of the Grand Encampment Constitution, Statutes, and Decisions as well as the requirements of Section 12 A, Section 14, and Section 15 of the Grand Commandery Law and Regulations. No Ritual shall be performed, and no Orders shall be conferred during any such virtual Conclave. To hold a virtual Conclave, it shall be necessary for the Grand Commander to obtain a dispensation from the Grand Master authorizing such a Conclave. (Adopted ??/??)

The events of the past couple of years have shown that extraordinary circumstances may make holding a Stated Annual Conclave or a Special Grand Conclave inadvisable or impossible. ARTICLE VI - Chartered Commanderies, Section 83. Conclaves.

The conclaves of commanderies shall be:

C. In the event of extraordinary circumstances, a Commandery may conduct a Stated or Special Conclave virtually. Such virtual Conclaves may be for the transaction of business only. A virtual meeting shall be held by means of teleconference or webcast, provided that the necessary facilities are widely available to the members of the Commandery and the Conclave shall be conducted in full compliance with the requirements of Section 83 and Section 84. No Ritual shall be performed, and no Orders shall be necessary for the commander to obtain a dispensation from the Grand Commander authorizing such a Conclave. (Adopted ??/??)

ARTICLE VI - Chartered Commanderies, Section 78. Elective and Appointive.

A. The Commander, Generalissimo, Captain General, Treasurer, and Recorder shall be elected by paper ballot. The remaining officers shall be elected, or appointed by the Commander, as may be provided by the by-laws. (Amended 5/12/79, ??/??/??)

Proposal to amend the Laws And Regulations of the Grand Commandery of Knights Templar of the State of Missouri to read as follows:

ARTICLE VI - Chartered Commanderies, Section 97. Dual Membership.

A. A Knight Templar may hold active multiple membership in two or more commanderies under the jurisdiction of the Grand Commandery of the State of Missouri, or active Dual memberships may be held in commanderies under the jurisdiction of the Grand Commandery of Missouri and another active membership held in commanderies in another Grand Commandery jurisdiction if the laws of that Grand Commandery provide for Dual membership.

A member cannot be a dais officer in more than one commandery at the same time. (Amended 5/18/85, 5/17/97, ??/??/?)

G. A Knight Templar with active multiple membership in two or more Commanderies under the jurisdiction of the Grand Commandery of the State of Missouri may be an elected officer in more than one Commandery at the same time, provided he may not be Commander of more than one Commandery at the same time. (Adopted ??/??/?)

The uniform of Knights Templar, Knights of Malta, and Companions of the Illustrious Order of the Red Cross is that which is prescribed by the Grand Commandery and published in the tactics, proceedings and rituals. <u>It is</u> permissible for the members of the Grand Commandery of Missouri and Constituent Missouri Commanderies to wear an apron with Templar Uniforms as described in the tactics, proceedings, and ritual. (Amended ??/??)

STATEMENT OF PURPOSE:

Many Sir Knights have expressed enthusiasm for resuming use of a Templar Apron. The Templar Jurisprudence Committee find that the addition of the provisions for the Templar Apron in the Grand Encampment Constitution, Statues, and Decision are prudent and need to be implemented in the Laws and Regulations of the Grand Commandery of Missouri.

Addendum:

The following language will be added to the Grand Commandery of Missouri Tactics Manual as a new entry titled "Grand Commandery Apron Regulations Sec XIII" on the Grand York Rite web site (moyorkrite.org) DOCUMENTS page under GRAND COMMANDERY DOCUMENTS.

Grand Commandery Apron Regulations Sec XIII

It is permissible for the members of the Grand Commandery of Missouri and Constituent Missouri Commanderies to wear an apron with Templar Uniforms as described in the tactics, proceedings, and ritual.

Traditional Apron. A Traditional Templar Apron shall conform substantially in design to the images below. It shall be trimmed in gold for Sir Knights of the rank of Commander or Past Commander and above, and in silver for Sir Knights below the rank of Commander. A Traditional Templar Apron may only be worn in an asylum or other private setting where only Knights Templar are present.



Contemporary Apron. A Contemporary Templar Apron shall conform substantially in design to the image below. It shall be trimmed in gold for Sir Knights of the rank of Commander or Past Commander and above, and in silver for Sir Knights below the rank of Commander. A Contemporary Templar Apron may be worn in both private and public settings. It is permissible to manufacturer an apron so that it is reversible with the Traditional Apron on one side and the Contemporary Apron on the other.



Grand Commandery Officers may wear such aprons and others, as deemed appropriate, from time to time, by the Grand Commander and in accordance with his directions.

If a Sir Knight appears in uniform in a tyled, Masonic Lodge, he shall wear such apron as in accord with local Masonic custom or approved by the presiding officer.

ARTICLE XXIV - Other Types of Commanderies, Section 238. Holding Commanderies.

The Grand Commandery of Missouri may create and charter one or more Missouri Holding Commanderies for the purpose of retaining Sir Knights who were members of a Constituent Missouri Commandery which demised. Membership in such a Holding Commandery shall only be obtained by affiliation. A Holding Commandery may not create Sir Knights. The Grand Commander shall appoint the officers of a Holding Commandery, except that the offices of Recorder and Treasurer shall be held by the Grand Recorder and Grand Treasurer respectively, and the elected Grand Commandery officers shall be ex officio members of the Holding Commandery without payment of dues or assessments. All other members of the Holding Commandery shall be subject to the payment of all dues and assessments levied by the Grand Encampment, the Grand Commandery, and the Holding Commandery; and shall be subject to discipline as otherwise provided by law. A Holding Commandery shall not be required to have a suitable Asylum per Section 92 - Place of Meeting or to meet guarterly per Section 83 - Conclaves - Paragraph A. The Commander of a Holding Commandery does not obtain the rank of Past Commander by virtue of such service. (Adopted ??/??/??)

STATEMENT OF PURPOSE:

It would be beneficial to allow the chartering of Holding Commanderies under the jurisdiction of the Grand Commandery of Missouri in order to retain the membership of Sir Knights whose Commandery has either surrendered its Charter and legally closed; or had its Charter arrested and legally closed. The Templar Jurisprudence Committee find that the addition of the provision for Holding Commanderies in the Grand Encampment Constitution, Statues, and Decision is prudent and needs to be implemented in the Laws and Regulations of the Grand Commandery of Missouri.

ARTICLE II - The Grand Officers, Section 30. Grand Treasurer.

A. The Grand Treasurer shall receive from the Grand Recorder all funds and securities of the Grand Commandery and deposit same in the name of the Grand Commandery in some bank or trust company, to be approved by the Grand Commander and Chairman of the Committee on Finance and Accounts. He shall attend the Annual Conclave of the Grand Commandery, and when required, meet the Grand Officers and Committees with his books and all necessary documents relating to his office, make a full report at the Annual Conclave; pay all warrants and at the commencement of his term of office, each year, execute and file with the Grand Commander, his official bond with some reliable company, as surety thereon, in the sum of twenty thousand dollars (\$20,000.00); to be renewed as to the amount of the surety, when required by the Grand Commander or Grand Commandery; the cost of said bond to be paid by the Grand Commandery. Such bond to be conditioned that he will faithfully discharge the duties of his office, account for all money or property of the Grand Commandery that may come into his hands; produce on demand of the Grand Commandery or Grand Commander or his successor in office the same, together with all books, papers, vouchers, securities, jewels, etc., belonging to Laws and Regulations of the Grand Commandery of Knights Templar of the State of Missouri the Grand Commandery. He shall take duplicate receipts for same, one of which shall be delivered to the Grand Recorder. (Amended 6/7/19, ??/??)

STATEMENT OF PURPOSE:

All money and securities collected by the Grand Recorder are handed to the Grand Treasurer simply to deposit in a transitional holding account (checking/ savings/money market). The Grand Treasurer should then disburse amounts from these accounts based on the warrants from the Grand Recorder. While this "holding account" may be selected by the Grand Treasurer, it must be approved by the Grand Commander and Chairman of the Committee on Finance and Accounts - the current name of the committee. The Templar Jurisprudence Committee, and the Finance and Accounts Committee, and the <u>Investments Committee</u>; each shall consist of five <u>or more</u> members. The Grand Commander shall, after his installation, appoint and announce the chairman of each of said committees.

D. Investment Committee consisting of three five or more members, one of whom shall be the Grand Treasurer, one of whom shall be the Chairman of the Finance and Accounts Committee, and one two of whom shall be appointed by the Grand Commander, with the stipulation that the members so appointed shall be one possessed of a background in financial matters, and two or more others appointed by the Grand Commander. The duties of this Committee shall be the control and management of the surplus funds of this Grand Commandery in such wise <u>a way</u> as, in its judgment, is prudent and adheres to sound business principles. The Committee shall invest any surplus funds of the Grand Commandery in an amount not less than one-guarter of all investments in obligations of the United States, or in the securities or accounts fully insured or guaranteed by the United States or an agency of the United States, except for those received by gift or bequest which may be retained in kind. The remainder may be invested in mutual funds, common stock or equal securities in nationally known corporations traded on the New York Stock Exchange, and rated "A": or better by Standard and Poore's or Moody's or by some equally well recognized investment rating service. The investment servicing company selected by the Committee shall invest the funds in a "fiduciary manner." The Committee is authorized, for and on behalf of this Grand Commandery, and in the name of the Grand Commandery of Knights Templar of the State of Missouri, to invest any surplus funds of the Grand Commandery as they may deem advisable, and from time to time sell, exchange, transfer, or reinvest such funds as described in this section. The Committee shall submit a preliminary report to the Grand Commandery to be included in the preliminary proceedings by the deadline set by the Grand Recorder. (Amended ??/??/??)

STATEMENT OF PURPOSE:

The Investment Committee needs to have five or more members similar to the Finance and Accounts Committee. The duties of the Investment Committee are specified in this Section, but it is not specifically listed in Paragraph A as a Standing Committee. However, due to the critical duties of the Investment Committee it needs to be specifically listed as a Standing Committee in Paragraph A.

All members of the Investment Committee should have a background or acumen in financial matters. We already have a provision for one qualified appointment to this committee. We need two such members. The chairman of the Finance and Accounts Committee should have some knowledge in this area as well. In regard to the Grand Treasurer, there is no merit for having a standing appointment

ARTICLE XI - Dues, Section 176. Non-Payment of Dues.

Commandery dues are payable in advance on the first day of January in each year and become delinquent on the first day of July following. Whenever a member shall fails to pay his dues at the time when the same become delinquent on or before February 1 of each year: (Amended ??/??)

A. The Commander shall appoint a Commandery Membership Retention Committee, consisting of no less than three (3) members who shall make direct contact with the member in question by phone or in person within thirty (30) days to discuss any potential financial hardships or other issues which may be the member's concern regarding their membership. (Adopted ??/??) **B.** The Membership Retention Committee shall file a written report within thirty (30) days with the Commander and Recorder indicating the contact date(s) and summary of the communication and recommendation, e.g. suspension, remission, or other arrangements to help the member retain and maintain their membership. (Adopted ??/??)

C. A Commandery may not act on any vote to suspend a member until the Membership Retention Committee report has been filed. (Adopted ??/??)

D. If, after the report of the Membership Retention Committee has been filed, and the recommendation is for suspension, the Recorder shall notify him of such delinquency by delivering to him, or causing to be delivered by a Knight, a bill for such indebtedness, or by mailing the same in a sealed envelope addressed to him at his present or last known place of residence. Should the delinquent refuse or fail to pay his dues within twenty days after the issuance of such notice, it shall be the duty of the Recorder to notify the Commander of such failure, who shall, at the next stated conclave of the commandery, order a notice to be given the delinquent by the Recorder, requiring him to appear at a specified subsequent stated conclave, to show cause why he should not be suspended for non-payments of dues. (Amended ??/??/??)

E. Such notice shall be served by the Recorder by delivering, or causing to be delivered by a Knight, to the delinquent a copy of the same, or by mailing it to him in a sealed envelope addressed to him at his present or last known place of residence at least ten days prior to the time he is to appear. (Amended ??/??/??)

F. Should the delinquent fail to appear, his dues still remain unpaid, or the same be not remitted for good cause, or the time of payment extended, by a majority vote of the members present, the Commander, upon proof of notice and the fact of arrearage, shall put the question: "Shall Sir <u>Knight</u> ______ be suspended for non-payment of his dues?" which shall be determined by a paper ballot or vote of the commandery; and if a majority of those present vote "yes", the Commander shall declare the Knight suspended until his dues are paid. The delinquents may be balloted on or voted on by the commandery individually or collectively. (Amended ??/??/??)

REPORT OF FINANCE AND ACCOUNTS COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

The Finance and Accounts committee participated in several financial review WebEx meetings held by the Grand Commandery Officers during the fiscal year. The Grand Recorder's office provided instruction on how the General Fund financial records on the Grand York Rite DropBox cloud storage system were kept. The committee is satisfied that the Grand Recorder's office is doing an exceptional job handling the monies and maintaining the financial records of the Grand Commandery.

Unfortunately, the Grand Treasurer experienced continued medical and technical challenges during the fiscal year. Due to both medical and technical issues, the Grand Treasurer needed assistance with his duties. In September 2022, the Grand Commander appointed Sir Knight Russell S. Hanson as the Assistant Grand Treasurer. Since that appointment SK Hanson has communicated weekly with SK Trabue working on several financial issues.

With the assistance of Lady Debbie Hanson, undeposited checks from May 2022 through July 2022 were recovered and replacement check request letters sent out. As of the date of this report, of the total of 93 undeposited checks, 84% of the May 2022 General Fund checks have been replaced and deposited, 79% of the June 2022 Charity Fund checks have been replaced and deposited, and 86% of the July 2022 Supply Fund checks have been replaced and deposited. However, there are still 9 undeposited July 2022 Supply Fund checks that have not been sent back to the Assistant Grand Treasurer for processing.

The committee reviewed the investment strategy of the Grand Treasurer. While some improvements have been implemented, the committee recommends that the Grand Commandery strive to improve its investment strategy. To that end certain proposed legislative items, if passed, will help with the process of improving the Grand Commandery's investment portfolio.

With the assistance of the Grand Recorder's office and the Grand Treasurer, the committee prepared a proposed budget for the ensuring year. The committee met with the Grand Line Officers and secured their approval of the proposed budget. The committee is pleased to report that the proposed budget continues to show a surplus due to the 2020 dues increase. However, as we all are very well aware, the price of goods and services has increased.

The committee continued to review the projections of future membership numbers as well as projections of future income levels and future expenses. Those projections show our per capita paying membership continuing to decline resulting in a decline in income. With the current economic situation that we are all experiencing today, it is projected that some of our expenses will continue to increase in the future. If the projections of decreased income and increased cost

are realized, then we will need to make some serious decisions about both per capita increases and cost reductions in the very near future.

The budget is subject to change if the proper requesting procedures are followed and with the approval of the Finance and Accounts committee.

REPORT OF THE GRAND TREASURER

Preliminary Report

The Report of the Grand Treasurer was not complete at the time of the printing of the Preliminary Proceedings. The Report will be available in a Preliminary Proceedings Supplement that will be available for the 2023 Annual Conclave.

REPORT OF THE ASSISTANT GRAND TREASURER

To the Grand Chapter of Royal Arch Masons of the State of Missouri, the Grand Council of Cryptic Masons of the State of Missouri, and the Grand Commandery of Knights Templar of the State of Missouri:

Companions and Sir Knights,

During September 2022, due to ongoing medical and technological challenges being experienced by the Grand Treasurer, I was appointed Assistant Grand

Treasurer to help with the Grand Treasurer's duties. I began immediately to work with the Grand Treasurer on a variety of issues and projects.

During the period of September 2022 through May 2023, I spoke with the Grand Treasurer by phone at least weekly concerning bills and deposits. Due to technological issues with the Grand Treasurer's computer equipment, I volunteered to scan and mail all checks for bills. The Grand Treasurer accepted my offer. Over the course of several months, we caught up on checks for bills and are again writing checks in the same month that the bills are posted. One issue that was uncovered was that incoming checks were not being deposited promptly. Grand York Rite Office check packs to the Grand Treasurer from May 2022, June 2022, July 2022, November 2022, and January 2023 were recovered and returned to the Grand York Rite Office. With the significant assistance of the Grand York Rite Executive Assistant, the expired checks from May 2022, June 2022, and July 2022 were returned to the members who originally wrote them with a request for a replacement check. To date, 84% of the May 2022 checks have been replaced and deposited; 79% of the June 2022 checks have been replaced and deposited; and 86% of the July 2022 checks have been replaced and deposited. The Grand York Rite Office will continue to work on getting replacement checks for all expired checks in the new fiscal year. We are currently caught up with check deposits, though there are a large number of recently received checks at the Grand York Rite Office that will be deposited after Grand Session.

One of the first projects that the Grand Treasurer asked me to work on was the Charity Donation submission situation. I started with the donation submission to the General Grand Chapter Royal Arch Research Assistance (RARA) program. During September 2022 and October 2022, I exchanged emails with J. William Riggs, concerning how to write the checks for collected RARA donation submissions and where to send the checks for collected RARA donation submissions. The last item that I was working on before I had to move on to other projects was the proper documentation of the collected RARA donation submissions. Consequently, this project was unfinished as of Grand Session, but will be completed in the next fiscal year.

The Grand Treasurer asked me to follow up on several IRS-related issues. I discovered that the Grand Chapter, Grand Council, Grand Commandery, Grand Commandery Educational Foundation, and Grand York Rite IRS 990 filings were not up to date. The Grand Commandery Educational Foundation and Grand York Rite both file IRS 990N (e-postcard). During February 2023 and April 2023, I

successfully caught up the filings for both the Grand Commandery Educational Foundation and Grand York Rite. The IRS 990N (e-postcard) filings for both entities are now up to date.

The Grand Chapter has in the past filed a full IRS 990, the Grand Council has in the past filed an IRS 990EZ, and the Grand Commandery has in the past filed a full IRS 990. The last fiscal year successfully filed for all three Grand Bodies was June 1, 2018 through May 31, 2019 (technically the 2018 reporting year, but the filing used the 2019 form). During December 2022, I began preparing Grand Chapter IRS 990 forms for the reporting years of 2019, 2020, and 2021. However, due to information issues, I was not able to complete those forms. I also was not able to get to the Grand Council IRS 990EZ forms. In addition, I was not able to get to the Grand Commandery IRS 990 forms or determine if the Grand Encampment was filing the IRS 990 forms on behalf of the Grand Commandery.

During December 2022, our Missouri Chapters and Councils began receiving the first batch of CP120B Notices from the IRS informing them that, "You're no longer recognized as a tax-exempt subordinate in a group exemption letter." The notices referenced three different IRS Tax Periods: January 31, 1965, December 31, 1971, and December 31, 1972. It was determined that the notices did not prevent the local Chapters and Councils from successfully filing their IRS 990N (e-postcard). A very limited second round of CP120B Notices were received during March 2023.

During March 2023, it was decided that the Grand Chapter, Grand Council, and, possibly, the Grand Commandery would seek the assistant of a professional tax accountant (or attorney) in order to get the three Grand Bodies IRS 990 filings caught up. During April 2023, the Grand Treasurer received a Notice from the IRS that the Grand Chapter must file an IRS 990 for 2022 before the end of 2023 in order to keep its tax-exempt status. Work on getting the IRS 990 status for all three Grand Bodies will continue in the months after Grand Session.

During February 2023, the IRS informed us that they had changed our mailing address to the address of the Grand York Rite Office in Fayette, Missouri. However, the mailing address change did not impact all correspondence from the IRS to the Grand York Rite and its associated Grand Bodies.

The Grand Treasurer asked me to follow up on several employee-related issues. During December 2022, I made several attempts to contact the IRS concerning submission of employee tax withholdings. Though I was eventually able to speak

with an IRS staff member about the issue, I was told that they would only address the issue with the actual Grand Treasurer of the Grand York Rite of Missouri. I reported this information to the Grand Treasurer during January 2023. During March 2023, I finally received the information needed to file the 2022 W-2/W-3 forms for our employees. Both employees reported the they had no problem using the 2022 W-2 forms to file their respective 2022 Federal and State income tax forms. During April 2023, the Grand York Rite received a CP237A Notice from the IRS concerning an undeposited September 2021 refund check for \$1,422.21 that had now expired and was no longer negotiable; and procedures for requisition a replacement. Shortly thereafter, the Grand York Rite received a replacement refund check in the amount of \$1,422.21. While no request for a replacement check was made, the check will be deposited after Grand Session.

Preliminary Proceedings

Between October 2022 and January 2023, I made several attempts to contact the Missouri Department of Labor and Industrial Relations, Division of Employment Security (DES) concerning the Grand York Rite's failure to file guarterly DES reports. During November 2022, I received a copy of a July 2022 monthly DES statement from the Grand Treasurer indicating that we had not filed guarterly reports for the 4th Q 2022 and the 1st Q 2023. During December 2022, with the assistance of the Grand Treasurer, I obtained access to the DES web portal for our account. However, I did not find a way to file quarterly reports using the portal. I contacted the DES customer service department about filing guarterly reports and was informed that I would need to speak with the DES liability department. I was connected to the DES liability department and was informed that the Grand York Rite account was not properly setup. Further, I was informed that they would only speak with the actual Grand Treasurer. I reported this information to the Grand Treasurer during December 2022. During January 2023, I received a copy of a November 2022 monthly DES statement from the Grand Treasurer stating that we had been fined \$400.00 for failure to file quarterly reports for the 4th Q 2022 and the 1st Q 2023. As I understood the DES system, because we are a nonprofit entity, we do not have to pay unemployment taxes on our employees, but we are required to file quarterly reports. If we fail to file a quarterly report, then we will be fined \$200.00 per report. During January 2023, I also received a copy of an October 2022 DES certificate of assessment from the Grand Treasurer stating that the assessed delinguency of \$400.00 was final and that paperwork had been filed

with the Clerk of the Circuit Court. During January 2023, I also received a copy

of a December 2022 DES letter indicating that because we no longer pay wages in Missouri, we no longer have to file quarterly contribution and wage reports with the DES. This issue was not resolved prior to Grand Session.

The Grand Treasurer asked me to follow up on several bank/nonprofit corporation issues. We had spoken about one of the banks used by the Grand York Rite requiring proof of State registration. During December 2022, I spoke with the bank staff member who had made the request of the Grand Treasurer. Based on the conversation, I understood that the evidence of State registration needed was a charter for a nonprofit corporation from the Secretary of State, Business Services Office (BSO). During December 2022, I successfully filed for and obtained a nonprofit corporation charter for the Grand Chapter (Grand Chapter RAM of Missouri, N001691180), Grand Council (Grand Council RSM of Missouri, N001691184), Grand Commandery (Grand Commandery KT of Missouri, N001691185), and Grand York Rite (Grand York Rite of Missouri, N001691187). During November 2022, I received a copy of an October 2022 letter from the Secretary of State informing us that the nonprofit corporation, Knights Templar Foundation of Missouri (Grand Commandery Educational Foundation), charter N00521196 had been revoked due to failure to file an annual report. I researched the process for requesting reinstatement of a nonprofit corporation charter; collected and created the necessary documentation for the request; verified with the Secretary of State, Business Services Office (BSO) that the request fee was \$40.00; obtained a check in the amount of \$40.00 from the Grand Treasurer; and submitted the request. During December 2022, I received a notice from the BSO that the request fee that I had submitted was incorrect and that the request was therefore denied. The letter stated that the request fee was \$25.00 and they were returning my \$40.00 check. I obtained a check for \$25.00 from the Grand Treasurer (eventually returning the unused \$40.00 check to him). During January 2023, I resubmitted the request for reinstatement and received a notice that the charter had been reinstated.

My tenure as the Assistant Grand Treasurer has been very enlightening though also frustrating at times. The Grand Treasurer and I have worked together since 2011. This year I have enjoyed working more closely with the Grand Treasurer and I have learned a lot about what it takes to do the job.

REPORT OF GRAND RECORDER'S OFFICE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

The Grand Recorder's Office of the Grand Commandery has completed its second year with Sir Knight Roger D. Fleer as the Grand Recorder and Sir Knight Russell S. Hanson, Grand Recorder Emeritus, as his assistant. We have divided up the work along the lines of what we each do best. Roger does most of the traveling and handles day-to-day requests for dispensations, by-laws approvals, and questions. Russell does most of the writing and report creation. We call each other often and are in constant email contact. We believe that we are working well together to get the job done.

Debbie continues to be a tremendous asset. She answers the Grand York Rite Office phone and watches the Grand York Rite Office email. She is also our Editorial compass. Debbie reviews all of our correspondence to make sure that the words we use are the right ones and correctly spelled; and that our sentences are complete and make sense.

The division of labor between the Grand Secretary's Office of the Grand Chapter, the Grand Recorder's Office of the Grand Council, and the Grand Recorder's Office of the Grand Commandery will continue to move the operation of the Grand York Rite Office forward. Together Companion and Sir Knight Donald MacCormick, Companion and Sir Knight Kevin B. Sample, Companion and Sir Knight Roger D. Fleer, and Sir Knight Russell S. Hanson will continue to resolve legacy issues as well as to cope with the constant flow of information into the Grand York Rite Office.

This past year we have continued to realize the full impact of our efforts to modernize the operation of the Grand York Rite Office. Debbie continues to be instrumental in dealing with the day-to-day operations of the office. The MGYR web site continues to be maintained under the care of Companion and Sir Knight Donald MacCormick, MGYR Web Master. Bringing the Grand York Rite of Missouri into the 21st Century continues to be our constant theme.

The Grand Commandery has completed its seventh year using the current annual reporting system. The 2022 Annual Reports and Per Capita Bills were based on the Missouri membership data in MMS, information from the Grand Commandery records, and information from the Commanderies.

The 2022 Annual Returns are more completely reviewed and analyzed in the Report from the Committee on Returns of Commanderies and your attention is directed to that report in the preliminary proceedings.

Overall, the response this year was good. Twenty-four of our twenty-six Missouri Commandery filed a 2022 Annual Return and paid their 2022 Per Capita Bill. Several Commanderies filed late. Two Commanderies failed to file a 2022 Annual Return and pay their 2022 Per Capita Bill.

The Grand Commandery of Missouri saw no overall growth in membership during the calendar year 2022. Excalibar Commandery No. 5 and Bethany Commandery No. 42 each receive an honorable mention for having no net loss reported. The following Commanderies reported positive growth during 2022. In conformity with Standing Resolution No. 10 of the Laws and Regulations of the Grand Commandery of Missouri, we acknowledge their accomplishment with the Grand Commandery Growth Award.

Section 236 Commandery Recorder Responsibilities, paragraph D, specified that "Recorders and IT Representatives shall log into MMS no less than monthly to maintain access credentials and to make any approved membership changes." Based on user login statistics from MMS for June 2022 through April 2023, the following Commanderies were in violation of Section 236.

REPORT OF RETURNS OF COMMANDERIES COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

The committee has reviewed the 2022 Annual Returns from the Missouri Commanderies and have prepared the following observations. As of the writing of this report, the committee reports that twenty-four of the twenty-six Missouri Commanderies submitted a 2022 Annual Return (92%).

Commanderies That Failed To File A 2022 Annual Return

As of the writing of this report, two Missouri Commanderies have failed to file a 2022 Annual Return, Constantine No. 27 and St. Elmo No. 43. If these Commanderies do not submit a complete 2022 Annual Return by May 2, 2023, then each Commandery and its members will forfeit all privileges for representation and voting at the 2023 Annual Conclave of the Grand Commandery of Missouri per **ARTICLE VI - Chartered Commanderies, Section 117. Annual Reports and Per Capita Payment**.

Commanderies That Filed A 2022 Annual Return

Considering the manner of preparation of the 2022 Annual Returns, twelve (50%) were handwritten with varying degrees of legibility and twelve were typed (50%). Twenty-one of the 2022 Annual Returns were received on or before the March 1st deadline (88%) and three were either received after the March 1st deadline or were incomplete (12%). The Commandery that filed late was Poplar Bluff No. 67. The Commanderies that were incomplete due to lack of 990 evidence were Excalibar No. 5 and Malta No. 72.

Twenty-three Missouri Commanderies paid 100% of their respective per capita payments. One Commandery, Ely No. 22, short paid their per capita bill by \$0.40. The total expected per capita was \$44,198.20. However, only \$42,795.40 was collected as of the writing of this report. The shortfall is due primarily to the fact that Constantine No. 27 (\$678.20) and St. Elmo No. 43 (\$724.20) did not pay their per capita bills (plus the \$0.40 short pay of Ely No. 22, of course). The committee is pleased to note that all Missouri Commanderies that filed late properly followed the instructions from the Grand Recorder concerning the late fee (and the Ely No. 22 short pay of \$0.40) which will be added to the respective Commandery 2023 per capita bill.

Issues With The 2022 Annual Returns

The Grand Recorder's letters of November 10, 2022, December 5, 2022, December 16, 2022, and January 19, 2023; clearly stated (several times) that a complete 2022 Annual Return was a check for the 2022 per capita payment, the completed information form, the completed financial report form, the completed annual examination committee report form, and a copy of the latest IRS Form 990 or a copy of the acceptance of the electronic submission of an IRS Form 990N (e-Postcard).

For the most part, there were no issues to report concerning the 2022 Annual Returns. Prince of Peace No. 29 did not perform the required annual examination of the Commandery's financial records. Poplar Bluff No. 67 indicated that they had performed the annual examination but did not provide any evidence that it was in fact performed (no date of acceptance and no list of committee members). The twenty-four reporting Missouri Commanderies submitted a check for their 2022 per capita payment, a completed information form, a completed financial report form, and a completed annual examination committee report form. That is 100% compliance by the reporting Commanderies and they deserve our congratulations.

IRS 990/990-N (e-postcard) Compliance

Of the twenty-four Missouri Commanderies that submitted an annual report, fourteen (58%) provided proper evidence of filing an IRS Form 990 or IRS Form 990N (e-postcard).

Four Commanderies did not provide any evidence of filing an IRS Form 990 or IRS Form 990N (e-postcard). These Missouri Commanderies were DeMolay No. 3, Excalibar No. 5, Bethany No. 42, and Malta No. 72.

One Commandery, Neosho No. 57, provided proof that their 990N (e-postcard) filing had been rejected by the IRS.

Five Commanderies provided evidence that they had filed a 990N (e-postcard) but did not provide evidence that their filing had been accepted by the IRS. These Commanderies were Hugh De Payens No. 4, Jasper No. 31, Oriental No. 35, Rolla No. 59, and Poplar Bluff No. 67. These Commanderies need to pay more attention to the instructions for completing the Commandery Annual Return.

The majority of the reporting Missouri Commanderies (87%) provided a value for their paraphernalia. The balance of the Commanderies (13%) reported that the value of their paraphernalia was zero (they entered zero or they entered "Unknown") indicating one of the following possible cases: they have no paraphernalia, their paraphernalia is unusable and worthless, or their paraphernalia is usable, but they failed to attempt to place a value on it. Six Commanderies valued their paraphernalia at below \$1,000.00 which the committee believes is below replacement value. The rest of the Commanderies valued their paraphernalia at \$1,000.00 or more which is much more reasonable. All of the reporting Missouri Commanderies provided information about their annual dues. The annual dues information provided was found to be consistent with **ARTICLE XI, Dues, Section 170. Amount, How Determined**.

The majority of the reporting Missouri Commanderies (75%) reported that their Recorder and Treasurer were not bonded. Seven Commanderies (25%) reported that their Recorder and Treasurer were bonded.

The majority of the reporting Missouri Commanderies (96%) reported that they had more than one person on the signature card for the Commandery's bank account. One Commandery (Bethany No. 42) reported that they only had one name on the signature card for the Commandery's bank account which the committee feels is a very dangerous situation.

The majority of the reporting Missouri Commanderies (96%) reported that they had an embossing or imprinting Commandery seal. One Commandery (Excalibar No. 5) left the question blank. The committee is not certain if the Commandery is indicating that they do not know if they have a seal or they accidentally neglected to answer the question. If they do not have one, then they are in violation of **ARTICLE VI - Chartered Commanderies, Section 82. Seal**.

Commanderies That Have Forfeited All Rights And Privileges

If Constantine Commandery No. 27 and St. Elmo Commandery No. 43 do not submit a complete 2022 Commandery Annual Return to the Grand York Rite Office on or before May 2, 2023, then the committee recommends to the Grand Recorder's Office consider both of the named Commanderies as having forfeited their rights and privileges to representation and voting at the 2023 Annual Conclave.

REPORT OF EXAMINER COMMITTEE

To the Grand Commandery of Knights Templar of the State of Missouri:

Sir Knights,

The Examiner committee participated in the Grand Officer/RGC WebEx meetings held during the 2022-2023 reporting year. A financial review of the records of the Grand Recorder's Office was an item on the agenda of several of the meetings. The committee received instruction as to how the General Fund financial records on the Grand York Rite DropBox cloud storage system were maintained. This process allows for review of the transactions of the Grand Recorder's Office rather than trying to reconstruct them a year later.

The committee believes that it has thoroughly reviewed the records of the Grand Recorder's Office and found no discrepancies or mishandling of any of funds appropriated to the Grand Recorder's Office. The committee found that the warrants provided by the Grand Recorder's Office were properly paid in accordance with the Grand Commandery Laws and Regulations. The committee found that most of the monies received by the Grand Recorder's Officer were properly deposited. However, one discrepancy was discovered; it was determined that 43 checks from May 2022 were not deposited in the General Fund. Unfortunately, the Grand Treasurer suffered several medical and technical challenges during the fiscal year. Due to both medical and technical issues, it was determined that the Grand Treasurer needed assistance with his duties. In September 2022, the Grand Commander appointed Sir Knight Russell S. Hanson as the Assistant Grand Treasurer. Since that appointment, SK Hanson has communicated weekly with SK Trabue working several financial issues. With the assistance of Lady Debbie Hanson, undeposited checks from May 2022 were recovered and replacement check request letters sent out. As of the date of this report, of the total of 36 undeposited checks have been replaced and deposited.

We commend the Grand Recorder's Office for an excellent records management system and SK Hanson's attention to the details of handling the financial records of the Grand Commandery.

A separate Special Examiner Committee was tasked by Sir Knight Michael C. Rohman, Grand Commander, with the duty of performing a detailed review of the last five years of the Grand Treasurer's records. Please see their report for an explanation of their findings.

The committee is aware that the Grand Treasurer continued to experience computer issues during the year in question. The committee continues to recommend that the Grand Treasurer keep and maintain all Grand Commandery financial records in a cloud storage system such as DropBox with shared access by the Grand Recorder's Office and the Finance Committee to insure against potential computer/file loss or corruption.

The committee also recommends that the Grand Treasurer provide quarterly reviews to this committee and the grand officers of all financial records and accounts of the Grand Commandery and to provide budgetary reconciliation reports for each quarter.

The committee is aware that the Grand Treasurer has expressed continued computer issues and incomplete reporting of the financial records of the Grand Commandery for more than just this past reporting period, with intent to complete the reports, yet they never followed.

Sir Knights, we all need to learn to recognize when we have reached the limits of our capabilities, no matter what the tasking or responsibility, and to ask for help before things get out of control. However, the Grand Commandery, that is each of YOU, must hold all grand officers and committees accountable and demand proper performance of their duties and responsibilities, and should it be necessary, consider removal for poor performance. Do not accept incomplete reports of any grand officer or committee and demand reconciliation of any failed reports. When any grand officer or committee fails to perform in accordance with the Laws and Regulations of the Grand Commandery, those issues should be addressed immediately, not letting them fester and grow into something much more difficult to address. Problems can be addressed by assigning others to assist with the requirements of the positions, as was done this year by our Grand Commander.

Individually, as grand officers and committee members, even as men and Masons, we need to learn how and be able to admit when we need help. We all know how difficult that can be, after all, we are all imperfect. Let us all learn from this experience and let it not be repeated, even for good intent.

Finally, we applaud the Grand Commander for taking a very passionate interest in the financial health and wellbeing of the Grand Commandery and working diligently to overcome the challenges we are currently experiencing. Please see the report of the Assistant Grand Treasurer for additional financial review considerations.

Due to medical and technological challenges, the 2022 distribution was not made in December 2022. Your Endowed Membership Committee is working to resolve the missing annual distributions.

With the proposed legislation it is our belief that we will be able to improve our return on investment regarding Endowed Membership funds. Our investment strategy will continue to evolve and modify allowing up to 50% of the funds to be invested in common stock or equal securities in nationally known corporations traded on the New York stock Exchange (such as American balanced Fund and American Income Fund) this is similar to what is allowed by the Grand Chapter and the Grand Council. The process of transitioning to this new investment strategy has been occurring over the past year and will continue to change as monetary conditions warrant.

Hopefully, the above-mentioned investment strategy will enhance the amounts that may be realized for future annual distributions to the Grand Commandery and the individual Commanderies.

in nationally known corporations traded on the New York Stock Exchange (American Balanced Fund and American Income Fund) and are being maintained at less than 50% of the total value of the Grand Commandery Funds. As CD interest rates are improving we believe there are opportunities to improve rates of return on Grand Commandery assets. This may include shopping for CD's from places other than local banking institutions. We are also looking forward to other avenues for money management moving into the secured digital era.

Interest bearing investments have been in a combination of interest-bearing money market accounts and Certificates of Deposit.

The strategy of investing in common stock or equal securities, as above noted, has been occurring over the past year and will continue to transition as monetary conditions warrant. Also, in concurrence with the Finance committee, it has been agreed that future earnings from the General Fund (Special Account) will de automatically transferred to the General Fund. Hopefully, these strategies will reduce future needs for per capita increases.

Presuming proposed Grand Commandery legislation is agreed to and approved we look forward to the new avenues that will be afforded to this committee for investment and improved operations.
