Kevin Michael Ritter was born on April 10, 1990, in Springfield, Missouri to parents Timothy L. Ritter and Marline M. Faherty. He has one younger brother, Corey Douglas Ritter, who resides in Blue Springs, Missouri. Kevin grew up in Fair Grove, Missouri, and attended kindergarten through twelfth grade at Fair Grove Schools, where he graduated in May 2008. He then attended Drury University in Springfield, receiving a Bachelor of Arts degree in May 2012. He is currently pursuing a Master of Arts in Communication and expects to graduate in May 2027. While attending Drury as an undergraduate, he met his best friend, closest confidante, and partner, Cecily Karin Robertson. They have been happily unmarried since October 26, 2009. They have two cats (Merlin and Cosmo), a nephew, and two godsons. They currently reside in Springfield, Missouri.

Kevin began his professional career working at Drury University for a year after graduation before moving to American National Property and Casualty Company (ANPAC), where he worked in the Underwriting department for eight years before deciding to return to higher education. He served the Grand Chapter as District Deputy Grand Lecturer of Region 7A and was elected to the Grand Chapter Line in 2018.

## **GRAND CHAPTER OFFICER REPORTS**

### **2025-2026 REPORT OF THE GRAND TREASURER**

*June 1, 2025 through March 31, 2026*

*To the Grand Chapter of Royal Arch Masons of the State of Missouri,*

While our third year as your Grand Treasurer has been very busy, I am very pleased to have Companion and Sir Knight Christopher L. Story, our Assistant Grand Treasurer, on the Office Team. Christopher is rapidly learning the job of Grand Treasurer and is actively contributing to the management of the workload. However, we still have more work to do in this next year in order to resolve the remaining issues.

#### **Grand Chapter Clerical Assistant**

Lady Debbie Hanson continues to be paid quarterly which aligns with the demands of reporting our Employee to the State and Federal Governments as well as making the requisite deposits/contributions.

The IRS 941 Employer's Quarterly Federal Tax Return forms for the four quarters of calendar year 2025 have been filed and all deposits made for Social Security, Medicare, and Federal Withholding Tax using the EFTPS portal. Included in those deposits were both the Employee and Employer monetary portions. In addition, the IRS 940 Employer's Annual Federal Unemployment (FUTA) Tax Return form for calendar year 2025 has been filed and the deposit made.

The IRS 941 Employer's Quarterly Federal Tax Return form for the first calendar quarter of 2026 has been filed and the deposit made for Social Security, Medicare, and Federal Withholding Tax using the EFTPS portal. Included in that deposit was both the Employee and Employer monetary portions.

The Missouri Division of Employment Security (DES) quarterly unemployment insurance reports for the four quarters of calendar year 2025 have been filed and all contributions, if any, made using the DES web portal. The unemployment insurance report for the first calendar quarter of 2026 has been filed and the contributions, if any, made using the DES web portal.

The Missouri Department of Revenue's (DOR) MO-941 Employer's Return of Income Taxes Withheld for calendar year 2025 has been filed and the withholding tax, additions, interest, and processing fee made using the DOR web portal.

The 2025 W-2 Wage and Tax Statement for Lady Hanson and the 2025 W-3 Transmittal of Wage and Tax Statements were filed and accepted by the IRS.

#### **Grand Chapter IRS Tax Status**

During the period of June 2025 through March 2026, REC Donald MacCormick (Grand Secretary, Grand Chapter of Missouri) worked with Lady April Dodd to complete and submit an IRS Form 1024 (Application for Recognition of Exemption Under Section 501(a) or Section 521 of the Internal Revenue Code) for the Grand Chapter of Missouri. The form had to be filed electronically using the Pay.gov Federal web site. On March 15, 2026, Lady Dodd filed the completed Grand Chapter IRS form 1024 and paid the \$600.00 user fee payment with her personal credit card. Lady Dodd was reimbursed by the Grand Chapter General Fund with Check Number 9085 in the amount of \$600.00 dated March 31, 2026. On May 2, 2026, REC MacCormick received a letter from the IRS Dated April 23, 2026, stating that the IRS had determined that the Grand Chapter was exempt from federal income tax under Internal Revenue Code (IRC) Section 501(c)(10). The letter further stated that the IRS had reinstated the Grand Chapter exemption for the period October 15, 2022, to the effective date of the letter under IRC Section 501(c)(8). The next step in the process for maintaining the exemption will be to file IRS form 990 (Return of Organization Exempt from Income Tax) or IRS form 990-EZ (Short Form Return of Organization Exempt from Income Tax) returns for the fiscal years since the reinstatement date of October 15, 2022. The future maintenance of the exemption will be to file an IRS form 990 or IRS form 990-EZ for each fiscal year.

The Grand York Rite of Missouri IRS Form 990-N (e-Postcard) for the tax year ending March 31, 2026, was successfully filed and accepted by the IRS. In addition, the Grand Chapter Palmyra Chapter No. 2 IRS Form 990-N (e-Postcard) for the tax year ending March 31, 2026, was successfully filed and accepted by the IRS.

### **Grand Chapter Missouri Certificate of Incorporation**

The Grand Chapter has a Certificate of Incorporation with the Missouri Office of the Secretary of State, with Articles, in all respects, comply with the requirements of Missouri Nonprofit Corporation Law. In addition, the Missouri Grand York Rite has a Certificate of Incorporation with the Missouri Office of the Secretary of State, with Articles, in all respects, comply with the requirements of Missouri Nonprofit Corporation Law. These certificates are required in order to establish business bank accounts in Missouri.

I filed the 2025 Annual Registration Reports for a Domestic Nonprofit Corporation for the Grand Chapter and the Missouri Grand York Rite, and paid the required registration and processing fees. The reports were accepted by the Missouri Secretary of State's Office.

### **Recovery of Outstanding Check Money**

The recovery effort of outstanding checks that began in 2024 is expected to continue through the next fiscal year. As of the writing of this report, \$1,191.05 of stale RARA checks have been recovered over the past year with one stale RARA check in the amount of \$71.10 currently listed as outstanding. A total of \$1,648.51 of stale Supply Fund checks have been recovered over the past year. There are five stale Supply Funds checks totaling \$1,923 listed as unrecoverable. There are six stale Supply Fund checks totaling \$793.82 currently listed as outstanding. A total of \$1,573.00 of stale General Fund checks have been recovered over the past year. There are two General Fund Checks totaling \$194.00 listed as unrecoverable. There are fifteen General Fund checks totaling \$11,248.28 currently listed as outstanding.

Here is an accounting of the outstanding General Fund and Supply Fund checks in hand awaiting resolution: July 2022 General Fund, 10 checks, \$1,927.00; March 2023 General Fund, 17 checks, \$9,321.28; July 2022 Supply Fund, 2 checks, \$110.00; November 2022 Supply Fund, 3 checks, \$83.82; and January 2023, 1 check, \$600.00. This represents a total of \$12,042.10.

There may be more outstanding checks that were not physically recovered, that will be discovered when the records of the period of June 2022 through March 2023 are reviewed.

### **Status of Liquid Bank Accounts**

A proposed legislative item decided during the 2025 Annual Convocation was to discontinue the Grand Chapter Leadership Fund program. Following the passage of the proposed amendment to repeal ARTICLE IX - Revenues of the Grand Chapter, Section 40 - Annual Dues, Paragraph D (the Leadership Fund program), a motion from the floor proposed that the former Leadership Fund money be returned to the Grand Chapter General Fund. The motion passed. Based on the actions taken during the 2025 Annual Convocation and with the approval of the Grand High Priest as well as the Grand Chapter Finance Chairman, I withdrew the former Leadership Fund money from Hawthorn Bank (HB) account 1726 in the amount of \$3,208.26 (without fee) in Cashier's Check 208465 on August 7, 2025. The HB account was then closed. On August 12, 2025, the HB check was deposited in the Commercial Trust Company (CTC) Grand Chapter deposit account. On August 25, 2026, the \$3,208.26 was transferred from the CTC Grand Chapter deposit account to the Jefferson Bank (JB) Grand Chapter General Fund Operating account.

A proposed legislative item decided during the 2025 Annual Convocation was to discontinue the Grand Chapter Triennial Fund program. Following the passage of the proposed amendment to repeal ARTICLE XXVI - Miscellaneous, Section 214 - Triennial Fund, a motion from the floor proposed that the former Triennial Fund money be returned to the Grand Chapter General Fund. The motion passed. Based on the actions taken during the 2025 Annual Convocation and with the approval of the Grand High Priest as well as the Grand Chapter Finance Chairman, I withdrew the former Triennial Fund money from First Mid Bank & Trust (FMB) account 7723 in the amount of \$2,040.28 (without fee) in Cashier's Check 624211 on August 7, 2025. The FMB account was then

closed. On August 12, 2025, the FMB check was deposited in the Commercial Trust Company (CTC) Grand Chapter deposit account. On August 25, 2026, the \$2,040.28 was transferred from the CTC Grand Chapter deposit account to the Jefferson Bank (JB) Grand Chapter General Fund Operating account.

On February 19, 2026, with permission from the Grand High Priest and the Finance Chairman, I withdrew the Grand Chapter Supply Fund money from Mid America Bank (MAB) account 2705 in the amount of \$10,279.55 (without fee) in Cashier's Check 007286. The MAB account was then closed. On February 26, 2026, I opened the new Grand Chapter Supply Fund account 5615 with Jefferson Bank (JB) and deposited the MAB check into the new Supply Fund account. This action was part of the move to consolidate all Grand Chapter accounts in a single banking system under the Central Bank (JB is part of the Central Bank system) in anticipation of the future change in the Office of the Grand Treasurer.

### **Long-Term Investment of Funds**

An issue that carried over from last year was the investment of certain investable monies in long-term investment instruments.

The investable funds across the Grand Bodies are: Jefferson Bank General Fund Hold accounts (JB GrCH GF Hold, JB GrCO GF Hold, & JB GrKT GF Hold), Jefferson Bank Foundation Fund/Charity Endowment Fund Hold accounts (JB GrCH FF Hold, JB GrCO CEF Hold, & JB GrKT CEF Hold), and Jefferson Bank Endowed Membership Fund Hold accounts (JB GrCH EMF Hold, JB GrCO EMF Hold, & JB GrKT EMF Hold).

The investable select funds are: Jefferson Bank GrCH Palmyra Fund Hold account (JB GrCH PF Hold), Jefferson Bank GrKT Holy Land Pilgrimage Fund Hold account (JB GrKT HLPF Hold), and Jefferson Bank GrKT Educational Foundation Fund Hold account (JB GrKT EdF Hold).

On February 20, 2026, the Grand High Priest of the Grand Chapter of Missouri sent a letter dated February 19, 2026, to the Grand Master of the Grand Council of Missouri officially notifying him that the orderly transfer of Grand Council money out of the Grand Chapter's Capital Group (CG1) account was thereby enforceably required. He further stated that the transfer of Grand Council money could be accomplished without any transfer fees.

On February 20, 2026, the Grand High Priest of the Grand Chapter of Missouri sent a letter dated February 19, 2026, to the Grand Commander of the Grand Commandery of Missouri officially notifying him that the orderly transfer of Grand Commandery money out of the Grand Chapter Capital Group 1 (CG1) account was thereby enforceably required. He further stated that the transfer of Grand Commandery money could be accomplished without any transfer fees.

On February 20, 2026, the Grand High Priest informed me by letter dated February 19, 2026, that I was thereby authorized to facilitate moving the shares attributed to the Grand Council and the Grand Commandery, respectively, out of the Grand Chapter's CG1 account to the destinations of their choosing.

On February 19, 2026, I met briefly with Mr. Russ Bell, Vice President, Financial Advisor, LPL (our Investment Banker) concerning the plan to move certain shares out of the CG1 (9778) account to other Capital Group account destinations. On February 26, 2026, I met with Mr. Bell to work on completing the necessary paperwork for the planned transfers.

On March 2, 2026, all Grand Commandery Educational Foundation shares were transferred from the Grand Chapter's CG1 account to the Grand Commandery Educational Foundation's Capital Group (CG3) account by Mr. Bell. On March 9, 2026, all Grand Council shares were transferred from the Grand Chapter's CG1 account to the Grand Council's Capitol Group (CG4) account by Mr. Bell.

The Capital Group 1 (CG1) account now contains only Grand Chapter money. The CG1 account is tied to the Jefferson Bank (JB) Grand Chapter General Fund Operating account (JB GrCH GF Op) for ACH transfers. All purchases are facilitated by Mr. Bell. The purchase limit for CG1 investments is \$100,000.00 per day. In addition, the investment level across the Grand Bodies is sufficient that all purchases can be made at Net Asset Value (NAV) so there are no fees.

On January 26, 2026, I sent an email to EC Terry D. Coppotelli, Investment Chairman, with a recommendation to move \$51,000.00 of Endowed Membership money from the Grand Chapter's Jefferson Bank (JB) Endowed Membership Holding account (JB GrCH EMF Hold) to the Investment Company of America (Am

Inv) in the Grand Chapter's Capital Group 1 (CG1) account. On March 5, 2026, I received authorization from EC Coppotelli to make the investment. On March 24, 2026, \$51,000.00 was transferred from the JB GrCH EMF Hold account to the JB GrCH GF Op account. On March 24, 2026, \$51,000.00 of Am Inv shares were purchased by Mr. Bell in the Grand Chapter's CG1 account.

**Grand Treasurer's Office**

Your Grand Treasurer and Assistant Grand Treasurer continue to work diligently to bring transparency to the office. We attended the Grand Chapter Grand Officer Zoom meetings. During those meetings, we provided requested financial review briefings to the Grand Officers and answered questions that the Grand Officers asked concerning the finances of the Grand Chapter.

The duties of the Assistant Grand Treasurer during this past fiscal year were monthly reconciliation of the financial spreadsheets, processing of deposit records, and recovery of outstanding check money. The Grand Treasurer and the Assistant Grand Treasurer plan to continue expanding the duties of the Assistant Grand Treasurer during the next fiscal year.

During the 2023-2024 fiscal year, the Grand Treasurer's Office received thirteen banker boxes of historical paper records from the office of the previous Grand Treasurer. The task of reviewing the mountain of documents is daunting and may require years to complete but remains a goal of the Office.

## **REPORT OF THE GRAND SECRETARY**

*To the Grand Chapter of Royal Arch Masons of the State of Missouri,*

Companions, it has been another busy term in the Grand Secretary's office. I would like to start this report by expressing my thanks to April Dodd for her hard work, diligence, and attention to detail in assisting us in the filing of 1024's with the IRS in order to get the Grand Chapter, Grand Council, and Grand Commandery back in compliance with the IRS. Our non-profit status, as a 501 (c)(10), has been re-instated with the effective date of October 15, 2022, the original date of revocation. All three bodies are now once again tax-exempt. Individual donors to each of the three Grand Bodies can once again deduct contributions made exclusively for charitable purposes as specified in IRC Section 170(c)(4) and meet the other specifications of section 170. As the regulatory landscape continues to become more integrated and complex, we will be reviewing our processes of statutory filing requirements, and may engage external experts to do so, to review our compliance, and ensure we remain compliant in the future.

In reviewing the costs of the Grand Convocation it may be necessary at some point to charge a registration fee to ease the burdens of hosting. We do not expect that to happen soon, the costs of the Grand York Rite Sessions for the next two years in Springfield are likely the lowest we have seen for several years. But, it may be necessary in the future. The meeting space used in each facility is free, but it is supported for a minimum number of room occupancies and meal purchases.

A couple of years ago Russell and Debbie Hanson announced their retirement from their duties with the Grand Chapter, Grand Council, and Grand Commandery. Lady Tara L. Ornsbey will step into Debbie's shoes in 2 years and has been working with Lady Debbie this year, documenting processes, and preparing to take on an ever-increasing workload as training and familiarization progresses. Simultaneously we are examining those processes and preparing to simplify or automate them where possible. We thank Lady Tara for stepping up.

We were saddened to process the consolidation this year of Greenfield Chapter No. 38 with Springfield Chapter No. 15 on December 12, 2025. It is sometimes necessary to consolidate, but it is always a loss especially for an organization with such an exalted history as Greenfield.

### **Growth Awards**

This year our growth awards are based on a slightly different calculation from past years. This year we have decided to base Chapter Growth awards on those factors that we can control, such as suspension, demits, and exaltations. We have no control when someone is called home, so deaths will not be a factor in this year's calculations.

There were 82 Exaltations, 55 affiliations, and 17 reinstatements during the 2025 calendar year, leading to an overall decrease in membership of 49 (demitted 84, suspended 40, deceased 79). If we remove those who passed in 2025, there is an overall growth 30. Chapter growth awards can be found in the Report of the Committee of Education.

### **Secretary Training**

Over the course of this last year it became obvious the little knowledge was being passed onto new Secretaries. Over the course of the next 6 months, we will be reaching out to all Secretaries and will be developing new tools to ensure Secretaries are aware of their responsibilities and shall provide the training to enable them to carry out their jobs.

### REPORT OF THE COMMITTEE ON INVESTMENTS

*To the Grand Chapter of Royal Arch Masons of the State of Missouri,*

Companions, it is with great satisfaction that we report that, at last, all the Grand Chapter's surplus funds have been turned over to the Investment Committee, and all these funds have been placed in investments as designated by the Committee. A special thank you to the Junior Past Grand High Priest, current Grand High Priest, and current Grand Treasurer for accomplishing this long-awaited task. The end of May will mark the closure of this fiscal year. At that time, the invested dollar benchmark will then be set so that we can give periodic updates on investment performance.

In addition to the funds that were allocated prior to involvement of the Investment Committee, the remainder of surplus funds have also been placed in the Capitol Groups funds, with the majority in the Investment Company of America (ICA). This fund has existed for over 80 years, and its objective is long term growth and income. Since its inception in 1934, it has averaged a rate of return of 12.3%. **CAUTION: It is critical to understand that returns will fluctuate.** The average bear market (defined as a 20% reduction in value) occurs approximately every 4 years, with the last one occurring in 2022.

There are several things that could be done to make our ongoing management of surplus funds more efficient. First, the Grand Chapter Finance Committee needs to establish how often it will be moving earnings from the investment account to the operating account. This amount should become evident and consistent over time. Once established, a cash balance in the operating account will prevent us from being forced to liquidate investments during a down market.

Another strategy that should be examined is to utilize the Capitol Groups Money Market Fund to park the Chapter Operating Funds, which are currently held in Jefferson Banks Money Market Account. Although this Money Market Fund is held within an investment firm, it is comprised of the same securities that back a Money Market account, however it generates several times the interest. While there is no bylaw preventing this, there has been hesitation by the Chapter to do this.

Lastly, consideration should be given to changing the Grand Chapter bylaws as to the Treasurers' responsibilities when it comes to the investments. No money should be removed from the Investment Account by anyone other than the Grand Secretary. Due to the sometimes dynamic and fast pace of the stock market, the Investment Committee should be able to speak to, and if necessary, have trades executed independently.

A second option would be better utilization of a non-banking Financial Advisor (FA). Our process of working with the current bank FA is cumbersome due to restrictions placed on us due to FINRA, Jefferson Banks regulations, and our By-law requirements.

A non-bank FA could be given freedom and discretion to manage our portfolio independently under our general instructions and goals. It feels we are limited in the choices we have now. While American Funds new purchases are not charged a commission, the internal expenses charged yearly (12b-1 fees) tend to run higher than some alternatives.

**REPORT OF COMMITTEE ON FINANCE AND BUDGET**

*To the Grand Chapter of Royal Arch Masons of the State of Missouri,*

Please see the report of the Grand Treasurer for an in-depth report of the Grand Chapter Finances. With the cooperation of the Grand Treasurer and the Investment Committee we have placed out investments in a position that our money is now working for us.

The Finance Committee met on April 11, 2026, and approved the budget for the 2026-2027 Capitular Year. While investment results are still new, a trend is developing that shows growth in our investments. The Grand Treasurer and the Investment Committee are to be commended for their hard work in putting our funds to their best use.

The Finance Committee has monitored the financial records of the Grand Chapter on a regular monthly basis. This allows us to be completely aware of our current and projected financial position.

Since our last report the Grand Treasurer and the Investment Committee have been able to separate the co-mingled funds of our investment portfolio to separate accounts for each body of the Grand York Rite. This allows for better tracking and record keeping.

We find that the Grand Treasurer and his office are continuing to maintain proper fiduciary standards as they apply to the Grand Chapter.

## LEGISLATION FOR ACTION AT THE 2026 GRAND CHAPTER CONVOCATION

### PROPOSAL No. 1

#### PROPOSAL TO AMEND THE CONSTITUTION AND BY-LAWS OF THE GRAND CHAPTER OF ROYAL ARCH MASONS OF THE STATE OF MISSOURI TO READ AS FOLLOWS:

#### ARTICLE II Grand Officers

**Section 9B. Grand Historian.** A Grand Historian shall be ~~elected for a three-year term which shall be subject to re-election for one additional three-year term~~ appointed by the Grand High Priest. The duties of the Grand Historian shall be to collect and assemble historical data pertinent to the Grand Chapter of Royal Arch Masons State of Missouri. Such data shall be published annually in the proceedings of the Grand Chapter. ~~In addition to Proceedings publication, such newly accumulated data will be made available in printed form to each companion attending the Annual Convocation.~~ The Grand Historian will be free to determine his choice of historical data to be compiled each year. The Grand Historian shall be free to publish his assembled data in other publications of Masonic character without prior approval of the Grand Chapter Royal Arch Masons of the State of Missouri. The Grand Historian will receive no compensation ~~but, if he is not a Past Grand High Priest, he shall receive mileage and per diem for his attendance at the Annual Convocation, providing such payments are currently in effect for other Grand Officers.~~ The honorary title of the Grand Historian will be Right Excellent Companion or the highest honorary title held by that individual in the Grand Chapter. (Adopted May 14, 1999)

*Statement of purpose*

The purpose of this proposed amendment is to provide clarity, continuity, and strengthened structure to the office of Grand Historian, ensuring that the historical record of the Grand Chapter is preserved and communicated in a consistent and meaningful manner. This amendment seeks to:

- Clarify the method of service and term structure of the Grand Historian.
- Reinforce the expectation of annual compilation and publication of historical data.
- Provide continuity in the stewardship of the Grand Chapter's historical archives.
- Ensure that the Companions receive the benefit of the historical materials contemplated by our By-Laws.

The proposed changes are not directed toward any individual, but rather toward strengthening the institutional framework of the office for the long-term benefit of the Craft. By adopting this amendment, the Grand Chapter affirms its commitment to preserving its history, honoring its traditions, and ensuring that future generations may look back upon our labors with clarity and pride.

#### ARTICLE VXIII

##### *Dues*

L. The Grand Secretary shall annually remit to the secretaries of participating subordinate chapters their prorated portion of the earnings of the Endowed Membership fund minus per capita. This is provided that no earnings shall be distributed on any Endowed Membership until after January 1 of the second (2nd) calendar year after such fee, paid in full, is deposited with the Grand Secretary. ~~When an Endowed member dies, the Grand Chapter will continue to receive his per capita, less 20% and his Chapter will continue to receive his prorated earnings, less 20%. The retained 20% will be added to the fund's principal to provide for growth in the fund. Prorated earnings shall be based on the member's chapter dues that existed at the time the individual entered the Endowed Membership Program. Per capita shall be the per capita By-Laws of the Grand Chapter of Royal Arch Masons of the State of Missouri Revised May 18, 2007, Including Amendments and Resolutions as of June 12, 2025, 31 that existed at the time the individual entered the Endowed Membership Program. (Amended May 8, 1986~~  
The Endowed Membership Fund shall establish as the Base Principal those funds received by the Grand Secretary from subordinate chapters for the purchase of an Endowed Membership. As new memberships are purchased the Base Principal will increase. At no time shall the fund draw down below this Base Principal.

Distribution of the Investment Growth in the fund shall follow these guidelines. The Investment Committee shall, as soon as practical after January 1 of each year, advise the Endowed Membership Committee the amount of gain or loss in the investments of Endowed Membership Fund.

Any gains accrued will be distributed as follows: First, the current Per Capita will be paid for all living Endowed members by the Grand Chapter. Second, from the remaining funds, 30% will be retained in the Endowed Membership Fund to fortify the continued growth of the fund and become part to the Base Principal. Third, the remaining 70% will be distributed to the subordinate Chapters on a prorated basis for the total number of endowed members, living and deceased that are/were members of that Chapter.

*Statement of purpose*

The purpose of this amendment is to clearly define, protect, and strengthen the long-term structure and distribution methodology of the Endowed Membership Fund of the Grand Chapter of Royal Arch Masons of the State of Missouri.

This proposal formally establishes the concept of a protected Base Principal, defined as all funds received from subordinate chapters for the purchase of Endowed Memberships. The amendment ensures that this Base Principal shall continually increase as new Endowed Memberships are purchased and shall never be reduced. This safeguard preserves the perpetual nature of the Endowed Membership Program and protects the integrity of the funds entrusted to the Grand Chapter.

Additionally, this amendment provides a clear and orderly framework for the annual distribution of investment growth. It:

- Establishes the priority payment of current Per Capita for all living Endowed Members to the Grand Chapter.
- Retains thirty percent (30%) of remaining gains within the Endowed Membership Fund to strengthen and fortify its continued growth.
- Distributes the remaining seventy percent (70%) to subordinate chapters on a prorated basis for all endowed members, living and deceased, affiliated with each chapter.

By clearly defining principal protection, distribution priorities, and proportional allocation methods, this amendment promotes financial transparency, stability, and responsible stewardship. It ensures the Endowed Membership Fund remains perpetual, equitable, and beneficial to both the Grand Chapter and its subordinate chapters for generations to come.

*Statement of purpose*

The purpose of this amendment is to provide reasonable flexibility in the administrative use of the Masonic Membership Solutions (MMS) system by removing an unnecessary mandatory monthly login requirement for Chapter Secretaries and IT Representatives. While maintaining accurate and timely membership records is essential, requiring monthly system access regardless of whether membership transactions or updates are pending places an administrative burden on local Chapters without any benefit. Many Chapters experience periods in which no membership activity occurs, making routine mandatory logins unnecessary.

This amendment does not diminish the responsibility of Secretaries and IT Representatives to promptly process approved membership changes. Rather, it removes a rigid procedural requirement that does not materially improve record accuracy or system integrity. By adopting this amendment, the Grand Chapter promotes efficient administration, respects the time of its officers, and maintains practical oversight of membership reporting.

Administrative requirements should serve a clear operational purpose and not impose obligations that do not contribute to improved governance or recordkeeping.

### REPORT OF COMMITTEE ON EDUCATION

*To the Grand Chapter of Royal Arch Masons of the State of Missouri,*

It was an honor to be appointed chairman of this committee for the past year. The experience and knowledge gained from this committee will help any future Grand Chapter officer as they continue on their way to the Grand East. The committee could not have operated or been successful without the assistance of all the members and so I would like to thank each of them for their contributions and communications throughout the year. No matter how many emails I sent, or the time at which they were sent, they always responded in a timely and supportive manner.

Our first order of business was to update the Distinguished Chapter Award form. In July we made several positive changes to the form. In addition to a few technical and grammatical changes, we amended or added:

- Regional York Rite Conferences changed to the Statewide York Rite Conference;
- Added a section for awarding points for Ritual cards, new or renewals;
- Added a section for presentation of RARA in a symbolic Lodge;
- Combined the sections regarding RARA presentations in the home Chapter.

It was our goal to get this in the hands of all High Priests in the jurisdiction early in the year because we know all High Priests are responsible for tracking the points - not the Chapter Secretary!! With the assistance of the Grand Secretary, this was ready and presented to all Chapters in the beginning of September. This would allow them to begin tracking points as soon as possible. Your Education Committee strongly believes that every Chapter in the state can, and should, earn the Distinguished Chapter Award.

Education for the year was focused on mentoring new members as well as reviewing material the more experienced members may not have visited in a while. We hope the education on each of the four degrees provided insight and understanding to new members and created an opportunity for discussion in the Chapter.

VEC Douglas C. Rose, Jr. proposed the idea of creating a Missouri Capitular Education manual based loosely off the example from the Grand Chapter of New York. This has not yet started but is in the process of organization by the Committee. Finally, a Capitular Mentoring Guide, loosely following the structure of the Missouri Freemasons Mentoring Program, was discussed among the Committee which we hope will be provided in 2026-2027.

We wish to express our gratitude to MEC Ritter and to the multitude of members of the Grand Chapter of Royal Arch Masons across the State of Missouri.

## **REPORT OF COMMITTEE ON RETURNS OF CHAPTERS**

*To the Grand Chapter Royal Arch Masons of the State of Missouri,*

The Grand Chapter Committee on Returns of Chapters was charged with reviewing the annual returns for accuracy and completeness for all Grand Chapter subordinate Chapters. Most of the communication between members was conducted via email.

In November 2025, the Grand High Priest was contacted by the Committee Chairman to determine his intent and directions for the committee. The Chairman then contacted the Grand Secretary in December 2025 to discuss the Grand Chapter's current process and captured the annual return submission process for that office. The Chairman used the information from the Grand Secretary and the Grand High Priest to developed draft guidelines for the committee and sent them to the Grand High Priest for review. When the review was completed, the Chairman sent the guidelines to the committee members for their input. The following was the final review process:

The committee members will review the Annual Return packets for the following items:

- a. The check for per capita and fees is the correct amount.
- b. The financial report form is completed.
- c. The annual audit form is completed.
- d. A copy of the acceptance notice of the Chapter's latest electronic submission of their 990 filing.

If any item is missing or incomplete, a record of the subordinate Chapter name, number and a description of the missing and/or incomplete item noted. After the review, the committee member will submit the findings of his record to the Committee Chairman, who will consolidate all the records into a single report.

The annual reporting period began in January 2026, but most of the reports did not come in until mid to late February 2026. The committee received twenty-four of the twenty-eight active Chapters (excluding historical chapter Palmyra Chapter No. 2) at the time of this report. The four missing Chapters were Lebanon Chapter No. 64, Triune Chapter No. 93, Orient Chapter No. 102 and Keystone Chapter No. 146.

Our review of the Chapter annual returns found that most were complete except for some 990 filings. Some Chapters had filed their previous 990Ns for the period of April 2024 to March 2025, which meant they would not be able to file their 2025 990N until after the annual return submission period was over. We found those returns acceptable. We found Meridian Sun Chapter No. 61 submitted their 2024 990N and two Chapters did not have an actual 990N in their annual return: Hannibal Chapter No. 7 and Rolla Chapter No. 32, which were on the IRS Revocation List. The IRS said that they are no longer recognized as tax-exempt subordinates in a group exemption letter. This was determined to be an issue due to the resubmission of the Grand Chapter Tax documentation. Additionally, we did discover one chapter paid .20 cents more on their return check to the Grand Chapter.

This completes the report of the Grand Chapter Committee on Returns of Chapters. On behalf the entire committee, I would like to extend our sincere thanks to the Grand High Priest and you, the Companions for giving us the opportunity to serve.

### **REPORT OF COMMITTEE ON ROYAL ARCH RESEARCH ASSISTANCE**

The Grand Chapter of Missouri has one primary charity, Royal Arch Research Assistance. Donations are collected through our subordinate Chapters in the State when dues are paid or during the occasional Table Chapter. The most notable event is the Annual Fish Fry hosted by Triune Chapter No. 93 which has been ongoing for the last 15 years or more. Each year the Grand High Priest is the guest of honor and this event consistently raises a substantial amount of money for R.A.R.A.

Regions 4, 6, and 7 participated in a three-region Table Chapter hosted in Lebanon. It was very well attended, with over 50 in attendance. The total amount raised from the event will be announced at this annual Grand Session.

Liberty Chapter No. 3 sponsored the Region 2 Table Chapter on March 16, 2026. The event was well attended and included two Rising Sun DeMolay members who were present to assist in various duties. VEC Steve Bright presented on R.A.R.A. and CAPD and raised nearly \$800.00 in donations for R.A.R.A.

Each sitting Grand High Priest decides the recipient of funds raised from his coin sales, and this year MEC Ritter has chosen RARA to be the recipient of those proceeds. Additionally, at the official reception of MEC Ritter at his home Chapter in Springfield, cigars were sold with those proceeds going to R.A.R.A. upon his request.

Springfield Chapter No. 15 celebrated a milestone of 175 years. The celebration was exciting with dignitaries from all Masonic bodies across the state, along with city and county officials who enjoyed a nice brunch and then retired to the Tabernacle to watch the rededication ceremony. A coin was struck to commemorate this event and proceeds from the sale of that coin were donated to R.A.R.A.

Caldwell Chapter No. 53 hosted a Sporting Clay Shoot for R.A.R.A. in May 2026. At the time of this report, the event had not yet taken place but given the fact that the event is in the hands of worthy Companions, we trust that it was successful.

The R.A.R.A. committee sent two requests to all Chapters in Missouri in an effort to raise additional money for the charity. The first was a “challenge” to every Chapter to donate an amount equal to \$3.65 for every member in their Chapter. The second was an R.A.R.A. drive in April to coincide with the annual fundraising campaign of Autism Speaks. This organization is one of the beneficiaries of grant monies from R.A.R.A. to continue research to end autism. This drive pitted Chapters in each region against each other. No other rules. Just one goal: raise more money than the other Chapters in the region. Those results will also be announced at this annual session during the awards ceremony.

Moving forward we encourage each Chapter to continue promoting this Charity in their Chapters, Lodges, and communities and to come up with new and creative ways to support this charity.

## **REPORT OF COMMITTEE ON MEMBERSHIP & RETENTION**

*To the Grand Chapter of Royal Arch Masons of the State of Missouri,*

It has been a pleasure for the Membership and Retention Committee to serve Most Excellent Companion Kevin M. Ritter during the 2025–2026 year.

In 2024–2025, the Grand York Rite bodies enacted changes to the Constitution and Bylaws, as well as the Laws and Regulations of the respective bodies. These changes require each local and constituent York Rite body to establish a committee to investigate the reasons for a member's delinquency and determine whether there are ways to retain that member. The findings are then to be reported to the Membership and Retention Committee. Membership continues to be a challenge within the majority of fraternal organizations. We must find innovative ways to retain our current members while making the York Rite of Freemasonry more appealing to both Craft Masons and non-Masons alike. Freemasonry remains a viable and meaningful organization, and we must continue to build upon its strengths.

We also continue to reinforce the Grand Chapter's legislation passed in 2024–2025: no member may be suspended for non-payment of dues until the Chapter's Retention Committee has met with him and submitted a report detailing the outcome of that meeting. This ensures that each Chapter remains compliant with the policy. We encourage continued engagement with Blue Lodges through Red Coat Blitzes, walk-about, and similar outreach efforts. Additionally, Chapters, Councils, and Commanderies are encouraged to maintain a visible public presence and participate in charitable outreach.

Region 6 has been especially active, conducting a food drive, a warm clothing drive, and Salvation Army bell ringing, as well as sponsoring a float in the 2025 Christmas Parade.

Efforts are also underway to track the number of Festivals conducted. Region 6 sponsored a York Rite Festival in October, resulting in 16 Companions being exalted. Participating Regions included 4, 5, 6, and 7. We have also seen an increase in Red Coat Blitzes, Chapter walk-about, and the wearing of Red Coats during Blue Lodge visits. Additionally, Table Chapters—such as the one hosted on January 30, 2026, involving Regions 4, 5, 6, and 7—have proven successful, particularly when open to the public.

Your Membership and Retention Committee is here to assist you; however, we cannot do the work for you. We encourage you to reach out at any time or connect with the York Rite bodies mentioned above to learn what strategies have been effective for them. A single approach will not work for every organization—success depends on finding what works best for your own body. Remember, doing nothing has a guaranteed result.

## **REPORT OF THE ORDER OF HIGH PRESTHOOD**

The Order of High Priesthood is an association for past and current High Priests of Chapters of Royal Arch Masons, sometimes referred to as the Anointed Order of High Priesthood. In antiquity, this degree was known as the Order of Melchizedek. The Holy Order of High Priesthood tells the story of Abraham returning from the slaughter of the kings and his encounter with Melchizedek, High Priest of Salem. The candidate is then solemnly anointed, consecrated, and set apart to the Holy Order of High Priesthood. If you have been or currently are, the High Priest of your Chapter, you should consider receiving this degree, as it furthers your knowledge and understanding of the Royal Arch Degrees.

The Annual Convention of the Anointed Order of High Priesthood of Missouri was held on Thursday, June 12, 2025, at 1:30 p.m. in Ballroom A of the Marriott Country Club Plaza Hotel in Kansas City, Missouri. Under the leadership of Excellent President Bobbie White, the Order was conferred upon twelve Missouri candidates. Each candidate had been certified by the Grand Secretary of the Grand Chapter of Royal Arch Masons of the State of Missouri as having served, or being then serving, as High Priest of his respective Chapter.

The twelve candidates, having been properly prepared, were received, anointed, consecrated, and set apart to the Holy Order of High Priesthood. The Order was conferred by a special ritual team appointed by the President, and the team presented a very impressive exemplification of the Order. The continued use of a dedicated ceremonial cast remains one of the strengths of this Order and helps preserve the dignity, solemnity, and beauty of the degree.

During the business of the Convention, the proceedings of the 2024 Convention were read, corrected, and approved. The Treasurer’s report was received, including balances in the Bank of Franklin County certificate of deposit, savings account, and operating funds. The Order also continued its support of proper ceremonial work and benevolent traditions, including expenses related to the Past Grand High Priest apron, degree supplies, and ritual printing. A motion was also made and approved to purchase up to twenty Bibles for future use in the ceremonies.
