BIOGRAPHY OF THE GRAND MASTER

Aaron M. Shoemaker was born and raised in Independence, Missouri. He and his wife, Casey, were married in June 2001. They have one daughter, Elizabeth who was born in July 2007. They reside in Lee's Summit, Missouri.

Aaron is currently the Search Marketing Manager for the global media company Andrews McMeel Universal. Previously he served as the Digital Engagement Strategist, and Manager of Consumer & Client Operations for Universal Uclick (now known as Andrews McMeel Syndication) - a division of Andrews McMeel Universal - where he provided editorial features, comic strips, puzzles and other content to leading media outlets such as the New York Times, the Washington Post, USA Today, the Los Angeles Times, Yahoo!, Google and many others. Prior to that, Aaron spent seven years managing a team of Customer Care and Information Technology

professionals located in the United States and England for the mobile application and media company Handmark, Inc. He also spent several years at Sprint working first as a Systems Integrator in the Operations Systems Support Center and then as a Network Systems Engineer in the System and Technology Integration Center within the Technology and Advanced Systems Development division.

He is a Past Master and Endowed Life Member of East Gate Lodge No. 630, Kansas City, Missouri. East Gate Lodge No. 630 received the Grand Lodge of Missouri's "Honor Lodge with Distinction" award upon completion of his term as Worshipful Master. He has served the Grand Lodge of Missouri as the chairman or member of numerous committees. In the past, Aaron has also been active in Kansas Masonry co-founding two Lodges. On September 27, 2011, he was appointed and installed as the Right Worshipful Grand Orator of the Grand Lodge of Ancient Free and Accepted Masons of the State of Missouri for the 2011-2012 Masonic year. He was made an Honorary Oklahoma Mason by the Grand Master of the Grand Lodge of Oklahoma, AF&AM in November 2011. In December 2011, he was honored to assist in raising Bro. Clifton Truman Daniel, grandson of the 33rd President of the United States of America MWB Harry S. Truman, to the Sublime Degree of Master Mason. He was subsequently instrumental in bringing Bro. Daniel to the Grand Lodge of Missouri where Clifton served as the Fall 2013 Truman Lecturer and assisted in opening the Missouri Masonic Research Library.

Aaron is an honorary life member and an Advisor in the Order of DeMolay. He is currently serving as the Director of Marketing for Missouri DeMolay. In 2018 he received the Honorary Legion of Honor.

Aaron is Past President of the Kansas Lodge of Research and assisted in the production of A History of Masonry in Kansas Vol. II. He is an active member of the Missouri Lodge of Research where he served for many years as the Editor and Chairman of the Publications Committee. Additionally, he was the founder and longtime Chairman of the Truman Lecture Series where he successfully managed over 12 major events. In this capacity, he brought over a dozen leading Masonic scholars to Missouri to address full-capacity audiences. In recognition of his efforts in the field of Masonic research and education, Aaron was elected as a member of the Masonic Study Society which was founded by JSM Ward and meets in London, England. In 2008, he was named a Founding Fellow of the Masonic Society where he currently serves on the board of directors. He holds membership in numerous additional Masonic Research organizations.

In recognition of his service to the Grand College of Rites of the United States of America, he was awarded the rank and decoration of Knight Grand Cross by the 2009-2010 Grand Chancellor, M. Ill. David Dixon Goodwin, FGCR, KGC. During the 2011 Annual Convocation he was appointed as the Right Illustrious Grand Seneschal of the Grand College of Rites of the United States of America by M. Ill. Martin P. Starr, FGCR, KGC, Grand Chancellor 2011-2012 and served in each advancing line office culminating with his election and installation as the Most Illustrious Grand Chancellor on February 11, 2017.

While Aaron enjoys all areas of Masonic research, his personal focus is on the study of various Masonic ritual and symbols. He has presented papers before numerous Masonic bodies around the United States. Several of his papers have been published in national Masonic publications such as Amicus (a publication of the Supreme Council, 33°, Southern Jurisdiction

of the Ancient and Accepted Scottish Rite of Freemasonry), Miscellanea (the annual publication of the Grand Council of Allied Masonic Degrees of the United States of America), and the Journal of The Masonic Society.

In the Ancient and Accepted Scottish Rite, he is a life member of both the Valley of Kansas City (Missouri) and the Valley of Northeast Kansas. He is a Past Venerable Master of the Kansas City Lodge of Perfection (2011). On February 25, 2015, he was elected to serve a two-year term as a Trustee and was reelected as a Trustee in 2017. Aaron serves on the Advisory Conference for the Valley of Kansas City's Personal Representative of the Sovereign Grand Inspector General in Missouri. Aaron is member of the board of directors of the Valley's charitable foundation. He served for four years as the Librarian and Historian of the Valley of Kansas City (Missouri) Scottish Rite. He has participated in degree work in both the Valley of Northeast Kansas (4°, 18°, and 32°) and the Valley of Kansas City (30°, and 32°). He served as the Asst. Class Director for several years and assisted in the KCCH investiture in the parts of "Grand Chancellor", and "Grand Minister of State." He has served the Supreme Council, 33°, Southern Jurisdiction of the Ancient and Accepted Scottish Rite of Freemasonry as the moderator of the Supreme Council's internet forum, by providing ad hoc advice on technological issues and was selected by the Sovereign Grand Commander as a Fellow in 2004. Aaron has also been appointed by the Sovereign Grand Inspector General in Missouri to serve the Scottish Rite as the Director of Communications for the Orient of Missouri (June 2007 - Present). He became a voting member in 2017 and as of that time had served for over a decade as the Chairman of the Communications Committee for the Scottish Rite Foundation of Missouri, Inc. On October 2nd, 2009, Aaron was elected to receive the rank and decoration of Knight Commander of the Court of Honour (KCCH) by the Supreme Council, 33°, Southern Jurisdiction, U.S.A. He is life member of the Scottish Rite Research Society and in 2017 was elected a member of its Board of Directors.

Sir Knight Shoemaker is very active in the York Rite having served as Illustrious Master, Excellent High Priest, and Eminent Commander. In recognition of his service to the York Rite of Freemasonry, Aaron has received the rank and title of Knight of the York Cross of Honour (KYCH). He is a life member in Missouri Priory No. 17, KYCH and an honorary member of Lily of the Valley Priory No. 1 (the Premier Priory) in North Carolina. He served as the Regional Grand Commander of Region 3 of the Grand Commandery of Knights Templar of the State of Missouri. Most Illustrious Companion Shoemaker served as the Regional Deputy Grand Master for Region 3A of the Grand Council of Cryptic Masons of the State of Missouri and was elected and installed as Most Illustrious Grand Master for the 2018-2019 term. He is also the Grand Representative of the Grand Council of Royal and Select Masters of the State of Iowa near the Grand Council of Cryptic Masons of the State of Missouri, Grand Representative of the United Supreme Grand Chapter of Mark and Royal Arch Masons of NSW and the ACT near the Grand Chapter of Royal Arch Masons of the State of Missouri. He received the Grand Council's Lewis and Clark Award for Distinguished Service in 2009 and the Grand Commandery's Lewis and Clark Award for Distinguished Service in 2011. He has also served as a member of numerous committees for all three Grand York Rite bodies in Missouri. Sir Knight Shoemaker served the Grand Encampment of Knights Templar of the United States of America as a member of the Knight Templar Magazine Editorial Review Board for 7 years.

He has been elected to membership in numerous honorary and invitational bodies including:

The Allied Masonic Degrees (AMD) where he is a Past Sovereign Master of Santa Fe Council No. 417 (2011-2012) and recipient of the Knight Commander of the Royal Order of the Red Branch of Eri. On February 15, 2014, Right Venerable Brother Shoemaker was appointed as the Grand Marshal of the Grand Council of Allied Masonic Degrees of the United States of America and has advanced to the office of Right Venerable Junior Grand Warden. He has served on the Publications Committee, Program Committee, Red Branch of Eri Committee and Order of the Scarlet Cord Committee of the Grand Council of Allied Masonic Degrees of the United States of America. He has also been honored by being made an Honorary Member of Supreme Ruler's Conclave No. 123 of the Order of the Secret Monitor, or Brotherhood of David and Jonathan in the British Isles and its Districts and Conclaves Overseas.

Right Excellent Sir Knight Shoemaker is also active in the Knight Masons where he served as the Excellent Chief of Charlemagne Council No. 79 in 2014. He has served the Grand Council of Knight Masons of the United States of America as Chairman of the Program Planning Committee, a Member of the Charter Committee (2011-Present), and the Ritual Committee. In recognition of his service to the Grand Council of Knight Masons he was honored as the premier recipient of the Knight Commander of Zerubbabel (No. 0001); he was also awarded the rank and decoration of "Right Excellent Past Grand Senior Knight."

He is an active member of the Commemorative Order of St. Thomas of Acon and was a Founder, Charter Secretary and served as the Worthy Master of Immanuel Chapel No. 56 in 2014. He remains involved in the ritualistic cast alternating between the parts of Worthy Master, and Prior. In February 2019, he was appointed and installed as a Grand Cellarer.

In the York Rite College, he is a Past Governor (2015-2016) of Harry S. Truman College No. 167; additionally, he served the York Rite Sovereign College of North America for several years as a member of the York Rite Progress and Promotion Committee. On August 5, 2017, he received the Order of the Purple Cross and was elevated to the rank of Associate Regent in the York Rite Sovereign College of North America.

In the Masonic Rosicrucian Society in the United States of America (SRICF) he has been honored with the IX° (Magus) grade. He has served the High Council as the Director-General of Ceremonies for many years and is a member of the Committee on Ritual. RW Frater Shoemaker also serves as the Chief Adept of Missouri (appointed in February 2013).

Upon his reception as a Knight Preceptor in the Sovereign Order of Knights Preceptor, he was appointed as Eminent Warden of Regalia for the Sovereign Grand Preceptor's Chapter and he was elected, installed, and served as Preceptor in 2014.

He is a Past Sovereign of St. Augustine Conclave of the Red Cross of Constantine in Topeka, Kansas (2010-2011) and is a dual-member in Mary Conclave in Kansas City, Missouri where he has served as Director of Properties and as a cast member.

Aaron served two terms as the Primus Worshipful Master of the Court of Discovery No. 80 of the Masonic Order of Athelstan in England, Wales and Provinces Overseas. In this role, he was instrumental in establishing the Masonic Order of Athelstan in Missouri. He was honored to assist in consecrating Noble Stone Court No. 104 in Minneapolis, Minnesota and has served in a

pro tem capacity for the Provincial Grand Court on numerous occasions. He served his mother court as the Eminent Prior for several terms after he completed his duties as Primus Master.

Rev. Knight Shoemaker is a member of St. James Lodge of Scottish Masters of St. Andrew No. 2 and the Commandery of St. James, both of which are seated in Mark Masons Hall in London, England, operating under the jurisdiction of the Grand Priory of Knights Beneficent of the Holy City of the Rectified Scottish Rite of England and Wales. In 2010, he received the grade of Knight Beneficent of the Holy City (VI°/CBCS/KBHC).

Additionally, he has been honored with membership in the Royal Order of Scotland (life member), The Operatives (The Worshipful Society of Free Masons, Rough Masons, Wallers, Slaters, Paviors, Plaisterers and Bricklayers), the Holy Royal Arch Knight Templar Priests (HRAKTP / KTP / Order of Holy Wisdom), etc., etc.

ADDRESS OF THE GRAND MASTER

To the Grand Officers, Most Illustrious Past Grand Masters, and Companions All:

Welcome to the One Hundred Fifty-Fourth Annual Assembly of the Grand Council of Cryptic Masons of the State of Missouri. I extend my appreciation to each of you for being here today as we conduct the business of this Grand Council. I hope that you find that it was a productive and enjoyable use of your time.

It has been a privilege for me to serve this Grand Council during the past year. I have enjoyed my term of office immensely and pursuant to Art. II, Section 9, I am pleased to share the following account of my term.

Necrology

Freemasonry offers us an opportunity to make the acquaintance of and develop a friendship with many men who we otherwise would not meet. This expanded network of Companions is perhaps the greatest blessing and benefit of membership in our ancient fraternity. With this in mind, it naturally follows that we must each experience the loss of a friend on a more frequent basis than many in society.

During the 2018 reporting year, our Grand Council has suffered the loss of 107 Companions. I also wish to make special mention of the passing of Most Illustrious Companions Kevin Earl Weaver on February 6, 2019, Honorary Past Grand Master (2018), LeRoy D. Unruh on March 16, 2019, Past Grand Master (2001-2002), and William J. Bowser on May 26, 2019, Past Grand Master (2000-2001). We additionally lost Frederick M. Message

- BROTHERLY LOVE to think of ways to improve social activities in our Councils.
- RELIEF to emphasize the importance of our Cryptic Philanthropies.
- And TRUTH to promote education within the Councils with the goal of improving our membership's understanding of the history and philosophy of the Cryptic Degrees.

The Grand Council's theme for the year was - PRESERVATION!

PRESERVATION is a theme that is unique to the Cryptic degrees in the American York Rite system.

- This begins with the story of the PRESERVATION of the Word in the Council's ritual.
- We should each strive to PRESERVE Masonic history and philosophy through assisting the Missouri Lodge of Research, and by actively preserving local Masonic records.
- And finally, the PRESERVATION of our health through the work of CMMRF. In our jurisdiction, this was reinforced during the month of April which I declared CMMRF Month within our Grand Council. Information was shared with each constituent Council regarding the work of CMMRF and providing instructions on the submission of contributions.

While not a part of my original message, FELLOWSHIP emerged as an additional theme as I traveled. In discussions with Companions during my travel, I often asked them what inspired them to join, what they hoped to find, and what has kept them active. The OVERWHELMING response was friendship and fellowship. While many aspects of our great fraternity are interesting and important, friendship and fellowship are what attracts and retains most of our companions.

Visitations

This annual conference provides York Rite Masons with an opportunity to listen to and converse with York Rite leaders from Arkansas, Kansas, Louisiana, Missouri, Oklahoma, and Texas. The presentations provided those of us who attended with new ideas and fresh insights into the various challenges that the York Rite is facing. These will be incorporated into our 7-year plan which is referenced later in this address. The highlight of the trip was attending the official visit of MIC Reese L. Harrison, Jr. to Blue Bonnet Council No. 409 in San Antonio, TX. I thoroughly enjoyed visiting a Texas Council and meeting new companions. After the meeting, Reese treated MIC Bill Snyder and me to dinner at the Petroleum Club of San Antonio where we enjoyed a delicious shrimp dinner and good conversation. I sincerely appreciated the warm hospitality shown by MIC Harrison and the companions of Blue Bonnet Council No. 409.

During my time in the line, I heard many positive stories about Poplar Bluff Council No. 27. I noted the fact that due to geography; they don't receive many official visits. With that in mind, I was determined to visit them during my term. On January 10, 2019, I was pleased to conduct this visit. I found the Council to be in good shape, with dedicated companions doing their best to preserve Cryptic Masonry in Southeast Missouri. Over the past decade, I have become good friends with their outgoing Grand Master, MIC John Bridegroom. John had an outstanding term as was evidenced by the comments of the many companions in attendance at his session. I am appreciative of the hospitality shown to me during my visit and look forward to visiting the Hoosier State again soon!

Time Capsule

On September 8, 2019, I traveled to Branson, Missouri with VIC Matthew D. Ruth, Grand Steward, in order to inspect the time capsule. The overall state of the site and structure are good. VIC Ruth and I did note that there is a hairline crack near the top of the obelisk. Additionally, the spaces between the various pieces of the structure need to be resealed. I photographically documented these issues. If these issues are not addressed soon, I fear that the frequent freezing and thawing that we experience each year will cause structural damage that will exceed our ability to repair.

Grand Master's Cryptic Day

The fifth annual Grand Master's Cryptic Day was held at the Independence Masonic Temple in Independence, Missouri on March 9, 2019. This event began in an effort to reinforce and strengthen our Grand Council's ties with the Grand Lodge of Missouri, AF&AM. We were honored to host Most Worshipful Brother Robert T. "Tim" Thomas, Grand Master of the Grand Lodge of Ancient, Free and Accepted Masons of the State of Missouri and several Grand Lodge Officers in attendance. 12 Companions (including two from Kansas) were greeted as Royal and Select Masters and they each received a short-form version of the Super Excellent Master degree. I extend my appreciation to Richard Riepe and his Lady Elizabeth D. Aman, Kevin B. Sample, Dan Quesenberry, the many Companions of our host Council, Independence Council No. 49, and especially to the Companions who took part in the degree work. Without your dedication that special day would not have occurred.

Grand Officer Collars and Aprons

At the suggestion of RIC Chris Tilley, Deputy Grand Master, our Grand Council Officers discussed the state of our regalia and the image that they project as we travel throughout the Craft. On March 17, 2019, the Grand Council authorized the purchase of new Grand Officer aprons. It was also recommended that we identify a vendor to repair and re-plate (restore the gold plating) our Grand Officer Collars during the next term.

Membership Records and MMS

I have heard throughout this year how successful of a program this has been for our Grand Council. Our Grand Recorder has commented numerous times how much time this saves our operations. During the conversion to MMS, we discovered many Companions who had fallen off the roles and of others who were listed as active members but had passed away.

IRS Form 990-N

Our Grand Treasurer, MIC Donald Trabue, spent a lot of time working with Councils who were behind with 990 reports. I commend him for his efforts which will be detailed in his report.

State of the Cryptic Rite

During my travels, I have observed great interest in and enthusiasm for Cryptic Masonry. A few Councils are very strong, and many are struggling. I find great encouragement in the fact that in each location that I visited, I found a group of sincere and dedicated Companions working to strengthen Cryptic Masonry. The challenges that we face are not unique to Cryptic Masonry but are found throughout the Craft as a whole. Our future rests in the hands of each of you.

The Advancing Grand Council Line

Our Grand Council is Blessed to have an advancing line of capable and committed Companions. Within our midst, we have professionals with expertise in digital marketing, website development, big data and analytics, business owners, a psychologist, a cattle rancher, and many other areas of experience.

The diversity of our skills and abilities brings us great strength. The Officers have worked together as a team to solve the many challenges faced by our Grand Council.

This year, we held an average of two video conference calls each month.

The first call each month was focused on administration with updates from the Grand Recorder, Grand Treasurer, and our Regional Officers. The goal was to introduce transparency with the issues facing our Grand Council and to keep our Officers informed so that they could offer their ideas and talents.

The second call each month was dedicated to the development of a rolling 7-year plan. This planning process was facilitated by VIC Michael S. Smith who helped us construct the plan

using techniques that he has used in the corporate world. The goal was to create a plan that includes the entire advancing line. The team identifies goals which are broken into measurable tasks, assigned to individuals, and tied to a deliverable date at which point a status is provided.

On May 2, 2019, RIC Christopher E. Tilley was diagnosed with a form of leukemia. The physicians have rapidly developed a treatment plan which Chris began in early May. He is determined to fight and to beat this!

RIC Tilley has been a significant figure in the renewal of Cryptic Masonry throughout our jurisdiction. His dedication to our Grand Council and creative thinking for the future have been noted by all who come in contact with him. Chris has let us know that he will be unable to progress to the office of Grand Master today due to his aggressive treatment plan. He intends to beat leukemia, restore his health, and hopefully be in a place where he could accept nomination in 2020. With that in mind, he has agreed to continue serving as Deputy Grand Master - if nominated and elected.

RIC Wayne B. Fryer is willing to accept nomination to the office of Grand Master and if elected is prepared to serve. Assuming a normal process, all other advancing line officers would then progress as normal.

The Grand Council Advancing line has weathered many challenges over the past several years. There have been several resignations due to health and other issues that have resulted in Companions rapidly advancing through the line. It is our sincere hope that the plan just outlined will be accepted by the Companions and that this will allow our Officers adequate time in the line to gain experience and to plan for their respective term as Grand Master.

Past Recommendations

During my time in the line, I have reviewed the addresses of numerous Past Grand Masters. I found many outstanding ideas, few of which have been acted on. The time seems to move along faster than expected and despite best intentions, many things are simply not completed. With this in mind, I commend the continued study of prior Grand Master Addresses to our advancing line Officers.

Recommendations

I recommend the following items for the consideration and action of this Grand Council.

- Continue wearing distinctive attire & custom ties. This establishes that we are a unique, yet cohesive group within the Masonic family.
- Continue the Production and Sale of the Grand Master Coins with proceeds to benefit CMMRF.
- Continue to acknowledge the work and dedication of our Companions and supporters through the Lewis & Clark Awards, Cryptic Mason of the Year, Lady of the Council, Adult Youth Leadership Award, and other available methods of recognition. While we each SERVE the Craft without expectation of acknowledgment or reward, it is always encouraging to know that it is noticed and appreciated.

- Attempt to schedule official visits and other events during the warmer months of the year. Numerous events had to be postponed or canceled this year due to poor road conditions from snow and ice.
- Expand education regarding CMMRF within our Councils. Share its mission and provide regular updates as to the results of the research within our Councils.
- Rekindle the Super Committee with each Grand Body's Time & Place Committee charged with representing the needs of their respective body to this super committee.
- Continue video conference calls twice per month.
- Encourage Grand Officers to attend visits with the MIGM. Set aside time before or after these visits to break bread with each other and to strengthen the bonds of fellowship.
- Creation of a Grand Recorder's Succession Plan
- Creation of a Grand Treasurer's Succession Plan
- Creation of a Special Committee to study issues discovered with the time capsule, submit an RFP to qualified contractors, and to present bids to the Grand Master along with a recommended course of action.

Fulfilling my responsibilities as Grand Master would not have been possible without the assistance of many individuals.

I am directing the printing of a Grand Master's Certificate of Appreciation for each and I will present these at a convenient time in the near future and share personal comments with each recipient at that time.

REPORTS OF THE GRAND RECORDER

To the Grand Council of Cryptic Masons of the State of Missouri:

Regrettably, this past year was not as productive as I or others would have anticipated or desired. My other profession with the Department of Veterans Affairs has escalated in scope and responsibility, requiring many additional hours dedicated to serving this amazing organization, for which I will not apologize. However, this requirement of my time is not fair to the Grand Council of Missouri, and as such, the amount of time devoted to the Grand Council has suffered. For this, I do apologize. Had it not been for the diligence and dedication of Russell and Debbie Hanson, I could not have done this job. They have worked tirelessly in the background to keep me and the duties of this office afloat, and for that I will be forever grateful. In my opinion, we do make a good team.

Companions, following this narrative you will find the statistical reports of the Grand Recorder's office. Although the same recommendations are made every year, again, it would be of benefit to the grand officers and others to actually review and study these reports as they provide much information as to the overall financial and physical health of the subordinate Councils of the Grand Council of Missouri.

To all grand officers, Masters and Recorders, I highly recommend an occasional perusal of Constitution and By-Laws of this Grand Council. Regarding this section of my report, I refer to Article VI, Chartered Councils, Section 61, 61A, 61B, and 82, to wit,

SEC. 61. Annual Returns. On or before December 31 each year, Council Recorders will submit to the Grand Recorder a complete list of remissions for their Council to include the member's full name and type of remission in accordance with Section 106. Dues, Remission. On or before February 1 each year the Grand Recorder will provide a Masonic Membership Solutions (MMS) statistical report for the previous reporting year along with a bill for the calculated fees due the Grand Council. The bill will include appropriate fees and credits. Fees shall consist of Greeting Fees, Per Capita and any outstanding balances from the previous year's return. Credits shall consist of approved Remissions, Endowed Memberships and General Grand Council Life Memberships as verified by the Grand Recorder, along with any overpayments from the previous year's return. A Financial Report Form and an Annual Audit Committee Report Form (see Section 61B. Annual Audit) will also be included as part of the Annual Return. All forms

shall be forwarded to the Grand Recorder with a copy of the latest IRS Form 990 or a copy of the acceptance of the electronic submission of a Form 990N, no later than the first day of March of each year. Failure to make such return as provided shall subject the Council to a fine of twenty-five dollars (\$25.00) dollars for each period of thirty days, or fraction thereof, said return is withheld. (Amended 5/2/97, 6/7/17, 7/8/18)

- SEC. 61A. Any Council not having its annual return submitted by March 8 (eight) of each year will lose all voting privileges at Grand Council and the Grand Recorder will hold all payments to that Council until the annual return is in and all fees paid for that year. (Added 5/17/01, renumbered 6/9/16)
- SEC. 61B. Annual Audit. There shall be a complete and careful audit of the financial affairs of each subordinate council and of the books, accounts, and vouchers of the Recorder and Treasurer and of others handling, and having in charge, money or property of the council. Such audit shall cover the period from the last previous audit up to and including the thirty-first day of December of each year.

Upon his election, or as soon thereafter as is possible, the Master-elect, shall appoint an auditing committee of three or more members, whose duty it shall be forthwith to audit the books and accounts and vouchers of the Treasurer and Recorder of the council. If the council has trustees, or other custodians of property or funds, then their books, accounts, and vouchers shall also be audited, and the securities or other property checked, inspected, etc. The books, accounts and vouchers of any other officer, member or committee may also be designated by the Master-elect and may be subject to an audit.

The Master-elect, may in lieu of an auditing committee designate any certified public accountant or firm of certified public accountants to make the final audit, provided that the certified public accountant or member of a firm of the same is not related by blood or marriage to the out-going Master, Recorder, or Treasurer.

The report of audit shall be in duplicate, in writing, and be signed by the Auditing Committee or by the C.P.A., or firm of C.P.A.'s who made the audit.

One copy of the report shall be delivered forthwith to the Master-elect, who shall see that the same is presented to and read in open council at the next stated assembly following its date and be spread upon the records thereof; and the other copy shall be transmitted to or filed with the Grand Recorder on or before the first day of March (that being the date for the transmittal to or filing with the Grand Recorder of the annual returns of the council).

All of the actions contemplated herein shall be performed with a view to having the audit completed and the report made prior to the first day of March in each year.

Said report of audit shall be made upon standard printed forms provided by the Grand Recorder, but nothing contained in or omitted from such printed forms shall relieve the auditing committee or C.P.A., or firm of C.P.A.'s from reporting fully and completely their findings in the premises. (Added 7/8/18)

SEC. 82. The Master. The Master has it in special charge to see that the By-Laws of his Council are duly observed, as well as statutes, rules and regulations of the Grand Council; that accurate records are made, and just accounts rendered; that regular returns are promptly made to the Grand Council, and that the annual dues are promptly paid. It

is his duty to preside at all Assemblies of his Council, and he is responsible for the proper conduct of its affairs. It is his duty, either in person or by proxy, to attend all Assemblies of the Grand Council, and to see that the Recorder of his Council promptly discharges his duty in reference to Council returns, and dues. And he shall have authority to remove any officer of his Council, whose actions are such as to disturb the Craft or to interfere with its proper procedures, customs, and requirements.

Annual Returns – **Late:** As of the time of this report, the following Councils filed late returns and were assessed penalties: Hiram Council No. 1; Shekinah Council No. 24; Zabud Council No. 25; Jasper Council No. 30; Westport Council No. 38; Rolla Council No. 39; John F. Houston Council No. 42; Bonne Terre Council No. 43; Kansas City Council No. 45; Neosho Council No. 46; Jeremiah Council No. 48; Independence Council no. 49; and Lebanon Council No. 56;

Annual Returns – No Return: As of the date of this report, the following Councils have not filed a return and will be assessed penalties: Fidelity Council No. 35; and East Gate Council No. 51. I refer these to the Grand Officers to address.

Annual Returns – Financial Statements: The following Councils either failed to submit or filed an incomplete Financial Statement: Shekinah Council No. 24; Trenton Council No. 37 (new Recorder); Westport Council No. 38; Lebanon Council No. 56; Bert S. Lee Council No. 58; Shelby Council No. 59; and West Plains Council No. 64. I refer these to the Grand Officers to address.

Annual Returns – CMMR and CEF Donations (according to the annual returns): The following Councils reported no contributions to CMMR or CEF: Hiram Council No. 1; St. Joseph Council No. 9; Cape Council No. 20; Shekinah Council No. 24; Zabud Council No. 25; Jasper Council No. 30; Ezra Council No. 32; Trenton Council No. 37; York Council No. 40; John F. Houston Council No. 42; Bonne Terre Council No. 43; Kansas City Council No. 45; Neosho Council No. 46; Trinity Council No. 47; Jeremiah Council No. 48; Liberty Council No. 50; Harmony Council No. 53; and West Plains Council No. 64.

In contrast, for CMMR, Rolla Council No. 39 was able to contribute \$3.55 per member for each of their members; Shelby Council No. 59 was able to contribute \$4.63 per member; Lebanon Council No. 56 was able to contribute \$5.16 per member; and for the second year in a row, Independence Council No. 49 had the largest contribution of \$8.55 per member and had the largest total contribution from all the Councils.

For the Grand Council Charity Endowment Fund (CEF), only 5 Councils reported contributions: Carthage Council No. 41 was able to contribute \$0.29 per member; Poplar Bluff Council No. 27 was able to contribute \$1.00 per member; Centralia Council No. 34 was able to contribute \$1.34 per member; Rolla Council No. 39 contributed \$1.72 per member; and Hiram Council No. 1 had the largest contribution of \$1.92 per member. The largest total contribution was from Centralia Council No. 34.

One item of importance to mention – CMMR and CEF donations according to Annual Return Financial Reports show total contributions of \$2,235.31 and \$469.22 respectively, however total contributions received in 2018 through our office were actually \$3,552.08 and \$433.9 respectfully. Recorders need to try to report accurately. *The awards given this year for charitable contributions are based on annual return reporting.*

Annual Returns – Bonding: The following Councils reported that the Treasurer and Recorder are NOT bonded: Hiram Council No. 1; Cape Council No. 20; Poplar Bluff Council No. 27; Jasper Council No. 30; Ezra Council No. 32; Centralia Council No. 34; Trenton Council No. 37; Westport Council No. 38; Rolla Council No. 39; York Council No. 40; Carthage Council No. 41; John F. Houston Council No. 42; Bonne Terre Council No. 43; Kirksville Council No. 44; Kansas City Council No. 45; Neosho Council No. 46; Trinity Council No. 47; Jeremiah Council No. 48; Harmony Council No. 53; Lebanon Council No. 56; Bert S. Lee Council No. 58; Shelby Council No. 59; and West Plains Council No. 64. Although there is no requirement by law that bonds be established, there is a necessity of ensuring the organizational officers who are responsible for your financial health are bonded.

Annual Returns – Audits: The following Councils did not file an Audit as part of their Annual Return or if they did file an Audit, it was incomplete: St. Joseph Council No. 9 – did not check all the boxes; Shekinah Council No. 24 – did not check all the boxes; Jasper Council No. 30 – did not check all the boxes; Trenton Council No. 37; Trinity Council No. 47 – not signed by audit committee; Jeremiah Council No. 48 – not signed by audit committee or officers; and Harmony Council No. 53 – not signed by audit committee.

Annual Returns – Dues: The following Councils reported dues charged each member to be less than that required by Grand Council (\$37.60), to wit:

SEC. 105. Dues, Minimum. Council dues shall not be less than \$10.00 plus Grand Council per capita and fees in addition to per capita of the General Grand Council, per annum, payable in advance on the first day of January. (Amended 5/2/97, 7/8/18)
St. Joseph Council No. 9 (\$30.00); Poplar Bluff Council No. 27 (\$37.00); Jasper Council No. 30 (\$32.00); Trenton Council No. 37 (\$30.00); and Harmony Council No. 53 (\$37.00).

Annual Returns – 990 Status: I defer the reporting of 990 status to the Grand Treasurer.

Annual Returns – Council Indebtedness: The following Councils reported a negative cash on hand as of December 31, 2018: John F. Houston Council No. 42. I refer these to the Grand Officers to address.

Annual Returns – Summary: Repeating from last year (nothing has changed), I would direct the Grand Officers' (as well as appropriate committees') attention to the several items in the statistical reports – Councils who report no Cash on Hand; no Paraphernalia value; Councils who show an indebtedness; and Councils whose dues are extremely low or even less than Grand Council per capita. Several Councils failed to record the amount of their annual dues. RDGM's should take notice of those Councils who failed to record any CMMR or CEF donations and provide education. It would appear that Recorders have forgotten (or were unaware) of the Penny-a-Day stickers our office provides for these charity donations. Finally, I would refer to the Grand Master and appropriate committees the list of Treasurers and Recorders who are not bonded, and whose Councils failed to submit an annual audit. We must start reviewing and addressing these statistical reports and what appears to be failures on the part of the Councils, although we are sure most of these items could be remediated through training and education for the officers by the appropriate Grand Councils officers.

Marion Council No. 3: I would encourage the Grand Council Officers to review the formation of this council and complete the process or repeal the law.

Greetings: We are pleased to report that there were 84 Greetings during the 2018 reporting year. Grand Council Growth Awards will be presented to John F. Houston Council No. 42 (10%); Bert S. Lee Council No. 58 (10%), and the most going to West Plains Council No. 64 with 12 (286%).

MMS: We are finally pleased to report that all our Councils are fully engaged and using MMS, either by the Council Recorder or the IT Representative designated for that purpose. Our office believes this to be one of the most significant positive changes to the Grand Council of Missouri in many years. We thank you for all your hard work.

Search for new Grand Recorder: It is anticipated that unless something drastic happens, I will be leaving this office in June 2021. Interested applicants should submit their resumes to directly to me (not the MGYR office). Applicants will be screened by the grand officers and the MGYR office staff to determine applicable skillset and capability to perform the job. Once selected, we will work with and train the designee(s), delegating some tasks, so they are fully qualified to perform the functions of this office, should they be elected by this body. It is my intention, after I retire in about 6 years, to fully invest the time needed to do all the things that remain unfinished and hopefully to work with and support whomever you select as my replacement.
