BIOGRAPHY OF THE GRAND HIGH PRIEST

Most Excellent Companion David Lee Leirer was born on July 26, 1948 in Sikeston, Missouri to Leon Leirer and Betty (Edwards) Leirer. He has two Sisters, Suzanne Null and Melisa Jane Herrington. MEC William Everett Brenneman was our Grand High Priest in 1995-1996. Bill was a good friend and mentor to me in both the York Rite and in the Blue Lodge. He was active and still doing great ritual until the time of his passing.

MEC William Bridgewood Stevenson, Jr. presided over this Grand Chapter in 2006-2007. He served Freemasonry so faithfully in the St. Louis area for so many years.

Edicts Issued

Edict No. 1

March 24, 2020

Whereas the Constitution and By-Laws of the Grand Chapter of the Royal Arch Masons of the State of Missouri, Article XXII, Chartered Chapters, Section 73. Stated Convocations. A., requires stated convocations shall be at least once a month, and further,

Whereas Section 76. To Meet Temporarily, anticipates the possibility of situations where it is impossible for a Chapter to hold a convocation at its regular place of meeting by various good and sufficient reasons for the Grand High Priest to grant a dispensation to do so, and,

Whereas a highly contagious and potentially deadly coronavirus is spreading throughout the world; and,

Whereas cases of and deaths due to the virus have been confirmed within the jurisdiction of this and neighboring Grand Jurisdictions,

Now, Therefore, under the authority of Article II, Powers and Duties of the Grand High Priest, Section 17. Official Decisions, I hereby issue the following Edict, effective immediately:

A. All Chapters subordinate to this Grand Chapter shall cancel or postpone all stated or special convocations and or meeting/events of said Chapter until further notice. The purpose of said cancelation or postponement is to prevent or limit the exposure of officers and members of the subordinate Chapter to coronavirus or some other such infectious or contagious disease of a similar nature.

B. This Edict will remain in place unless cancelled or amended by further Order of the Grand High Priest or until the term of office of the office of the Grand High Priest shall be concluded.

C. This Edict shall serve as the Official Dispensation for all cancelled or postponed convocations during the period of this Edict.

Amendment to Edict No. 1

May 2, 2020

A. Effective Monday, May 4, 2020, the restrictions previously imposed on the Grand Chapter and the Subordinate Chapters by canceling or postponing all stated or special convocations and or meetings/events of said Chapter are herein partially lifted with the following restrictions remaining in force:

B. All meetings held shall be conducted in a manner which complies with all laws, regulations, requirements and guidelines of the State of Missouri and any city, county or other political subdivision in which the Chapter meeting facility is located. Further, all meetings shall adhere to all social distancing and public gathering size limitations/restrictions as defined by the above agencies. In addition, all meetings so held shall be conducted in a manner which complies with all recommendations of the United States Centers for Disease Control with respect to face coverings, hand sanitation and disease mitigation protocols.

C. Chapters may not confer any degrees or orders. Chapters may conduct ceremonies, education or other business only in a manner which complies with the above requirements.

D. Further information about State of Missouri and any city, county or other political subdivision restrictions may be found at the following web site: <https://health.mo.gov/living/healthcondiseases/communicable/novel-coronavirus/results.php>

E. This Amended Edict No. 1 will remain in place unless cancelled or amended by further Order of the Grand High Priest or until the term of office of the office of the Grand High Priest shall be concluded.

Edict No. 2

May 4, 2020

Whereas ARTICLE V of the Constitution, Annual Convocation, Section 1. states This Grand Chapter shall hold an annual convocation every year at such time and place as shall be provided in the By-Laws, provided that, in the event of a war emergency making it difficult or impossible to hold such stated annual convocation, two of the first three principal officers of this Grand Chapter, at least thirty days prior to any scheduled convocation, according to the By-Laws of this Grand Chapter, may postpone such scheduled convocation not more than one year, and

Whereas ARTICLE VI of the Constitution, Officers, Section 1. A. states the elective officers of this Grand Chapter shall be elected by ballot, and by a majority of the votes cast for that purpose, at each annual convocation, and

Whereas ARTICLE I of the By-Laws, Convocations of the Grand Chapter, Section 2. Special Convocations states Special convocations of the Grand Chapter may be held at such times and at such places as the Grand High Priest may designate, due notice thereof having been given to each chapter, and to each officer and past grand officer of the Grand Chapter, but no business shall be transacted except that for which it shall have been specially convened, and

Whereas ARTICLE I of the By-Laws, Convocations of the Grand Chapter, Section 3. Change of Place of Meeting states In case of an emergency, epidemic or other occasion or circumstance making it advisable or expedient, the Grand High Priest, with the written consent of the Grand King and the Grand Scribe or either one of such officers, may change the place or time of holding the next annual convocation of this Grand Chapter, and

Whereas the Grand Chapter Officers feel that it is in the best interest of our membership to take seriously the current health environment and the potential infectious and contagious risk to our membership, and

Whereas the Grand High Priest and the Grand Scribe have provided written consent to postpone the 2020 Annual Grand Convocation of the Grand Chapter of Royal Arch Masons of the State of Missouri until June 9, 2021, and

Whereas the Grand Chapter has official business which must be conducted before June 9, 2021,

Now, Therefore, under the authority of Article III, Powers and Duties of the Grand High Priest, Section 13.A. General Duties and Section 17. Official Decisions, I hereby issue the following Edict, effective immediately:

A. The 2020 Annual Grand Convocation of the Grand Chapter of Royal Arch Masons of the State of Missouri will be postponed until June 9, 2021, and

B. There will be a virtual Special Convocation of the Grand Chapter of Royal Arch Masons of the State of Missouri to be held on Saturday, June 13, 2020 at 8:00 a.m. via WebEx and private YouTube attendance, and the business of the virtual Special Convocation will consist of:

a. Receiving and acting upon the proposed 2020-2021 Grand Chapter fiscal year budget, and

b. Receiving and acting upon legislative proposals received by the Committee on Jurisprudence for the previously scheduled Annual Grand Convocation, and

c. The election of all the officers below the office of Grand High Priest to fill the vacancy created by the passing of the Grand King, and

d. The declared Installation of said officers by the Grand High Priest

Information will be forthcoming about how to register (credentials) and how to attend the virtual Special Convocation.

Further Amendment to Edict No. 1

September 28, 2020

Whereas the highly contagious and potentially deadly coronavirus is continuing to spread throughout the world, resulting in more cases and more deaths within the jurisdiction of this and neighboring Grand Jurisdictions,

Now, Therefore, Edict No. 1 is further amended as follows:

F. The continued safety of all members of Subordinate Chapters under the jurisdiction of the Grand Chapter being of the utmost importance and concern, all Subordinate Chapters will have the option of conducting all Convocations and other ceremonies virtually. If any assistance is needed by Subordinate Chapters in setting up virtual Convocations or other ceremonies, please contact the Grand Secretary of the Grand Chapter for assistance.

G. In determining compliance with the requirements of the Grand Chapter, all awards presentations by the Grand Chapter, all Convocations and other ceremonies held virtually, will be considered the same as in-person meetings.

H. This further Amendment to Edict No. 1 will serve as the official dispensation for all Subordinate Chapters to hold Convocations and other ceremonies virtually, in place of in-person Convocations and ceremonies held in a designated facility, for the duration of Edict No. 1 and the amendments to Edict No. 1.

I. This further Amendment of Edict No. 1 and the previous Amendment dated May 2, 2020 (herein contained) will remain in place unless cancelled or further amended by Order of the Grand High Priest or until the term of office of the office of the Grand High Priest shall be concluded.

Edict No. 3

March 15, 2021

Whereas The infection levels in the State of Missouri have started to decline to levels that many health professionals consider to decrease risk of infection in an environment that is using accepted safety guidelines and using safe protocols,

Whereas While resuming activities, one must keep in mind that the situation is still unknown and volatile, and could worsen at any time,

Whereas The members of the Masonic Fraternity have been limiting their risks of exposure for over a year, and are anxious about resuming activities in their Chapters,

Now, Therefore, under the authority of Article III, Powers and Duties of the Grand High Priest, Section 17. Official Decisions, I hereby issue the following Edict, effective April 1, 2021: The following EDICTS and Amendments are rescinded as of April 1, 2021:

Edict No. 1, dated March 24, 2020

Amendment to Edict No. 1, dated May 2, 2020

Further Amendment to Edict No. 1, dated September 28, 2020

Effective April 1, 2021, Chapters may now confer all the Capitular Degrees under the following conditions:

A. The Chapter MUST comply with all Federal, State, County, and Municipal/City laws, directives, ordinances, and mandates. This includes any restrictions on meeting attendance size, meeting length, meeting location, or any other particulars that may be specified for gathering by any of these governmental entities including the wearing of masks and safely social distancing from each other.

a. The candidate and those participating in the degree must be aware of the possible risk of exposure to COVID-19 during the conferral of the degree and consent to participate, and the conferral of the degree implicitly acknowledges consent by all parties. No coercion is to be used on the candidate to appear or for participation in conferring a degree. If the candidate or any Companion is concerned about exposure, the degree is to be rescheduled and no ill will is to be demonstrated towards any candidate or Companion that declines to participate.

b. A personal copy of a Volume of Sacred Law must be given to the candidate by the Chapter to use for his degree work, or a candidate may provide his own Volume of Sacred Law. Under no condition can a Volume of Sacred Law be used by more than one candidate.

c. If there is a resurgence of the virus, stricter conditions could be enacted or a "Suspend Work" order could be issued, which will have the same authority as an Edict, and Chapters will suspend degree work immediately.

d. Failure to follow any of the aforementioned conditions for degree conferral will be considered a direct violation of the orders of the Grand High Priest and may subject the Chapter to disciplinary action, up to and including arrest of the Chapter charter.

e. Further information about State of Missouri and any city, county or other political subdivision restrictions may be found at the following web site: <https://showmestrong.mo.gov/data/public-health/>

B. Chapter High Priests, if they feel there is still a risk of infection to the members of the Chapter and/or to comply with any federal, state, county, and/or local municipality restrictions that could affect the ability of Chapters to meet, shall have the ability to:

- a. Reschedule Chapter Convocations,
- b. Cancel Chapter Convocations, or
- c. To hold virtual Convocations in place of in-person Convocations.
 - i. If meeting virtually, no ritual may be performed.

ii. In determining compliance with the requirements of the Grand Chapter, all awards presentations by the Grand Chapter, all Convocations and other ceremonies held virtually, will be considered the same as in-person meetings.

d. This Edict shall serve as the Official Dispensation for all cancelled, postponed, or virtual Convocations during the period of this Edict.

This Edict No. 3 will remain in place unless cancelled or amended by further Order of the Grand High Priest or until the term of office of the office of the Grand High Priest shall be concluded.

Charters Arrested

July 2, 2020 Arrested Charter of Mountain Grove Chapter No. 137 and authorized Companion Gregory J. Walker to take possession of the Charter and Seal on behalf of the Grand Chapter. Ordered Grand Secretary to send notice to each member and if any member wishes to remain a member, to issue a Statement of Good Standing and facilitate their Affiliation with the Chapter of their choosing.

Decisions

August 10, 2019 A request for dispensation was received from Joplin Chapter No. 91, Jasper Council No. 30, and Ascension Commandery No. 39 to hold a special meeting for their election of officers since their June meeting conflicted with the Grand York Rite Special meetings.

The request was not granted for two reasons: 1) the request should have been three separate requests for three separate organizations, and 2) the request was for either August of September.

Requests for dispensations may not be co-mingled with other organizational requests, and the request must be very specific in nature, defining the issue, the proposed solution, and the very specific date, time of the original date/time and of the newly proposed date/time, and the very specific locations involved if there are location changes.

October 28, 2019 Approved the Consolidation of West Plains Chapter No. 108 with Springfield Chapter No. 15.

November 13, 2019 Approved the Consolidation of East Gate Chapter No. 136 with Orient Chapter No. 102.

August 23, 2020 Authorized Subordinate Chapters to hold Virtual meetings to conduct business, elect and install officers, but they may not perform any ritual.

August 27, 2020 Regarding the Arrest of the Charter of Mountain Grove Chapter No. 137, the Grand Secretary notified each member of the Chapter in writing to determine their membership desires. Companion Baltz expressed his desire to move his membership to Tyrian Chapter No. 52. Companion Baltz is already an Affiliated member of Tyrian Chapter No. 52. Therefore, Companion Baltz is herein granted a Dimit from Mountain Grove Chapter No. 137, dated July 2, 2020. Further, Companion Baltz's Endowed Membership in Mountain Grove Chapter No. 137 is hereby transferred to Tyrian Chapter No. 52.

August 27, 2020 Regarding the Arrest of the Charter of Mountain Grove Chapter No. 137, the Grand Secretary notified each member of the Chapter in writing to determine their membership desires. Companion Phares expressed his desire to move his membership to Springfield

Chapter No. 15. Therefore, Companion Phares is herein granted a Dimit from Mountain Grove Chapter No. 137, dated July 2, 2020. Further, Companion Phares' membership is hereby officially moved to Springfield Chapter No. 15 by Affiliation, dated July 2, 2020. Springfield Chapter No. 15 will have the responsibility of collecting 2020 dues from Companion Phares.

March 17, 2021

Request presented for a Subordinate Chapter to do Courtesy Work for a PHA Chapter. I approved the following language to be communicated to the Chapter: Courtesy Work for another Grand Jurisdiction: The requesting Chapter (PHA) would need to request courtesy work through their Grand Secretary to our Grand Secretary. The request would include a copy of the petition identifying the Brothers full name, acknowledgement that he had been elected to receive the degrees in his Chapter. If their Grand Secretary does not agree, it stops there. If their Grand Secretary permits us to do the work, they will forward that request to our Grand Secretary and he would forward that request to the Chapter being requested to do the work.

Following the conferral of the degrees, the Chapter conferring the work would report back to our Grand Secretary and he to their Grand Secretary so the conferral can be recorded in their records. This conferral of other jurisdiction candidates would NOT be recorded in MMS but would be recorded in the minutes of the Chapter.

March 24, 2021

Request from Lexington Chapter No. 10: Lexington York Rite has been approached by two Brothers in Sedalia. They recently received two Royal Arch degrees at Wyoming Chapter. They have decided they would prefer to be in a York Rite group with all three bodies and have approached Lexington York Rite, hence, the contact with us. At this stage of the process what is the procedure for them to move from Wyoming to Lexington?

Response: Should Wyoming be amenable to requesting that Lexington confer the remaining degrees under Art. XX, section 177, then they could confer the degrees. However, once the Companion received the degrees, he could then request affiliation pursuant to Art. XVI, section 152, then request a dimit. Once granted, he could then proceed with receiving further degrees in the new jurisdiction.

Dispensations Granted

August 30, 2019

Granted dispensation to Oriental-Rabboni Chapter No. 78 to move their regular stated meeting on September 2, 2019 to September 9, 2019 due to the Labor Day holiday being on September 2, 2019.

September 6, 2019

Granted dispensation to Lexington Chapter No. 10 to move their regular stated meeting on September 23, 2019 to September 9, 2019 due to the Grand Lodge Grand Session on September 23, 2019.

December 7, 2019

Granted dispensation to Mt. Nebo Chapter No. 148 to remove from its regular stated meeting place and time on December 11, 2019 to the St. Charles Masonic Temple at 6:00 p.m. on December 11, 2019, to participate in the Region 5 Holiday Celebration with the other York Rite bodies in the immediate area.

January 27, 2020

Granted dispensation to Palmyra Chapter No. 2 to remove from its domicile to the domicile of Jefferson City Chapter No. 34 located at 3211 Masonic Court in Jefferson City, MO for the purpose of opening the Grand Master's Royal Arch Class on Saturday, March 7, 2020.

This dispensation additionally permits Palmyra Chapter No. 2 to change its meeting date to March 7, 2020 for this event only but does not preclude their requirement to meet during the Annual Session of the Grand Chapter of Royal Arch Masons of the State of Missouri. Finally, this dispensation permits the opening time to be determined by the Grand Lecturer and the Grand High Priest based on scheduling needs.

- February 28, 2021 Granted dispensation to Springfield Chapter No. 15 for Temporary Removal from their home at the Masonic York Rite Temple, 1930 W. Catalpa, Springfield, MO to Gate of the Temple Lodge, 1700 N. Booneville, Springfield, MO due to the sale of their building.
- May 18, 2021 Granted dispensation to Orient Chapter No. 102 to move it's May 19, 2021 Stated Convocation to 8640 Holmes Road for the purpose of holding a Joint Convocation with Kansas City Chapter No. 28 for the conferral of the Most Excellent and Royal Arch Mason Degrees.

By Law Changes, Subordinate Chapters

- March 2, 2020 Approved By-Laws change for Tyrian Chapter No. 52, changing their meeting date to the third Tuesday of each month, changing the fee for the degrees to \$56.00, and changing the annual dues to be Ten Dollars (\$10.00) plus Grand Chapter per capita tax, fees and assessments,
- December 20, 2020 Approved By-Laws change for Independence Chapter No. 12 lowering their Annual Dues from \$40.00 to \$25.00.
- March 8, 2021 Approved By-Laws change for Harry D. Brown Chapter No. 284 as to a change of location to the Masonic Lodge located at 2409 SW M 291 Highway, Lee's Summit, MO and their meeting date and time to the first Monday of each month except in July and August. These proposed changes were presented to the Grand Secretary in 2019 but due to several communication issues, they were not formally approved until the above date.
- March 10, 2021 Approved complete By-Laws Revision for Triune Chapter No. 93 with the following corrections, change "demits" to "dimits" throughout the document, and in Article VIII, Section A, change "adapted" to "adopted".

Grand High Priest Coins

In keeping with MEC Loren Lloyd's original intent when starting the coin program, I have designated that all proceeds raised from coin sales this year be deposited in the Grand Chapter's Masonic Youth Fund.

Due to the Global Pandemic, York Rite Masonry in the State of Missouri has been at a virtual standstill for the past year. With the new guidelines as set forth by the Center for Disease Control, the Grand Chapter has been able to pick up where we left off and will continue to move forward. We have been able to move from a virtual Grand Session last year to a modified in person session this year, while some things are different, the outcomes are the same – Companions and Sir Knights coming together in brotherhood to continue their work for the betterment of man.


It is my hope that Royal Arch Masonry in the State of Missouri will continue to grow and move forward to make all men greater, not only for themselves but also in the eyes of God.

REPORTS OF THE GRAND SECRETARY

To the Grand Chapter of Royal Arch Masons of the State of Missouri:

Companions, this was intended to be my final report as your Grand Secretary. The business partnership agreement with the Grand York Rite and presiding officers when I was requested to come back in 2014 was that I would work with REC Hanson and Lady Debbie until their retirement this year. As of this moment in time, there has been no viable expressed interest by any Companion willing to step up and assume this awesome responsibility this year. There is one Companion in whom I have much confidence who has indicated that he might be a willing candidate in one more year. For this reason, if re-elected, I will serve one final term, but this is it.

This does not mean that I am going to fade away into my sunset years. Russell and I are willing to serve in background administrative support of the new Grand Secretary when that time comes. What I have learned over the years is that in order to do this job well, it takes much more time and commitment than I have to give. I still have a full-time job for the Department of Veterans Affairs as an Enterprise Division Chief for Data Transport Services with an ever-increasing demand of my time and attention. Moving forward, if acceptable to our officers and membership, our hope is that five (counting Debbie) can do more and better work than three. There is much to be done that remains incomplete: historical records, research projects, proceedings, grand representatives, membership cleanup, archival projects, process improvements, electronic and internet advancements, etc., that Russell and I can and are willing to work on in the background, while helping tutor and support our replacements should they desire such support. We feel this will help facilitate a much smoother transition than those experienced in past years.

There are no words to adequately express my appreciation to Russell and Debbie, they have stood me up where I have been deficient and I could not and would not be capable of performing the duties and responsibilities of Grand Secretary without each of them, they are priceless.

One serious concern I have is that there is no official process for vetting new candidates for Grand Secretary and Grand Treasurer; the process we had, albeit flawed, was removed from our laws in 2014. Now there is nothing. I feel this was a grievous error on our part and should be corrected.

There are many who say they want the job, but few that can actually perform. The office of Grand Secretary (and even more so the Clerical Assistant) is much more than an elected office of the Grand Chapter, this position is a salaried employee (although the salary wouldn't feed a gnat). Unless one is retired and doesn't need the money, the salary provided to both positions is prohibitive of supporting skilled professionals capable of providing the services required of the positions.

Companions, following this narrative you will find the statistical reports of the Grand Secretary's office. Although the same recommendations are made every year, again, it would be of great benefit to the grand officers and committees to actually review and study these reports as they provide much institutional information as to the overall financial and physical health of the subordinate Chapters of the Grand Chapter of Missouri.

To all grand officers, High Priests and Secretaries, I highly recommend an occasional perusal of the Constitution and By-Laws of this Grand Chapter. I respectfully refer you to the 2019 reports of the Grand Secretary for more information on continued operational deficiencies.

The following are the reports for the last two Capitular years.

2019 Annual Returns – Late: As of the time of this report, the following Chapters filed late returns and were assessed penalties: Rolla Chapter No. 32; Greenfield Chapter No. 38; Oriental-Rabboni Chapter No. 78; Bethany Chapter No. 80; Vincil Chapter No. 110; Mt. Nebo Chapter No. 148; and Harry D. Brown Jr. Chapter No. 284.

2020 Annual Returns – Late: As of the time of this report, the following Chapters filed late returns and were assessed penalties: Palmyra Chapter No. 2; Hannibal Chapter No. 7; Bellefontaine Chapter No. 25; Lebanon Chapter No. 64; Shelbina Chapter No. 99; Mt. Nebo Chapter No. 148; and Harry D. Brown Jr. Chapter No. 284.

2019 Annual Returns – No Return: As of the date of this report, the following Chapters have not filed a return, have forfeited all rights and privileges to representation and voting at the Annual Convocation, and will be assessed penalties: Mountain Grove Chapter No. 137. I refer these to the Grand Officers to address.

2020 Annual Returns – No Return: As of the date of this report, the following Chapters have not filed a return, have forfeited all rights and privileges to representation and voting at the Annual Convocation, and will be assessed penalties: Greenfield Chapter No. 38 and Vincil Chapter No. 110. I refer these to the Grand Officers to address.

2019 Annual Returns – Not Received thirty days prior to Annual Convocation: there was no 2020 Annual Convocation.

2020 Annual Returns – Not Received thirty days prior to Annual Convocation: As of the date of this report, the following Chapter filed an annual return, but not later than thirty (30) days prior to the Annual Convocation, has forfeited all rights and privileges to representation and voting at the Annual Convocation, and will be assessed penalties: None.

2019 Annual Returns – Financial Statements: The following Chapters either failed to submit or filed an incomplete Financial Statement, and in one case was completely unintelligible: West Plains Chapter N. 108; East Gate Chapter No. 136; and Harry D. Brown Chapter No. 284. I refer these to the Grand Officers to address.

2020 Annual Returns – Financial Statements: The following Chapters either failed to submit or filed an incomplete Financial Statement, and in one case was completely unintelligible: Greenfield Chapter No. 38; Trenton Chapter No. 66; Bethany Chapter No. 80; Vincil Chapter No. 110; and Harry D. Brown Chapter No. 284. I refer these to the Grand Officers to address.

2019 Annual Returns – RARA Donations (according to the annual returns): The following Chapters reported no contributions to RARA: Bolivar Chapter No. 5; Hannibal Chapter No. 7; Macon Chapter No. 22; Kansas City Chapter No. 28; Wyoming Chapter No. 43; Trenton Chapter No. 66; Bethany Chapter No. 80; Joplin Chapter No. 91; Shelbina Chapter No. 99; Orient Chapter No. 102; West Plains Chapter No. 108; East Gate Chapter No. 136; and Mt. Nebo Chapter No. 148.

The above Chapters are not adhering to the Grand Chapter By-Laws, Article IX, Revenues of the Grand Chapter, Section 40. Annual Dues, Paragraph B, or they are receiving donations and not forwarding them to the Grand Chapter, or they are forwarding them to the Grand Chapter but not keeping accurate financial records of income and disbursements as detailed in the Annual Financial Reports included with the Annual Return, all of which I refer to the Grand Officers to address.

In contrast, St. Charles Chapter No. 1 was able to contribute \$4.58 per member for each of their members; Independence Chapter No. 12 contributed \$7.25 per member; Greenfield Chapter No. 38 contributed \$3.33 per member; Triune Chapter No. 93 once again had the largest contribution of \$12.51 per member for each of their members and had the largest total contribution from all the Chapters; and Poplar Bluff Chapter No. 114 hit the mark with \$3.65 per member.

2020 Annual Returns – RARA Donations (according to the annual returns): The following Chapters reported no contributions to RARA: Bolivar Chapter No. 5; Hannibal Chapter No. 7; Lexington Chapter No. 10; Independence Chapter No. 12; Mitchell Chapter No. 14; Macon Chapter No. 22; Wyoming Chapter No. 43; Meridian Sun Chapter No. 61; Lebanon Chapter No. 64; Trenton Chapter No. 66; Bethany Chapter No. 80; Joplin Chapter No. 91; Triune Chapter No. 93; Shelbina Chapter No. 99; Orient Chapter No. 102; Uel Chapter No. 129; Mt. Nebo Chapter No. 148; and Harry D. Brown Jr. Chapter No. 284.

The above Chapters are not adhering to the Grand Chapter By-Laws, Article IX, Revenues of the Grand Chapter, Section 40. Annual Dues, Paragraph B, or they are receiving donations and not forwarding them to the Grand Chapter, or they are forwarding them to the Grand Chapter but not keeping accurate financial records of income and disbursements as detailed in the Annual Financial Report included with the Annual Return, all of which I refer to the Grand Officers to address.

This was a bad year for collections due to the pandemic. No Chapter hit the mark of \$3.65 per member. The closest was Liberty Chapter No. 3 with \$2.08 per member and Putnam Chapter No. 123 with the best return of \$2.35 per member.

One item of importance to mention – 2019 RARA donations according to Annual Return Financial Reports show total contributions for the reporting year of \$2,647.44. However total contributions received through our office in the 2019 fiscal year were actually \$1,868.79. 2020 RARA donations according to Annual Return Financial Reports show total contributions for the reporting year of \$882.68. However total contributions received through our office in the 2020-2021 fiscal year were actually \$2,131.82. Secretaries need to try to report more accurately.

2020 Annual Returns – Bonding: The following Chapters reported that the Treasurer and Secretary are NOT bonded: Hannibal Chapter No. 7; Lexington Chapter No. 10; Columbia Chapter No. 17; Macon Chapter No. 22; Bellefontaine Chapter No. 25; Rolla Chapter No. 32; Jefferson City Chapter No. 34; Greenfield Chapter No. 38; Wyoming Chapter No. 43; Tyrian Chapter No. 52; Caldwell Chapter No. 53; Nevada Chapter No. 56; Meridian Sun Chapter No. 61; Lebanon Chapter No. 64; Trenton Chapter No. 66; Wilson Chapter No. 75; Oriental-Rabboni Chapter No. 78; Bethany Chapter No. 80; Joplin Chapter No. 91; Triune Chapter No. 93; Shelbina Chapter No. 99; Orient Chapter No. 102; Vincil Chapter No. 110; Poplar Bluff Chapter No. 114; Putnam Chapter No. 123; Uel Chapter No. 129; Keystone Chapter No. 146; Mt. Nebo Chapter No. 148, and Harry D. Brown Jr. Chapter No. 284. Although there is no requirement by law that bonds be established, there is a necessity of ensuring the organizational officers who are responsible for your financial health are bonded.

2019 Annual Returns – Audits: The following Chapters did not file an Audit as part of their Annual Return or if they did file an Audit, it was incomplete: Greenfield Chapter No. 38 – missing committee signatures, missing High Priest signatures; Meridian Sun Chapter No. 31 – missing High Priest signature; Trenton Chapter No. 66 – no audit; Wyoming Chapter No. 43 – filed an audit but did not report on the form provided by the Grand Secretary's office, missing High Priest signature; Wilson Chapter No. 75 – did not check any of the boxes; Triune Chapter No. 93 – did not check all the boxes; Vincil Chapter No. 110 – missing committee signatures, missing High Priest signature; Mt. Nebo Chapter No. 148 – did not check all boxes, missing committee signatures; Harry D. Brown, Jr. Chapter No. 284 – completed, not dated. I refer these to the Grand Officers to address.

2020 Annual Returns – Audits: The following Chapters did not file an Audit as part of their Annual Return or if they did file an Audit, it was incomplete: Lexington Chapter No. 10 – did not check all the boxes; Bellefontaine Chapter No. 25 – not all boxes checked; Greenfield Chapter No. 38 – no audit; Trenton Chapter No. 66 – no audit; Joplin Chapter No. 91 – not all boxes checked; Orient Chapter No. 102 – printed committee members, no committee signatures; Vincil Chapter No. 110 – no audit; Harry D. Brown, Jr. Chapter No. 284 – missing committee signatures (only one signature), missing audit date. I refer these to the Grand Officers to address.

2019/2020 Annual Returns - Signatories: The following Chapters report that there is not more than one signatory on the accounts of the Chapter: Independence Chapter No. 12; Macon Chapter No. 22; Oriental-Rabboni Chapter No. 78; Bethany Chapter No. 80; and Keystone Chapter No. 146. I refer these to the Grand Officers to address.

2019 Annual Returns – Dues: The following Chapters reported dues charged each member to be less than that required by Grand Chapter (\$35.60): Columbia Chapter No. 17 (\$35.00); Macon Chapter No. 22 (\$29.60); Bellefontaine Chapter No. 25 (\$33.75); Trenton Chapter No. 66 (\$30.00); and Joplin Chapter No. 91 (\$30.00). I refer these to the Grand Officers to address.

2020 Annual Returns – Dues: The following Chapters reported dues charged each member to be less than that required by Grand Chapter (\$35.60): Columbia Chapter No. 17 (\$35.00); and Joplin Chapter No. 91 (\$30.00). I refer these to the Grand Officers to address.

2019 Annual Returns – 990 Status: The following Chapters did not file evidence of a completed 990 filing (see note below): Hannibal Chapter No. 7; Lexington Chapter No. 10 – filed, but no notice of IRS Confirmation; Mitchell Chapter No. 14 – filed, but no notice of IRS Confirmation; Macon Chapter No. 22; Greenfield Chapter No. 38; Lebanon Chapter No. 64 – filed, but no notice of IRS Confirmation; Bethany Chapter No. 80 – working with CPA to get status restored, filed notice with Grand Secretary; Shelbina Chapter No. 99; Vincil Chapter No. 110; Poplar Bluff Chapter No. 114 – filed, but no notice of IRS Confirmation; and Harry D. Brown, Jr. Chapter No. 284. I refer these to the Grand Officers to address.

2020 Annual Returns – 990 Status: The following Chapters did not file evidence of a completed 990 filing (see note below): St. Charles Chapter No. 1 – filed but no evidence of IRS Confirmation; Hannibal Chapter No. 7; Mitchell Chapter No. 14 – filed, but no notice of IRS Confirmation; Macon Chapter No. 22; Lebanon Chapter No. 64, Trenton Chapter No. 66; Bethany Chapter No. 80 – working with CPA to get status restored, filed notice with Grand Secretary; Joplin Chapter No. 92 – filed, but no notice of IRS Confirmation; Shelbina Chapter No. 99; Orient Chapter No. 102 – filed but no notice of IRS Confirmation; Poplar Bluff Chapter No. 114 – filed, but no notice of IRS Confirmation; and Harry D. Brown, Jr. Chapter No. 284. I refer these to the Grand Officers to address.

2019 Annual Returns – Chapter Indebtedness: The following Chapters reported a negative cash on hand as of December 31, 2018: None.

2020 Annual Returns – Chapter Indebtedness: The following Chapters reported a negative cash on hand as of December 31, 2018: Keystone Chapter No. 146. I refer this to the Grand Officers to address.

Annual Returns – Summary: Repeating from previous years, again, (nothing has changed). I would direct the Grand Officers' (as well as appropriate committees') attention to the several items in the written reports above and the statistical reports below – Chapters who report little to no Cash on Hand; no Paraphernalia value; Chapters who show an indebtedness; and Chapters whose dues are extremely low or even less than Grand Chapter per capita. DDGHP's should take notice of those Chapters who failed to record any RARA donations and provide education. Any Chapter having only one signature on Chapter accounts is a critical failure of local leadership and audit committees. Finally, I would refer to the Grand High Priest and appropriate committees the list of Treasurers and Secretaries who are not bonded, and whose Chapters failed to submit an annual audit. We must start reviewing and addressing these statistical reports and what appears to be failures on the part of the Chapters, although we are sure most of these items could be remediated through training, education, and accurate reporting of the subordinate officers by the appropriate Grand Chapter officers.

Missouri Chapter No. 0: Again, I would encourage the Grand Chapter Officers to review the formation of this chapter and complete the process or repeal the law.

2019 Growth Awards: There were 48 Exaltations during the 2019 reporting year. Grand Chapter Growth Award will be presented to Jefferson City Chapter No. 34 (5%), Mt. Nebo Chapter No. 148 (5%), and Kansas City Chapter No. 28 with the largest growth (21%). No other Chapter met the 5% growth minimum.

2020 Growth Awards: There were only 12 Exaltations during the 2020 reporting year before things broke down due to the pandemic. A Grand Chapter Growth Award will be presented to Macon Chapter No. 22 (8%). No other Chapter met the 5% growth minimum.

MMS: We are finally pleased to report that all of our Chapters are fully engaged and using MMS, either by the Chapter Secretary or the IT Representative designated for that purpose. Our office believes this to be one of the most significant positive changes to the Grand Chapter of Missouri in many years. We thank you for all your hard work.

Secretaries and IT Representatives: Although the above narrative highlights many opportunities for improvement, the operations of the Subordinate Chapters in Missouri would not exist, nor, I dare say, this Grand Chapter, without the ultimate devotion and hard work of all of the Secretaries and IT Representatives of each and every Chapter around this great state. They have helped improve the business processes of this office, moved us forward in managing membership records, and are even the lifeblood of their Chapters. There is a very fine line between dedication and insanity, and it takes a special kind of crazy to be a fraternal Secretary. We owe each one of them our gratitude and appreciation for keeping us alive. Thank you!

Search for new Grand Secretary: It is anticipated that unless something drastic happens, I will be leaving this office in June 2022. Although it is not bound by law, I would encourage interested applicants to submit their resumes directly to me for review and referral to the appropriate grand officers. Applicants will be screened to determine an applicable skillset and capability to perform the job. Upon their successful election to office, we will work with and train the new Grand Secretary and his staff, so they are fully qualified to perform the functions of this office. It is my intention, after I retire, to fully invest the time needed to help complete all the things that remain unfinished and hopefully to work with and support whomever you select as my successor, if you will have me.

LEGISLATION FOR ACTION AT THE 2021 GRAND CHAPTER CONVOCATION

Proposal No. 1 consists of proposed amendments to four Articles and five Sections of the by-laws. Since they are wording changes of a simple and collective nature, unless there is an objection, they will be voted upon collectively.

PROPOSAL No. 1

PROPOSAL TO AMEND THE BY-LAWS OF THE GRAND CHAPTER OF ROYAL ARCH MASONS OF THE STATE OF MISSOURI TO READ AS FOLLOWS:

(Deletions appear in ~~strike-through~~, additions appear underlined)

ARTICLE III, Powers and Duties of the Grand High Priest, Section 24. Appointment of ~~Auditor~~ Examiner, and Other Duties. He shall appoint an ~~auditor~~ Examiner, whose duty shall immediately prior to the annual convocation to examine and ~~audit~~ inspect the accounts and vouchers of the Grand Secretary and Grand Treasurer and certify the facts, as found, to the Grand Chapter.

ARTICLE V, Grand Treasurer, Section 27. Grand Treasurer. The Grand Treasurer shall receive from the Grand Secretary all funds and securities of the Grand Chapter, and deposit the same in the name of the Grand Chapter in some bank or trust company, to be approved by the Grand High Priest and Chairman of the Committee on Finance. He shall attend the annual convocation of the Grand Chapter, and when required, meet the Grand Officers with his books and all necessary documents relating to his office, turn said books over to the ~~auditor~~ Examiner when requested, make a full report at the annual convocation, pay all warrants drawn on him by authority of the Grand Chapter and at the commencement of his term of office, each year, execute and file with the Grand High Priest his official bond with some reliable company as surety thereon, in such sum as the Grand Chapter shall determine, to be renewed as to the amount of surety, when required by the Grand High Priest or Grand Chapter; the cost of such bond to be paid by the Grand Chapter. Such bond to be conditioned that he will faithfully discharge the duties of his office, account for all money or property of the Grand Chapter that may come into his hands; produce on demand of the Grand Chapter, Grand High Priest, or his successor in office the same, together with all books, papers, vouchers, securities jewels, etc., belonging to the Grand Chapter. He shall take duplicate receipts for same, one of which shall be delivered to the Grand Secretary. The salary of the Grand Treasurer shall be fixed by the Grand Chapter annually, upon the recommendation of the Finance Committee. (*Amended April 24, 1973, May 9, 1998*)

ARTICLE X, Standing Committees, E. The Committee on Finance and Accounts shall examine the financial statements of the Grand Treasurer, Grand Secretary, and ~~auditor's~~ Examiner's report upon the same. It shall also report upon all matters touching the finances of the Grand Chapter; and no appropriations shall be made without having been considered and reported on by this Committee. It shall be a committee of three consisting of the Grand King, Grand Scribe and Grand Captain of the Host. Each year, the Grand High Priest shall designate one of the aforementioned three officers as the chairman for the ensuing year. All Remaining elected Grand Chapter Line Officers Shall be ex-officio members of the Committee. (*Amended May 14, 2009*)

1. In addition, in the event of death or disability of either the Grand Treasurer or Grand Secretary, the Finance Committee together with the concurrence of the Grand High Priest shall have the authority to remove all ledgers and other financial records and shall retain a qualified ~~auditor~~ Examiner not previously involved who shall perform a complete ~~audit~~ review of such records. These actions shall be conducted with expediency so as not to unduly interfere with the operations of the specific office. (*Amended May 9, 1998*)

ARTICLE XII, Chaptered Chapters, Section 103. Annual Returns. On or before December 31st of each year, Chapter Secretaries will submit to the Grand Secretary a complete list of remissions for their Chapter to include the member's full name and type of remission in accordance with Section 163. Remission of Dues. On or before February 1st of each year the Grand Secretary will provide a Masonic Membership Solutions (MMS) statistical report for the previous reporting year along with an invoice for the calculated fees due the Grand Chapter. The invoice will include appropriate fees and credits. Fees shall consist of Exaltation Fees, Per Capita and any outstanding balances from the previous year's return. Credits shall consist of approved Remissions. Endowed Memberships and General Grand Chapter Perpetual Memberships as verified by the Grand Secretary, along with any overpayments from the previous year's return. A Financial Report and an Annual ~~Audit~~ Inquiry and Examination Committee Report Form (see Section 104A. Annual ~~Audit~~ Examination) will also be included as part of the Annual Return. All forms will be completed and returned to the Grand Secretary along with a copy of the latest IRS Form 990 or a copy of the acceptance of the electronic submission of a Form 990N and a check or money order for all fees due the Grand Chapter. Failure to file a complete return as provided herein shall subject the chapter to a fine of twenty-five dollars (\$25.00) for each period of thirty days, or fraction thereof said return is withheld. Any Chapter that does not submit a complete annual return and/or any late filing fees to the Grand Secretary's office not later than thirty (30) days prior to the Annual Convocation of the Grand Chapter shall forfeit all rights and privileges to representation and voting at the Annual Convocation. (*Amended May 20, 2005, May 19, 2006, June 8, 2017, June 2018*)

ARTICLE XII, Chaptered Chapters, Section 104A. Annual ~~Audit~~ Inquiry and Examination. There shall be a complete and careful ~~audit~~ examination of the financial affairs of each subordinate chapter and of ~~the~~ its books, accounts, and vouchers of the Secretary and Treasurer and of others handling, and having in charge, money or property of the chapter. Such ~~audit~~ examination shall cover the period from the last previous ~~audit~~ examination up to and including the thirty-first day of December of each year.

Upon his election, or as soon thereafter as is possible, the High Priest-elect, shall appoint an ~~auditing~~ Inquiry and Examination ~~e~~ Committee of three or more members, whose duty it shall be forthwith to ~~audit~~ examine the books and accounts and vouchers of the Treasurer and Secretary of the chapter. If the chapter has trustees, or other custodians of property or funds, then their books, accounts, and vouchers shall also be ~~audited~~ examined and the securities or other property checked, inspected, etc. The books, accounts and vouchers of any other officer, member or committee may subject to an ~~audit~~ inquiry and examination review.

The High Priest-elect, may in lieu of an ~~auditing~~ Inquiry and Examination ~~e~~ Committee designate any certified public accountant or firm of certified public accountants to make ~~the final~~ an audit on their books, provided that the certified public accountant or member of a firm of the same is not related by blood or marriage to the out-going High Priest, Secretary, or Treasurer.

The report of ~~audit~~ inquiry and examination shall be in duplicate, in writing, and be signed by the ~~Audit~~ Inquiry and Examination Committee or the C.P.A., or firm of C.P.A.'s who made the inquiry and examination or audit.

One copy of the report shall be delivered forthwith to the High Priest-elect, who shall see that the same is presented to and read in open chapter at the next stated convocation following its date and be spread upon the records thereof; and the other copy shall be transmitted to or filed with the Grand Secretary on or before the first day of March (that being the date for the transmittal to or filing with the Grand Secretary of the annual returns of the chapter).

All of the actions contemplated herein shall be performed with a view to having the ~~audit~~ examination completed and the report made prior to the first day of March in each year.

Said report of ~~audit~~ **inquiry and examination** shall be made upon standard printed forms provided by the Grand Secretary, but nothing contained in or omitted from such printed forms shall relieve the ~~auditing~~ **Inquiry and Examination** e Committee or C.P.A., OR firm of C.P.A.'s from reporting fully and completely their findings in the premises. (*Amended May 19, 2006*)

STATEMENT OF PURPOSE: Companions, the proposed changes have been submitted and recommended because the Internal Revenue Service of the United States of America, has in recent years demeaned and viewed that Auditor and audit can only be done by an authorized Certified Accountant or firm that handles such matters. This makes it risky and could inspire an inquiry or examination of our fraternity by the federal government into our operations. This is to eliminate such an occurrence from happening.

PROPOSAL TO AMEND THE BY-LAWS OF THE GRAND CHAPTER OF ROYAL ARCH MASONS OF THE STATE OF MISSOURI TO READ AS FOLLOWS:

(Deletions appear in ~~strike-through~~, additions appear underlined)

ARTICLE XXII, Suspension for Non-Payment of Dues, Section 187. Non-Payment of Dues. ~~When a member fails to pay his dues on or before April 1 of any year, the secretary, must immediately notify the member, in writing, of his delinquency. Should the delinquent refuse or fail to pay his dues on or before the next stated convocation of the chapter, after the issuance of such notice, it shall be the duty of the secretary to notify the High Priest of such failure, who shall, in open chapter, appoint a committee to investigate the background and circumstances of the delinquent companion and report at the next stated convocation. If, after such notice and investigation, the member fails to pay his dues on or before June 1, he is automatically suspended for nonpayment of dues, without any further action necessary by the chapter. The suspension is recorded by the secretary in the minutes of the first meeting of the chapter thereafter. The secretary must give written notice, on or before June 11, to all members automatically suspended for nonpayment of dues. Written notice is given by first class, fully prepaid, United States mail, to the member at his last known post office address. The automatic suspension of the member is not affected by any failure to notify or to record the suspension. This section shall not apply in instances where a member's dues have been remitted." (Adopted in 1954 as Section 188, Amended 1962, May 15, 2013)~~

To:

ARTICLE XXII, Suspension for Non-Payment of Dues, Section 187. Non-Payment of Dues. When a member fails to pay his dues on or before March 1 of each year, the secretary must notify the member in writing of his delinquency on or before March 11. If, after notice, the member fails to pay his dues on or before April 1, he is automatically suspended for non-payment of dues. The suspension should be recorded by the secretary in the minutes of the first meeting of the chapter thereafter. See Section 155E. Suspension of Dual/Plural Member for Non-Payment of Dues.

STATEMENT OF PURPOSE: A Companion's dues should be paid by December 31st of each year. The length of time a Companion has to pay his dues is longer than necessary. Shortening the time to pay dues will make the Secretary's job easier and gives each Chapter better control over their finances and budgets and matches Grand Lodge of Missouri dues payment bylaws.
