BIOGRAPHY OF THE GRAND MASTER

Most Illustrious Companion Wayne Brian Fryer was born on March 19, 1961 in Rolla, MO. He attended schools in Rolla and graduated from Rolla High School in May 1979. He then attended College of the Ozarks in Point Lookout, MO, from June 1979 to May 1981, where he studied Business Administration. He transferred to Missouri State University in Springfield, MO, where he attended from August 1981 to July 1983, and graduated with a Bachelor of Science Degree in Marketing.

Wayne worked for ProCare Medical Supply Company in Rolla, MO, as a Home Medical Technician, for over six years. He then went to work for Kentucky Finance Company in Rolla, as an Assistant Manager. In October 1993, he was hired by the Missouri Department of Social Services as a Child Support Specialist. He worked in the Kansas City, Rolla and Springfield Offices, and retired in October 2017 after 24 years of service. He has worked several different jobs since that time. Wayne has two sons, Craig and Andrew. His parents are Luther and Shela Fryer. His father served as Secretary/Recorder of the Rolla York Rite Bodies for over 20 years.

Wayne petitioned St. James Lodge No. 230, Ancient Free and Accepted Masons, and was raised a Master

Mason in March 1998. He served as Worshipful Master from 2000 to 2001. He is an Endowed Member, and the current Chaplain. He was inducted into the Order of the Past Master in September 2002. He is also a dual member with Rolla Lodge No. 213, Ancient Free and Accepted Masons, where he is a current Trustee.

Wayne received his York Rite Degrees and Orders in May 1998, at a York Festival in Springfield, MO. He served as High Priest of Rolla Chapter No. 32, Royal Arch Masons from 2005 to 2006. He is an Endowed Member, and the current Treasurer. He received the Grand Chapter Achievement Award, and the Lewis and Clark Award. He also is a member of the Order of the High Priesthood. Wayne served as Illustrious Master of Rolla Council No. 39, Royal and Select Masters, from 2014 to 2015. He is the current Treasurer, and also a member of the Order of the Silver Trowel. Wayne was made an honorary member of the Grand Council, Cryptic Masons of Tennessee in March 2021. He served as Eminent Commander of Rolla Commandery No. 59, Knights Templar from 2015 to 2016. He is the current Treasurer, and a member of the Past Commander's Association.

Wayne currently serves as Junior Warden of Elizabeth St. Leger Council No. 386, Allied Masonic Degrees, and as the current Treasurer of Gates of Derry Council No. 82, Knight Masons. He is a Past Watchman of Shepherds of Harmony Shrine No. 20, Order of the White Shrine of Jerusalem, and is the current Worthy Guardian. He is the current Associate Patron of Rolla Chapter No. 176, Order of the Eastern Star, and the current Advisor of Spirit Conclave No. 27, Order of True Kindred. He is also a member of Missouri Priory No. 17, Knights York Cross of Honour, and received the Knight York Grand Cross of Honour in July 2019. His other memberships include the Missouri Lodge of Research, Lord of Lords Tabernacle LI, HRAKTP, Ancient and Accepted Scottish Rite, Valley of Joplin, and Pulasco Scottish Rite Club.

Wayne previously was a member of the Independent Order of Oddfellows, where he served as Noble Grand of Big Spring Lodge No. 237, and as Chief Patriarch of Gateway Encampment No. 175. Neither of those Lodges exist today.

ADDRESS OF THE GRAND MASTER

To the Grand Officers, Most Illustrious Past Grand Masters, and Companions All:

It is my pleasure to welcome you to the One Hundred Fifty-Fifth Annual Assembly of the Grand Council of Cryptic Masons of the State of Missouri. It has been a great honor to have served as your Grand Master for these last two years. I was elected Grand Master of the Grand Council for the 2019-2020 year, after our Deputy Grand Master Christopher E. Tilley was unable to advance to the office of Grand Master. Right Illustrious Companion Tilley was diagnosed with Leukemia, and unfortunately passed away only a few short months later. His death left a huge void not only in the leadership of the Grand Council, but also within our hearts.

Three months before the end of my term, the COVID 19-Pandemic effectively shut down all in person meetings and events. It was determined that the best course of action would be for me to serve a second year as Grand Master, and to hold a Virtual Special Assembly in place of our Annual Grand Assembly. An in person Grand Assembly was just not possible due to the spread of COVID-19, and our concern for the health of all members. Although this was unprecedented in the Grand Council, the abbreviated virtual Special Assembly was a great success. This is due to the efforts of our Grand Recorder, Most Illustrious Companion Kevin B. Sample, Right Illustrious Companion Russell S. Hanson, and several others. A simple thank you seems inadequate, but I think they know how much they are appreciated.

Finally, I would like to thank Most Illustrious Companion Todd A. Schulze for appointing me to the Grand Council advancing line. I hope I have met his expectations during my term as Grand Master. Todd also assumed Chairmanship of the Jurisprudence Committee last year, and I am very grateful for his willingness to continue to serve the Grand Council. I want to thank each one of you in attendance at the 2021 Grand York Rite Annual Sessions. I hope your time here is enjoyable and memorable for many years to come. Pursuant to Article II, Section 9 of the Grand Council By-laws, I present the following report on my term as Grand Master.

Necrology

We make many new friends in Freemasonry, and the losses of our members and friends is felt for many years to come. During the 2019-2021 reporting years (1/1/19-12/31/20), the Grand Council lost a total of 199

A Memorial Service will be conducted by our Grand Chaplain, Very Illustrious Companion Roy L. Gilkey.

Past Grand Masters

I would like to thank the Past Grand Masters who provided guidance to me when needed. I appreciate their concern for the future of the Grand Council, their willingness to serve on committees when needed, and for

being there for me whenever I had questions. Special mention goes out to Most Illustrious Companions Todd A. Schulze, Joseph P. Elsen, and Aaron M. Shoemaker. Their guidance and council were vital in a COVID-19 Pandemic Environment that included issues and concerns that we had not encountered before.

Appointments

Serving a second term in 2020-2021 gave me the opportunity to appoint two Companions to the Grand Council Advancing Line. It was a privilege to be able to appoint Very Illustrious Companion Dennis W. Houck as Grand Steward for 2019-2020, and Very Illustrious Companion Taz A. Meyer as Grand Steward for 2020-2021. These companions have distinguished themselves through their work in the quarries over the years in a number of Masonic Bodies, and their backgrounds make them exceptionally qualified. They have the character and talent to lead this Grand Council to greater success in the future.

Message

My themes for my term as Grand Master were simply Mentorship and Teamwork.

Mentorship: "A relationship in which a more experienced or knowledgeable person helps to guide a less experienced or less knowledgeable person". Being a mentor is absolutely crucial in order to create interest in our fraternity, as well as prepare our newest members to be active York Rite Masons & future leaders in our councils. It helps our members and leaders improve to the point where they are performing consistently at an optimum level. In any endeavor, we need the guidance of those who have traveled the same path before us. Let us strive to seek out those members who need our guidance and mentoring and fulfill our duty as Cryptic Masons to serve others

Teamwork: To be a successful team, we must develop relationships with our members, and learn about their interests, their strengths, and even their weaknesses. This helps us determine the best opportunities for service within our Councils and Grand Council. My focus on teamwork centers mainly around improved communication. We must continuously work together to improve communication between Grand Council Officers, the Grand Council and Subordinate Councils, and Subordinate Councils and their membership. Communication is not only a key, but the first step in working together as a team. Team members must be clear on what is expected of them, as well as know how to perform their duties. You cannot perform to your capabilities without knowing exactly what is expected of you as an officer. To assist in this effort, we established a new and expanded version of the document "Duties & Responsibilities of a Regional Deputy Grand Master".

In our effort to improve communications, we also established a Grand Council Monthly Newsletter in October 2020. The newsletter focuses on York Rite and Cryptic Education, upcoming events, and news about past events and recognitions that have occurred at York Rite and Council events around the State. I also want to commend the Springfield York Rite and the Kansas City York Rite for outstanding newsletters, which do a great job in providing information and promoting the York Rite in their regions. Special thanks go out to Very Excellent Companion Greg Walker and Right Illustrious Companion Don MacCormack for the excellent work that they do.

Ritual Proficiency: Although Ritual Proficiency was not a theme of mine, I do want to reiterate the importance of ritual. Our degree work is so much more impressive to the candidate when it is performed by memory. That is not to say that every single part needs to be performed without a ritual book, but that the majority of it should be when possible. We have to understand that some members just are not good at memorizing and performing ritual. However, we can all improve our ritual just by working at it on a consistent basis. To this end, I scheduled several Grand Council Ritual Schools of Instruction during my term. We held a Ritual School of Instruction in Springfield on March 27, 2021, mainly for Grand Council Officers, and one in Columbia on April 24, 2021, for all members. As Grand Council Officers is it our goal to set the example for members, in working toward ritual proficiencies. These two Ritual Schools increased the number of Companions with a Part One (Opening and Closing of a Council) proficiency by eight, including three Grand Council Line Officers. I recommend we continue the promotion of Council Ritual Proficiencies in the next few years.

Visitations

Throughout portions of my 2019-2020 term as Grand Master, my visitations were hampered by the COVID-19 Pandemic. For a large portion of 2020, Councils were not allowed to meet in person. This was due to Edicts from the Grand Lodge and Grand York Rite Bodies, which were established to keep our membership safe. However, our Councils were able to hold virtual meetings. It also gave me the time to attend many virtual educational presentations and other online events. The ability to hold meetings and events virtually was a lifesaver. It allowed us to conduct the necessary business of our Councils, and also provided a necessary means for social interaction. Although these virtual meetings and events did not take the place of in person meetings, they served their purpose very well.

I was fortunate to be able to attend a number of Masonic Youth Events, including the Missouri Annual Sessions of the Jobs Daughters International, and the International Order of Rainbow for Girls. I also attended several DeMolay events in our region. Rolla DeMolay Chapter was instituted on March 15, 2020, due to the efforts of Chapter Advisor Matt Cordoves. The previous Chapter had closed over a decade ago. I saw some outstanding ritual performed in the DeMolay degrees. When you see how much these young men and young ladies enjoy the fun and fellowship of these events, it makes you realize just how important our Masonic Youth Organizations are. The support from our Masonic Bodies is crucial to their future, and we need to make sure we continue to support them. Not just financially, but by attending and supporting their local events and activities also.

I was able to attend two out of state Grand Sessions, the Grand York Rite of Tennessee in Lebanon, TN, and the Grand York Rite of Nebraska in Kearney, NE. In Tennessee, the Grand York Rite Sessions were condensed from the usual two days to one day. I was fortunate to be able to also attend the Grand Lodge of Tennessee, F&AM the next day, which was also condensed from two days to one day. It was very well attended and both sessions were run very well. It was a great experience to meet other Companions and Sir Knights and learn how they conduct their Grand Sessions. I was also privileged to be made an honorary member of the Grand Council of Cryptic Masons of Tennessee. In Nebraska, I attended the York Rite Sessions along with Right Puissant Companion Bill Snyder. I met a number of new companions, and I can't say enough about the warm reception we received from the Companions and Sir Knights in Nebraska. They had a great session, which included many out of state dignitaries in attendance. It was a great opportunity to meet other Companions and Sir Knights, and learn how their jurisdictions were similar to ours, and how they were different.

I also attended the Laclede County All-Masonic Family Christmas Dinner, in Lebanon, MO on December 21, 2019. This event was held at the Laclede County Shrine Club, which is next door to the Laclede Masonic Temple. I enjoyed a wonderful event, which not only celebrated the Christmas Season, but included a great dinner, fellowship, and many fun activities. All members of local Masonic Bodies and their family members were invited. It was such a pleasure to see the family members and especially the children having a good time. There were several speakers, including Illustrious Companion Dale Roller as emcee, myself, Sir Knight Roger Fleer, Past Grand Commander, and the Potentate of Abou Ben Adhem Temple in Springfield. We saw the local Shrine Club Installation of Officers, as well as one of the many children helped by Shriner's Hospitals for Children. This was a great event that I feel should be emulated in our communities across the state.

As I traveled throughout Missouri, I was warmly received by many companions I knew, and some that I met for the first time. Making new friends is one of the highlights of serving these past two years. All made me feel at home wherever I went. I cannot thank everyone enough for the wonderful treatment I received.

Edicts Issued

Edict No. 1

March 24, 2020

Whereas the Constitution of the Grand Council of Cryptic Masons of the State of Missouri, Article I. Grand Council Sec. 4. Special Powers (9)...to consider and do all whatsoever it may regard as necessary, or appertaining to the well being and perpetuation of Cryptic Masonry...and,

Whereas The By-Laws Article II Sec II. The Grand Master, Powers and Duties (1) ...have general supervision of the craft..., and,

Whereas Article VI Councils, Chartered Councils Sec. 47. Councils Stated Assemblies, requires stated Assemblies shall be at the time specified in the By-Laws. and,

Whereas Section 55. Councils, Place of Meeting, anticipates the possibility of situations where it is impossible for a Council to hold an assembly at its regular place of meeting by various good and sufficient reasons for the Grand Master to grant a dispensation to do so, and,

Whereas, a highly contagious and potentially deadly coronavirus is spreading throughout the world; and,

Whereas, cases of and deaths due to the virus have been confirmed within the jurisdiction of this and neighboring Grand Jurisdictions,

Now, Therefore, under the authority of Article I, Grand Master, Powers and Duties of the Grand Master, Sec.4 (9), I hereby issue the following Edict, effective immediately:

- A. All Councils subordinate to this Grand Council shall cancel or postpone all stated or special assemblies and or meeting/events of said Council until further notice. The purpose of said cancelation or postponement is to prevent or limit the exposure of officers and members of the subordinate Council to coronavirus or some other such infectious or contagious disease of a similar nature.
- B. This Edict will remain in place unless cancelled or amended by further Order of the Grand Master or until the term of office of the office of the Grand Master shall be concluded.
- C. This Edict shall serve as the Dispensation for all cancelled or postponed assemblies during the period of this Edict.

Amendment to Edict No. 1

May 2, 2020

- A. Effective Monday, May 4, 2020, the restrictions previously imposed on the Grand Council and the Subordinate Councils by canceling or postponing all stated or special convocations and or meetings/events of said Council are herein partially lifted with the following restrictions remaining in force:
- B. All meetings held shall be conducted in a manner which complies with all laws, regulations, requirements and guidelines of the State of Missouri and any city, county or

other political subdivision in which the Council meeting facility is located. Further, all meetings shall adhere to all social distancing and public gathering size limitations/restrictions as defined by the above agencies. In addition, all meetings so held shall be conducted in a manner which complies with all recommendations of the United States Centers for Disease Control with respect to face coverings, hand sanitation and disease mitigation protocols.

- C. Councils may not confer any degrees or orders. Councils may conduct ceremonies, education or other business only in a manner which complies with the above requirements.
- D. Further information about State of Missouri and any city, county or other political subdivision restrictions may be found at the following web site: https://health.mo.gov/living/healthcondiseases/communicable/novel-coronavirus/results.php
- E. This Amended Edict No. 1 will remain in place unless cancelled or amended by further Order of the Grand Master or until the term of office of the office of the Grand Master shall be concluded.

Edict No. 2

May 4, 2020

Whereas Article I of the Constitution, Grand Council Sec. 4. Special Powers (9) states ...to consider and do all whatsoever it may regard as necessary, or appertaining to the well being and perpetuation of Cryptic Masonry...and

Whereas ARTICLE II of the Constitution, SEC. 8. Assembly of Grand Council states This Grand Council may hold an Annual Assembly at such time and place as shall be provided in the by-laws, provided, that whenever in time of emergency it is found by two, or all three, highest officers of this Grand Council that on account of any law, regulation, or executive order be so restricted that representatives to the Annual Assembly will not be able to attend such Assembly, the Grand Master may, thirty days prior to the date of the stated Annual Assembly, notify all subordinate Councils that the Annual Assembly for any year in which such conditions exists, will not be held, and

Whereas ARTICLE I of the By-Laws, Assemblies of the Grand Council, SEC. 1. Assemblies states ...whenever the majority of the three highest officers of the Grand Council shall be in their discretion determine that the business of the Grand Council may be such that the annual assembly should convene at some other or different hour than 10 o'clock a.m., the Grand Master shall be authorized to fix the hour of opening of such annual assembly, giving the subordinate councils sufficient notice of such a change to enable all representatives to be present at the opening of the assembly, and

Whereas ARTICLE I of the By-Laws, Assemblies of the Grand Council, SEC. 2. Special Assemblies states Special Assemblies may be called at the pleasure of the Grand Master, but no business shall be transacted at a Special Assembly other than that specified in the notice for the Assembly, and

Whereas ARTICLE II of the By-Laws, SEC. 11. The Grand Master, Powers and Duties, (1) states ...have general supervision of the craft..., and

Whereas the Grand Council Officers feel that it is in the best interest of our membership to take seriously the current health environment and the potential infectious and contagious risk to our membership, and

Whereas the Grand Master and the Grand Principal Conductor of the Work have provided written consent to postpone the 2020 Annual Grand Assembly of the Grand Council of Cryptic Masons of the State of Missouri until June 10, 2021, and

Whereas the Grand Council has official business which must be conducted before June 10, 2021,

Now, Therefore, under the authority of Article I, Grand Master, Powers and Duties of the Grand Master, Sec.4 (9), I hereby issue the following Edict, effective immediately:

- A. The 2020 Annual Grand Assembly of the Grand Council of Cryptic Masons of the State of Missouri will be postponed until June 10, 2021, and
- B. There will be a virtual Special Assembly of the Grand Council of Cryptic Masons of the State of Missouri to be held on Saturday, June 13, 2020 at 10:00 a.m. via WebEx and private YouTube attendance, and the business of the virtual Special Assembly will consist of:
- a. Receiving and acting upon the proposed 2020-2021 Grand Council fiscal year budget, and
- b. Receiving and acting upon legislative proposals received by the Committee on Jurisprudence for the previously scheduled Annual Grand Assembly, and
- c. The election of all the officers below the office of Grand Master to fill the vacancy created by the passing of the Deputy Grand Master, and
- d. The declared Installation of said officers by the Grand Master Information will be forthcoming about how to register (credentials) and how to attend the virtual Special Assembly.

Further Amendment to Edict No. 1

September 28, 2020

Whereas the highly contagious and potentially deadly coronavirus is continuing to spread throughout the world, resulting in more cases and more deaths within the jurisdiction of this and neighboring Grand Jurisdictions,

Now, Therefore, Edict No. 1 is further amended as follows:

- F. The continued safety of all members of Subordinate Councils under the jurisdiction of the Grand Council being of the utmost importance and concern, all Subordinate Councils will have the option of conducting all Assemblies and other ceremonies virtually. If any assistance is needed by Subordinate Councils in setting up virtual Assemblies or other ceremonies, please contact the Grand Recorder of the Grand Council for assistance.
- G. In determining compliance with the requirements of the Grand Council, all awards presentations by the Grand Council, all Assemblies and other ceremonies held virtually, will be considered the same as in-person meetings.
- H. This further Amendment to Edict No. 1 will serve as the official dispensation for all Subordinate Councils to hold Assemblies and other ceremonies virtually, in place of inperson Assemblies and ceremonies held in a designated facility, for the duration of Edict No. 1 and the amendments to Edict No. 1.
- I. This further Amendment of Edict No. 1 and the previous Amendment dated May 2, 2020 (herein contained) will remain in place unless cancelled or further amended by Order of the Grand Master or until the term of office of the office of the Grand Master shall be concluded.

Edict No. 3

March 15, 2020

Whereas The infection levels in the State of Missouri have started to decline to levels that many health professionals consider to decrease risk of infection in an environment that is using accepted safety guidelines and using safe protocols,

Whereas While resuming activities, one must keep in mind that the situation is still unknown and volatile, and could worsen at any time,

Whereas The members of the Masonic Fraternity have been limiting their risks of exposure for over a year, and are anxious about resuming activities in their Councils,

Now, Therefore, under the authority of Article I, Grand Master, Powers and Duties of the Grand Master, Sec.4 (9), I hereby issue the following Edict, effective immediately: The following EDICTS are rescinded as of April 1, 2021:

Edict No. 1, dated March 24, 2020

Amendment to Edict No. 1, dated May 2, 2020

Further Amendment to Edict No. 1, dated September 28, 2020

Effective April 1, 2021, Councils may confer all the Cryptic Degrees under the following conditions:

- A. The Council MUST comply with all Federal, State, County, and Municipal/City laws, directives, ordinances, and mandates. This includes any restrictions on meeting attendance size, meeting length, meeting location, or any other particulars that may be specified for gathering by any of these governmental entities including the wearing of masks and safely social distancing from each other.
- a. The candidate and those participating in the degree must be aware of the possible risk of exposure to COVID-19 during the conferral of the degree and consent to participate, and the conferral of the degree implicitly acknowledges consent by all parties. No coercion is to be used on the candidate to appear or for participation in conferring a degree. If the candidate or any Companion is concerned about exposure, the degree is to be rescheduled and no ill will is to be demonstrated towards any candidate or Companion that declines to participate.
- b. A personal copy of a Volume of Sacred Law must be given to the candidate by the Councils to use for his degree work, or a candidate may provide his own Volume of Sacred Law. Under no condition can a Volume of Sacred Law be used by more than one candidate.
- c. If there is a resurgence of the virus, stricter conditions could be enacted or a "Suspend Work" order could be issued, which will have the same authority as an Edict, and councils will suspend degree work immediately.
- d. Failure to follow any of the aforementioned conditions for degree conferral will be considered a direct violation of the orders of the Grand Master and may subject the council to disciplinary action, up to and including arrest of the Council charter.
- e. Further information about State of Missouri and any city, county or other political subdivision restrictions may be found at the following web site: https://showmestrong.mo.gov/data/public-health/
- B. Council Masters, if they feel there is still a risk of infection to the members of the Council and/or to comply with any federal, state, county, and/or local municipality restrictions that could affect the ability of Councils to meet, shall have the ability to:
 - a. Reschedule Council Assemblies,
 - b. Cancel Council Assemblies, or
 - c. To hold virtual Assemblies in place of in-person Assemblies.
 - i. If meeting virtually, no ritual may be performed.
- ii. In determining compliance with the requirements of the Grand Council, all awards presentations by the Grand Council, all Assemblies and other ceremonies held virtually, will be considered the same as in-person meetings.
- d. This Edict shall serve as the Official Dispensation for all cancelled, postponed, or virtual Assemblies during the period of this Edict.

This Edict No. 3 will remain in place unless cancelled or amended by further Order of the Grand Master or until the term of office of the office of the Grand Master shall be concluded.

Charters Arrested

July 2, 2020

Arrested Charter of Fidelity Council No. 35 and authorized VIC Carlin Smittle, RDGM, Region 7A, to take possession of the Charter and Seal on behalf of the Grand Council. Ordered Grand Recorder to send notice to each member and if any member wishes to remain a member, to issue a Statement of Good Standing and facilitate their Affiliation with the Council of their choosing.

Decisions

August 10, 2019

A request for dispensation was received from Joplin Chapter No. 91, Jasper Council No. 30, and Ascension Commandery No. 39 to hold a special meeting for their election of officers since their June meeting conflicted with the Grand York Rite Special meetings.

The request was not granted for two reasons: 1) the request should have been three separate requests for three separate organizations, and 2) the request was for either August or September.

Requests for dispensations may not be co-mingled with other organizational requests, and the request must be very specific in nature, defining the issue, the proposed solution, and the very specific date, time of the original date/time and of the newly proposed date/time, and the very specific locations involved if there are location changes.

November 13, 2019

Approved the Consolidation of Eastgate Council No. 51 with Shekinah Council No. 24.

November 11, 2019

Approved the Consolidation of West Plains Council No. 64 with Zabud Council No. 25.

August 23, 2020

Authorized Subordinate Councils to hold Virtual meetings to conduct business, elect and install officers, but they may not perform any ritual.

August 27, 2020

Regarding the Arrest of the Charter of Fidelity Council No. 35, the Grand Recorder notified each member of the Council in writing to determine their membership desires. Companion Baltz expressed his desire to move his membership to Neosho Council No. 46. Companion Baltz is already an Affiliated member of Neosho Council No. 46. Therefore, Companion Baltz is herein granted a Dimit from Fidelity Council No. 35, dated July 2, 2020. Further, Companion Baltz's Endowed Membership in Fidelity Council No. 35 is hereby transferred to Neosho Council No. 46.

August 27, 2020

Regarding the Arrest of the Charter of Fidelity Council No. 35, the Grand Recorder notified each member of the Council in writing to determine their membership desires. Companion Phares expressed his desire to move his membership to Zabud Council No. 25. Therefore, Companion Phares is herein granted a Dimit from Fidelity Council No. 35, dated July 2, 2020. Further, Companion Phares' membership is hereby officially moved to Zabud Council No. 25 by Affiliation, dated July 2, 2020. Zabud Council No. 25 will have the responsibility of collecting 2020 dues from Companion Phares.

November 27, 2020

A companion expressed concern regarding the name of the Grand Council of Missouri's "Purple Heart lapel pin". The Purple Heart Pin is given to Companions who donate \$100.00 to CMMRF. The name is "Purple Heart" because that is the color of the Council and shape of the pin.

I have determined that the Purple Heart Pin is different from the Purple Heart Medal and in no way is meant to copy or downplay the importance and significance of the Purple Heart Medal. Some of our Officers are Veterans and they agreed with this opinion. Jurisprudence also did not feel that there are any legal issues concerning our use of the name "Purple Heart".

The name of the pin will remain "Purple Heart Lapel Pin".

Dispensations Granted

September 6, 2019 Granted dispensation to John F. Houston Council No. 42 to move its stated assembly from September 23, 2019 to September 9, 2019, due to the Grand Lodge of Missouri annual

communication to be held on September 23, 2019.

December 7, 2019 Granted dispensation to Jeremiah Council No. 48 to remove from its regular stated meeting place and time on December 16, 2019 to the St. Charles Masonic Temple at 6:30 p.m. on

December 11, 2019, to participate in the Annual Christmas Observance with the other York

Rite bodies in the immediate area.

December 20, 2021 Granted dispensation to Shekinah Council No. 24 to change their meeting date to the first

Friday of every even number month with your first meeting under this dispensation to be held on February 5, 2021. This dispensation shall remain in force until the Annual Assembly of the Grand Council of Cryptic Masons of the State of Missouri after which it

shall no longer be in force.

Your Council is strongly encouraged to follow due process to amend their by-laws

accordingly before the Annual Assembly.

February 28, 2021 Granted dispensation to Zabud Council No. 25 for Temporary Removal from their home

at the Masonic York Rite Temple, 1930 W. Catalpa, Springfield, MO to Gate of the Temple

Lodge, 1700 N. Booneville, Springfield, MO due to the sale of their building.

By Law Changes, Subordinate Councils

July 25, 2020 Approved the By-Laws changes for Jeremiah Council No. 48, changing their greeting fee

from twenty dollars (\$20) to thirty dollars (\$30.00), and changing their annual dues from

thirty two (32) to forty dollars (\$40.00).

December 20, 2020 Approved the By-Laws change for Independence Council No. 49, lowering their annual

dues from \$40.00 to \$25.00.

March 15, 2021 Approved complete By-Laws Revision for York Council No. 40.

March 16, 2021 Approved complete By-Laws Revision for Tork Council No. 40.

Approved By-Laws change for Westport Council No. 38 as to a change of location to the

Masonic Lodge located at 2409 SW M 291 Highway, Lee's Summit, MO and their meeting date and time to the first Monday of each month except in July and August at 7:00 p.m. or

immediately following the meeting of Harry D. Brown, Jr., Chapter No. 284. These proposed changes were presented to the Grand Recorder in 2019 but due to several

communication issues, they were not formally approved until the above date.

Time Capsule

I visited and inspected the Masonic Time capsule in Branson, MO on April 24, 2020, and on April 26, 2021. It is a beautiful monument that was dedicated in 1999. The Time Capsule is in good condition overall, with a few minor issues that are of concern. It has a few light hairline fractures on the surface near the top of the monument, and some holes in the caulking around the base. The fractures are very minor, and do not seem to be getting worse over time. I believe no actions are needed unless the cracks get worse. The caulking is wearing due to the elements, and the holes need to be fixed. I would recommend that all of the caulking be replaced in the near future.

Grand Master's Coins

We have continued the tradition of Grand Masters Coins, in four-year sets. My coin for the 2019-2020 year was the third coin in the second set of four coins. All proceeds minus the cost of the coins were donated to CMMRF. The donation from the sale of coins helped Missouri place fourth in total contributions to CMMRF for the 2020 year, an outstanding accomplishment. I recommend the coin program be continued, as they are a popular keepsake and a very effective way to support our charities.

Grand Master's Cryptic Day

Grand Master's Cryptic Day was started back in April 2016, to honor the current Most Worshipful Grand Master of the Grand Lodge of Missouri. It also provides an opportunity to confer the Cryptic Degrees, and the Super Excellent Master Degree in Full Form. This event has been a very enjoyable one, and I was looking forward to continuing it in honor of our Most Worshipful Grand Master. We scheduled it for March 2020 in Jefferson City, MO, but I decided to cancel it at the last moment, as the COVID-19 Pandemic was just beginning to gain steam. The risk to our members was too great. It was scheduled again for March 2021 in Jefferson City, MO. However, I again made the decision to cancel it. The safety of our members was my ultimate concern. Now that COVID-19 vaccines are available to all, we are meeting in person again. I am confident we will be able to resume this event in 2022.

Membership Records and MMS

I believe the MMS system has worked well overall and improved many facets of our membership recordkeeping. However, issues that Recorders are having with MMS should be considered in determining possible recommendations for improvement.

IRS Form 990-N

Our Grand Treasurer has worked diligently in helping those Councils that are behind on their Form 990-N reports. He has always been willing to assist Councils with their problems and questions, and I very much appreciate his efforts.

State of the Cryptic Rite

We have some very active Councils that are prospering, and some that are barely hanging on. I do not have the answer to the problems we are facing. I do understand that as times change, many different things in our lives compete for our time. All organizations are dealing with the same issues. We must remember that the York Rite and Cryptic Rite offer something you cannot find elsewhere. The benefits are many. Members must determine that the investment in our Councils is a good investment of their time. By being active in our Blue Lodges, I believe potential members will become more aware of the York Rite, and see it as something they may want to be a part of. By making our presence known in Blue Lodges, I believe this will improve our Council membership numbers in the long run.

The Advancing Grand Council Line

The Grand Council Advancing Line of Officers has stabilized after the loss of several officers in recent years. The recent loss of our beloved companion and friend, Right Illustrious Companion Christopher E. Tilley was a huge loss. However, we have persevered and have an outstanding group who I believe will continue to lead this Grand Council to new heights. Our team is diverse, but cohesive, and has learned a lot from each other over these last two years. This will pay dividends well into the future, and I am very bullish on the future of the Grand Council.

Recommendations

I recommend the following items for consideration by the Grand Council in the near future:

- Continue with Ritual Schools of Instruction, and the promotion of Ritual Proficiencies. All Grand Council Officers and Regional Deputies should hold certificates of proficiency in Part One of the Proficiency Program. This makes it easier to promote proficiencies to members in all Regions.
- Continue with the Grand Master Coins in sets of four, as a keepsake to benefit our charities. I believe many members look forward to getting the new presiding officer's coin each year.
- Continue virtual meetings with Grand Council Officers at a minimum of once per month. Continue separate virtual meetings with Regional Deputy Grand Masters and Regional Deputy Grand Lecturers. These meetings with Regional Deputy Officers have been a productive way to educate, learn from each other, and to receive feedback about what's happening in each region.
- Continue with the Grand York Rite Pocket Directory and Monthly Calendar. This is a very handy reference that companions are able to carry with them and refer to when needed. It is very popular and well worth the expense.
- Review our financial accounts and investments, as suggested in one of our recent officer meetings, to ensure we are maximizing our return on investments. Have our investments reviewed by a financial expert for recommendations on the best ways to improve our financial condition as a Grand Council.

Appreciation

I cannot thank our Grand York Rite Office enough for their tireless efforts in the many daily functions and activities that keep our Grand Council functioning at a high level. Thanks to Most Illustrious Companion Kevin B. Sample, Grand Recorder, Illustrious Companion Russell S. Hanson, Assistant to the Grand Recorder, and Debbie L. Hanson, Executive Assistant. I do not think we actually understand the efforts they make on a daily basis in the work of the Grand Council. Their commitment to the success of the York Rite in Missouri is unmatched.

Thanks also to the RDGMs and RDGLs, who spent many hours traveling and working for the betterment of the Grand Council. Their dedication to the success of the Councils in their regions is much appreciated.

Finally, thank you to a few of my mentors, who set the example for me in my Masonic journey: Most Illustrious Companion Willie C. Woolsey, who's dedication to the York Rite as well as his guidance inspired me to follow in his footsteps; My father Luther H. Fryer, who has dedicated his life to his fraternity and his church, and is one of the main reasons I became a Mason; and Most Excellent Companion Roy L. Gilkey, who served as my Grand Chaplain these past two years, and who I admire greatly for his many years of dedication to the craft.

Conclusion

The COVID-19 Pandemic has reminded us just how fragile life is. We have lost dear friends and family members, witnessed suffering by others, as well as dealt with our own sickness and frailties. We have had to rely on the help and assistance of others, as well as assist those in need. This is what we are about, service to others. Our great charity, the Cryptic Mason Medical Research Foundation (CMMRF), is doing so many great things for those afflicted with a variety of health issues. We have no way to even realize the effect it has on so many. Let us continue to persevere in difficult times to support our charities and serve those in need.

Although new members are the future of our organizations, we must not forget our inactive members. Some of our inactive members may have no intention of ever being active. However, many become inactive due to things happening in their lives that take up their time and changes their focus. With encouragement, they may become active again when the time is right for them. We need to continue to stay in contact with them whenever we can and be aware of their needs and what we can do to help them.

We must also not forget that many members have a lot of responsibilities in addition to their activities in the York Rite. They are also active in their Blue Lodges, the Scottish Rite, the Shrine, and appendant bodies. We must ensure their time away from their family, employment, and other responsibilities is time well spent.

I sincerely believe our Grand Council is headed in the right direction. We have accomplished a number of things over the last two years, through the efforts of many. There is much more to accomplish, but our Grand Council Team is positioned to lead us into the future and accomplish even greater things. Thank you to all members of the York Rite for your service to our great fraternity.

REPORTS OF THE GRAND RECORDER

To the Grand Council of Cryptic Masons of the State of Missouri:

Companions, this was intended to be my final report as your Grand Recorder. The business partnership agreement with the Grand York Rite and presiding officers when I was requested to come back in 2014 was that I would work with RIC Hanson and Lady Debbie until their retirement this year. As of this moment in time, there has been no viable expressed interest by any Companion willing to step up and assume this awesome responsibility this year. There is one Companion in whom I have much confidence who has indicated that he might be a willing candidate in one more year. For this reason, if re-elected, I will serve one final term, but this is it.

This does not mean that I am going to fade away into my sunset years. Russell and I are willing to serve in background administrative support of the new Grand Recorder when that time comes. What I have learned over the years is that in order to do this job well, it takes much more time and commitment than I have to give. I still have a full-time job for the Department of Veterans Affairs as an Enterprise Division Chief for Data Transport Services with an ever-increasing demand of my time and attention. Moving forward, if acceptable to our officers and membership, our hope is that five (counting Debbie) can do more and better work than three. There is much to be done that remains incomplete: historical records, research projects, proceedings, grand representatives, membership cleanup, archival projects, process improvements, electronic and internet advancements, etc., that Russell and I can and are willing to work on in the background, while helping tutor and support our replacements should they desire such support. We feel this will help facilitate a much smoother transition than those experienced in past years.

There are no words to adequately express my appreciation to Russell and Debbie, they have stood me up where I have been deficient and I could not and would not be capable of performing the duties and responsibilities of Grand Recorder without each of them, they are priceless.

One serious concern I have is that there is no official process for vetting new candidates for Grand Recorder and Grand Treasurer; the process we had, albeit flawed, was removed from our laws in 2014. Now there is nothing. I feel this was a grievous error on our part and should be corrected.

There are many who say they want the job, but few that can actually perform. The office of Grand Recorder (and even more so the Clerical Assistant) is much more than an elected office of the Grand Council, this position is a salaried employee (although the salary wouldn't feed a gnat). Unless one is retired and doesn't need the money, the salary provided to both positions is prohibitive of supporting skilled professionals capable of providing the services required of the positions.

Companions, following this narrative you will find the statistical reports of the Grand Recorder's office. Although the same recommendations are made every year, again, it would be of great benefit to the grand officers and committees to actually review and study these reports as they provide much institutional information as to the overall financial and physical health of the subordinate Councils of the Grand Council of Missouri.

To all grand officers, Masters and Recorders, I highly recommend an occasional perusal of the Constitution and By-Laws of this Grand Council. I respectfully refer you to the 2019 reports of the Grand Recorder for more information on continued operational deficiencies.

The following are the reports for the last two Cryptic years.

2019 Annual Returns – Late: As of the time of this report, the following Councils filed late returns and were assessed penalties: Hiram Council No. 1; Poplar Bluff Council No. 27; Westport Council No. 38; Rolla Council No. 39; Harmony Council No. 53; and Bert S. Lee Council No. 58.

2020 Annual Returns – Late: As of the time of this report, the following Councils filed late returns and were assessed penalties: Westport Council No. 38; York Council No. 40; Trinity Council No. 47; Jeremiah Council No. 48; Lebanon Council No. 56; and Shelby Council No. 59.

2019 Annual Returns – **No Return:** As of the date of this report, the following Councils have not filed a return and will be assessed penalties: Fidelity Council No. 35. This Council Charter has since been arrested.

2020 Annual Returns – No Return: As of the date of this report, the following Councils have not filed a return and will be assessed penalties: Bert S. Lee Council No. 58. IAW SEC. 61A. Any Council not having its annual return submitted not later than thirty (30) days prior to the Annual Assembly will lose all voting

privileges at Grand Council and the Grand Recorder will hold all payments to that Council until the annual return is in and all fees paid for that year. I refer this to the Grand Officers to address.

2019 Annual Returns – Financial Statements: The following Councils either failed to submit or filed an incomplete Financial Statement: Jasper Council No. 30 (no receipts); Trenton Council No. 37; Westport Council No. 38; and East Gate Council No. 51. I refer these to the Grand Officers to address.

2020 Annual Returns – Financial Statements: The following Councils either failed to submit or filed an incomplete Financial Statement: Jasper Council No. 30 (no receipts); Trenton Council no. 37; Westport Council No. 38; York Council No. 40; Harmony Council No. 53; and Lebanon Council No. 56. I refer these to the Grand Officers to address.

2019 Annual Returns – CMMR and CEF Donations (according to the annual returns): The following Councils reported no contributions to CMMR or CEF: Hiram Council No. 1; St. Joseph Council No. 9; Shekinah Council No. 24; Jasper Council No. 30; Trenton Council No. 37; John F. Houston Council No. 42; Bonne Terre Council No. 43; Kirksville Council No. 44; Kansas City Council No. 45; Trinity Council No. 47; Independence Council No. 49; Harmony Council No. 53; Lebanon Council No. 56; and Shelby Council No. 59.

In contrast, for CMMR, Jeremiah Council No. 48 was able to contribute \$6.17 per member for each of their members. No other Council met the \$3.65 per member.

For the Grand Council Charity Endowment Fund (CEF), only 9 Councils reported contributions (up from 5 the previous year): St. Joseph Council No. 9 was able to contribute \$0.48 per member; Zabud Council No. 25 was able to contribute \$0.41 per member; Poplar Bluff Council No. 27 contributed \$1.22 per member; Ezra Council No. 32 contributed \$0.13 per member; Centralia Council No. 34 contributed \$1.47 per member; Lebanon Council No. 56 contributed \$0.48 per member; Carthage Council No. 41 contributed \$2.31 per member; and York Council No. 40 had the largest contribution of \$2.42 per member.

One item of importance to mention – CMMR and CEF donations according to Annual Return Financial Reports show total contributions of \$1,279.05 and \$655.15 respectively, however total contributions received in 2019 through our office were actually \$4,126.49 and \$647.74 respectfully. Recorders need to try to report accurately.

2020 Annual Returns – CMMR and CEF Donations (according to the annual returns): The following Councils reported no contributions to CMMR or CEF: Hiram Council No. 1; St. Joseph Council No. 9; Shekinah Council No. 24; Jasper Council No. 30; Ezra Council No. 32; Trenton Council No. 37; York Council No. 40; Carthage Council No. 41; John F. Houston Council No. 42; Bonne Terre Council No. 43; Trinity Council No. 47; Independence Council No. 49; Harmony Council No. 53; Lebanon Council No. 56; Bert S. Lee Council No. 58 and Shelby Council No. 59.

In contrast, for CMMR, Cape Council No. 20 was able to contribute \$\$1.50 per member for each of their members; Zabud Council No. 25 contributed \$0.36 per member; Poplar Bluff contributed \$0.86 per member; Centralia Council No. 34 contributed \$1.82 per member; Westport Council No. 38 contributed \$1.22 per member; Rolla Council No. 39 contributed \$0.33 per member; Kirksville Council No. 44 contributed \$0.29 per member; Kansas City Council No. 45 contributed \$0.62 per member; Neosho Council No. 46 contributed \$0.50 per member; Liberty Council No. 50 contributed \$3.02 per member; and Jeremiah Council No. 48 has the largest contribution at \$4.40 per member. No other Council met the \$3.65 per member.

Houston Council No. 42 – did not check all boxes; Bonne Terre Council No. 43 – not signed by Recorder, missing date of audit; and Jeremiah Council No. 48 – no boxes checked, only one signature for audit committee. 2019 Annual Returns – Council Indebtedness: The following Councils reported a negative cash on hand as of December 31, 2019: None.

2020 Annual Returns – Council Indebtedness: The following Councils reported a negative cash on hand as of December 31, 2020: None.

Annual Returns – Summary: Repeating from last year (nothing has changed), I would direct the Grand Officers' (as well as appropriate committees') attention to the several items in the statistical reports – Councils who report little to no Cash on Hand; no Paraphernalia value; Councils who show an indebtedness; and Councils whose dues are extremely low or even less than Grand Council per capita. Several Councils failed to record the amount of their annual dues. RDGM's should take notice of those Councils who failed to record any CMMR or CEF donations and provide education. It would appear that Recorders have forgotten (or were unaware) of the Penny-a-Day stickers our office provides for these charity donations. Finally, I would refer to the Grand Master and appropriate committees the list of Treasurers and Recorders who are not bonded, and whose Councils failed to submit an annual audit. We must start reviewing and addressing these statistical reports and what appears to be failures on the part of the Councils, although we are sure most of these items could be remediated through training and education for the officers by the appropriate Grand Councils officers.

Marion Council No. 3: I would encourage the Grand Council Officers to review the formation of this council and complete the process or repeal the law.

2019 Growth Awards: We are pleased to report that there were 53 Greetings during the 2018 reporting year. Grand Council Growth Awards will be presented to Cape Council No. 20 (5%); Neosho Council No. 46 (5%); Ezra Council No. 32 (8%); and the most going to Kansas City Council No. 45 (12%).

2020 Growth Awards: Unfortunately, there was only 1 greeting during the reporting year. No Council received a 5% growth award.

MMS: We are finally pleased to report that all our Councils are fully engaged and using MMS, either by the Council Recorder or the IT Representative designated for that purpose. Our office believes this to be one of the most significant positive changes to the Grand Council of Missouri in many years. We thank you for all your hard work.

Secretaries and IT Representatives: Although the above narrative highlights many opportunities for improvement, the operations of the Subordinate Councils in Missouri would not exist, nor, I dare say, this Grand Council, without the ultimate devotion and hard work of all of the Recorders and IT Representatives of each and every Council around this great state. They have helped improve the business processes of this office, moved us forward in managing membership records, and are even the lifeblood of their Councils. There is a very fine line between dedication and insanity, and it takes a special kind of crazy to be a fraternal Recorder. We owe each one of them our gratitude and appreciation for keeping us alive. Thank you!

Search for new Grand Recorder: It is anticipated that unless something drastic happens, I will be leaving this office in June 2022. Although it is not bound by law, I would encourage interested applicants to submit their resumes directly to me for review and referral to the appropriate grand officers. Applicants will be screened to determine an applicable skillset and capability to perform the job. Upon their successful election to office, we will work with and train the new Grand Recorder and his staff, so they are fully qualified to perform the functions of this office. It is my intention, after I retire, to fully invest the time needed to help complete all the things that remain unfinished and hopefully to work with and support whomever you select as my successor, if you will have me.

REPORT OF COMMITTEE ON FINANCE AND ACCOUNTS

To the Grand Council of Cryptic Masons of the State of Missouri:

Companions, please excuse my absence from our Annual Assembly. It falls during the time that my wife and I are celebrating our 20th Wedding Anniversary and our current location makes my attendance here today impossible.

I therefore submit the following written report on behalf of the Grand Council's Committee on Finance & Accounts which R. Ill. Companion Michael S. Smith is presenting in my absence.

The Committee on Finance & Accounts has reviewed the Grand Council budgets and actuals from recent years and used that to inform the creation of the working budget for the 2021-2022 cryptic year. The committee has reviewed each line item, and asked many questions of the Grand Recorder, Grand Treasurer, etc. The committee acknowledges that the Grand Officers and Grand Office do have to spend money in order to continue to operate in support of Cryptic Masonry in our jurisdiction. In reviewing the relevant reports from the past 10-15 years, the committee believes that the Grand Officers, Grand Office, and former members of the Committee on Finance & Accounts are to be commended for their diligence in reviewing expenses and making cuts where necessary.

We applaud the actions of the Companions of this Grand Council in supporting per capita increases in 2008 and 2016. These forward-looking actions have enabled your Grand Council to remain financially solvent with a shrinking membership and during multiple economic downturns. After reviewing our investments, income, and expenses it is clear that it is again time for us to increase our per capita to stay ahead of the effects of decreasing membership and inflation. There will be relevant legislation presented at the next Annual Assembly and the committee strongly urges your support so that the Grand Council can continue to operate in the black and to provide programs in support of the constituent councils.

The committee recommends the following actions:

- 1. The creation of an Investment Advisory Committee composed of qualified Companions of this Grand Council.
- 2. The Investment Advisory Committee to be charged with an annual review of our investments in cooperation with an outside investment advisor who has no financial interest in our investments or their management. Recommended changes shall be presented to the Finance & Accounts Committee for their review & approval and then presented to the Grand Council for their approval.
- 3. The Investment Advisory Committee shall review relevant sections of the Grand Council Constitution and By-laws (e.g., Article II, Section 13, Paragraph 7) and in conjunction with the Finance & Accounts Committee draft proposed amendments to support any proposed changes to our investment strategy. These proposed amendments will be subject to the review of the Jurisprudence Committee and approval of the Grand Council.

LEGISLATION FOR ACTION AT THE 2021 GRAND COUNCIL ASSEMBLY

Proposal No. 1 consists of proposed amendments to four Articles and four Sections of the by-laws. Since they are wording changes of a simple and collective nature, unless there is an objection, they will be voted upon collectively.

PROPOSAL No. 1

PROPOSAL TO AMEND THE BY-LAWS OF THE GRAND COUNCIL OF CRYTIC MASONS OF THE STTE OF MISSOURI TO READ AS FOLLOWS:

ARTICLE III. SEC. 17. *Grand Council, Committees.* The Chairman of the following Standing Committees shall be appointed by the Grand Master immediately after his installation:

- 1. Credentials
- 2. Reports of Grand Officers
- 3. Jurisprudence
- 4. Finance and Accounts
- 5. Returns of Councils
- 6. Mileage and Per Diem (*Deleted 5/8/98*)
- 7. Fraternal Correspondence
- 8. Youth and Membership (Added 5/12/86)
- 9. Time & Place (*Added 5/12/10*)
- 10. Audit Inquiry & Examination Committee (Added 5/13/15)

SEC. 18. Standing Committees, Duties of. (4) The Committee on Finance and Accounts shall examine the financial statements of the Grand Treasurer and Grand Recorder together with the report of the Auditor Examiner and report upon the same. It shall also report upon all matters touching the finances of the Grand Council, and no appropriation shall be made without having been considered and reported upon by this committee. The fiscal year of the Grand Council shall end May 31st of each year. (Amended 5/15/03)

In addition, in the event of the death or disability of either the Grand Treasurer or Grand Recorder, the Finance and Accounts Committee together with the concurrence of the Grand Master shall have the authority to remove all ledgers and financial records and shall retain a qualified auditor Examiner not previously involved who shall perform a complete audit examination of such records. These actions shall be conducted with expediency so as not to interfere with operations of the office. (Added 5/2/97)

(10) The Committee on Audit Inquiry and Examination shall conduct an annual audit examination of

the Administrative and Financial records of the Grand Council and report to the Grand Master and the Annual Grand Assembly of the Grand Council. This Committee has the authority to contract with accounting professionals for the performance of a triennial fiscal or tax audit review.

ARTICLE VI., Chartered Councils, SEC. 61. Annual Returns. On or before December 31st each year, Council Recorders will submit to the Grand Recorder a complete list of remissions for their Council to include the member's full name and type of remission in accordance with Section 106. Dues, Remission. On or before February 1st each year the Grand Recorder will provide a Masonic Membership Solutions (MMS) statistical report for the previous reporting year along with a bill for the calculated fees due the Grand Council. The bill will include appropriate fees and credits. Fees shall consist of Greeting Fees, Per Capita and any outstanding balances from the previous year's return. Credits shall consist of approved Remissions, Endowed Memberships and General Grand Council Life Memberships as verified by the Grand Recorder, along with any overpayments from the previous year's return. A Financial Report Form and an Annual Audit Inquiry and Examination Committee Report Form (see Section 61B. Annual Audit Inquiry and Examination) will also be included as part of the Annual Return. All forms shall be forwarded to the Grand Recorder with a copy of the latest IRS Form 990 or a copy of the acceptance of the electronic submission of a Form 990N, no later than the first day of March of each year. Failure to make such return as provided shall subject the Council to a fine of twenty-five dollars (\$25.00) dollars for each period of thirty days, or fraction thereof, said return in withheld. (Amended 5/2/97, 6/7/17, 7/8/18)

SEC. 61B. Annual Audit. There shall be a complete and careful audit examination of the financial affairs of each subordinate council and of the books, accounts, and vouchers of the Recorder and Treasurer and of others handling, and having a charge, money or property of the council. Such audit examination shall cover the period from the last previous audit examination up to and including the thirty-first day of December of each year.

Upon his election, or as soon thereafter as is possible, the Master-elect shall appoint an auditing Inquiry and Examination e Committee of three or more members, whose duty it shall be forthwith to audit examine the books and accounts and vouchers of the Treasurer and Recorder of the council. If the council has trustees, or other custodians of property or funds, then their books, accounts, and vouchers shall also be auditied examined, and the securities or other property checked, inspected, etc. The books, accounts and vouchers of any other officer, member or committee may also be designated by the Master-elect and may be subject to an audit examination.

The Master-elect, may in lieu of an auditing Inquiry and Examination e Committee designate any certified public accountant or firm of certified public accountants to make the a final audit, provided that the certified accountant or firm of certified public accountants or member of a firm of the same is not related by blood or marriage to the outgoing Master, Recorder, or Treasurer.

The report of audit the Inquiry and Examination Committee shall be in duplicate, in writing, and be signed by the Audit Inquiry and Examination Committee or the C.P.A., or firm of C.P.A.'s who made the inquiry and examination or audit.

One copy of the report shall be delivered forthwith to the Master-elect, who shall see that the same is presented to and read in open council at the next stated assembly following its date and be spread upon the records thereof; and other copy shall be transmitted to or filed with the Grand Recorder on or before the first day of March (that being the date for the transmittal to or filing with the Grand Recorder of the annual returns of the council).

All of the actions contemplated herein shall be performed with a view to having the audit inquiry and examination completed and the report made prior to the first day of March in each year.

Said report of <u>audit</u> <u>inquiry and examination</u> shall be made upon standard printed forms provided by the Grand Recorder, but nothing contained in or omitted from such printed forms shall relieve the <u>auditing Inquiry and Examination</u> e Committee or C.P.A., from reporting fully and completely their findings in the premises. (*Added 7/8/18*)

STATEMENT OF PURPOSE: Companions, the proposed changes have been submitted and recommended because the Internal Revenue Service of the United States of America, has in recent years demeaned and viewed that Auditor and audit can only be done by an authorized Certified Accountant or firm that handles such matters.

This makes it risky and could inspire an inquiry or examination of our fraternity by the federal government into our operations. This is to eliminate such an occurrence from happening.

Whenever a member shall fail to pay his dues at the time when the same become due and payable, as fixed by the By-Laws of the Grand Council, it shall be the duty of the Recorder to notify him of such delinquency by delivering to him, in person, a bill for such indebtedness, or by mailing the same in a sealed envelope, addressed to him at his present or last known place of residence; should the delinquent refuse or fail to pay his dues within twenty days after the issuance of such notice, it shall be the duty of the Recorder to notify the Master of such failure, who shall at the next stated Assembly of the Council order a notice to be given the delinquent by the Recorder, requiring him to appear at a specified subsequent stated Assembly, to show cause why he should not be suspended for non-payment of dues.

A companion remaining in arrears for more than one year after suspension for non-payment of dues may be restored to membership by making written application, payment of one years dues and receiving a 2/3 favorable vote by paper ballot. (Amended 5/6/94)

To:

SEC. 111. Dues, Non-Payment of. Whenever a member fails to pay his dues on or before March 1 of each year, the recorder must notify the member in writing of his delinquency on or before March 11. If, after notice, the member fails to pay his dues on or before April 1, he is automatically suspended for non-payment of dues. The suspension should be recorded by the recorder in the minutes of the first meeting of the council thereafter. See SEC 141A. Duties of Council Recorders and of the Grand Recorder.

A companion remaining in arrears for more than one year after suspension for non-payment of dues may be restored to membership by making written application, payment of one years dues and receiving a 2/3 favorable vote by paper ballot. (Amended 5/6/94)

STATEMENT OF PURPOSE: A Companion's dues should be paid by December 31st of each year. The length of time a Companion has to pay his dues is longer than necessary. Shortening the time to pay dues will make the Secretary's job easier, and give each Chapter better control over their finances and budgets, and matches Grand Lodge of Missouri dues payment bylaws.

REPORTS OF SPECIAL COMMITTEES 2020-2021 REPORT OF AUDIT COMMITTEE

To the Grand Council of Cryptic Masons of the State of Missouri:

Companions, in the 2014 Audit report, IC Robert Schlichter brought up the possible confusion with the title of this committee and the perception that an audit had been performed by an audit firm and conducted in accordance with AICPA accounting board standards. In that report he suggested that the name should be changed to more properly describe the extent of the examination being performed. We are pleased to see that there is proposed legislation to change the title of this committee which is charged with verifying and confirming the compliance of the Grand Council with its by-laws and that proper and adequate processes are in place to minimize the possibility of either non-compliance or malfeasance. The proposers have adequately explained the reason for the change in their "statement of purpose".

Due to the abbreviated Grand York Rite session and the decisions that had to be made on almost a daily basis leading up to last year's session, the audit committee was unable to complete their assigned task. Therefore, part of this year's review included going back an additional year in the records and tracing selected financial transactions from the creation of the obligation or event, through each step of the process, until the obligation or event was satisfied or completed. The process developed by the Grand Recorder and Grand Treasurer is extremely detailed with all warrants issued, invoices scanned and made a part of the record, budgets and proceedings checked to make sure it was properly authorized, and checks issued and then verified as clearing with bank by reconciliations performed. In all cases, no deviation from established processes were noted.

The Grand Council officers who compose this committee have been given unfettered access to and attendance at the regular WebEx financial meetings conducted by the Grand Recorder, Grand Treasurer and RIC Hanson. Detailed financial transactions are discussed in these meetings and any concerns or questions may be expressed by anyone on this meeting. Based on this and the results of the sample transactions traced during the examination of the records, the committee can express confidence that the records as shown in the preliminary reports properly reflect an accurate accounting of the transactions and balances of the Grand Council of Cryptic Masons for the preceding 2 years.

Recommendations:

- 1. That a "final" Grand Treasurer's financial report be issued as of the close of the fiscal year and distributed to appropriate individuals and committees. Since the preliminary report published for the Grand York Rite session usually is an interim report due to the timing of statements and reconciliation, there is a gap between what was shown in the interim report and the previous years beginning balance. It can be difficult to account for the difference in the preliminary report ending balance and the beginning balance for the next year.
- 2. That an investment committee be created for the purpose of developing investment strategies which would maximize returns and yet maintain adequate safety measures. We realize that the funds entrusted to us creates a fiduciary responsibility which cannot be ignored. However, the strategy could include appropriate mixes of treasury's, bonds and equity positions to increase our investment revenues and contribute to the overall revenue stream. This committee would create the investment policy in consultation with a qualified investment advisory company and the Grand Council Finance and Budget committee as well as the advancing line.

3. That the financial statements from the investments held at investment firms be included in the regular financial reports for review by the Grand Council officers and that a second person be given access rights to make transfers and access to the account.

In conclusion, the committee found the records to be extremely detailed, that there were adequate controls and safeguards in place to establish discovery of any errors or malfeasance.

The committee would like to commend the Grand Recorder and Grand Treasurer for their cooperation during this process and their attention to detail.

2019-2020 REPORT OF COMMITTEE ON CHARITY AND CHARITY ENDOWMENT FUND

To the Grand Council Cryptic Masons of the State of Missouri:

Companions, for those who have some reverence for history, it should be noted that this Committee hearkens back to a time when the Grand Council of Missouri annually submitted to the Cryptic Masons Medical Research Foundation (CMMRF) donations over \$15,000. This was inclusive of donations sent directly to CMMRF by generous members and the ingenious Pick 3 Calendar Book sales. The efforts were spearheaded by great leaders like MIC Robert Bray and MIC William J. Bowser. Both of those great lights have passed on to the realm beyond the Ninth Arch. The Pick 3 Calendar program was essentially abandoned and there is no true "endowment" of our premiere York Rite charity. It is time to make changes.

First, we need a State Chairman for CMMRF. Second, that State Chairman needs to coordinate efforts in all Missouri Councils and work with CMMRF leadership and staff to bring our donations and donators the recognition that is justly deserved.

Third, we need to establish a Missouri Nonprofit Corporation with all the tax deductibility and responsibilities of a 501(c)3 IRS-regulated entity. All charitable donations raised by local Councils should be directed to the 501(c)3. Ideally, the Grand Council (a 501(c)10 entity) could be the owner or manager of this Nonprofit Corporation. Why has this not been done in the past, you may ask? There are no good reasons: Things like, well, who will control such a charitable corporation? Who will be on its Board of Directors? While I concur that we should be cautious in how we manage our charitable endeavors, I think that we have avoided doing the right thing in favor of rhetoric and delay. In other words, as Masons, we have not taken the time to make the effort to do what should have been done over 40 years ago because we worry about control rather than the wellbeing of our charity.

Another contention against a separate charitable corporation was that the Grand Council needed to justify its tax-exempt status by accumulating charitable donations in Grand Council investment accounts. This is rubbish. The Grand Council can justify its tax-exempt status by being a Masonic entity and any donations that it receives can be paid over to our Missouri charitable corporation.

The General Grand Chapter of Royal Arch Masons has recently received IRS recognition of a 501(c)3 Educational Foundation. Missouri York Rite entities should follow this lead and authorize the creation of a York Rite nonprofit corporation as soon as possible.

Fortunately, the first two items have already been accomplished under the leadership of our Grand Council Officers. Now, let's take the next step.

Companions, it should be noted that an Endowed Membership in the General Grand Council is available at a cost to any member for the sum of \$65.00 ($$62.50 = 25 \times 2.50 annual per capita plus current year's per capita of \$2.50). The General Grand Chapter of Royal Arch Masons requires \$100.00 for an Endowed Membership even though the current annual per capita rate is \$3.00 for US Grand Chapter members. Every Missouri Council member who purchases a General Grand Council Endowed Membership helps reduce annual dues by \$2.50 for himself, his local Council and the Grand Council.
