BIOGRAPHY OF THE GRAND HIGH PRIEST

Most Excellent Companion Kyle R. Palacios was born December 9, 1958, in St. Louis, Missouri to Josè and Selma Palacios. Theirs being a blended family, he is one of nine boys and a girl.

His Masonic career started in 1971 two weeks after his 13th birthday when he was initiated into Gardenville DeMolay. The first in his family to make the journey, he was followed by his brother Gene and ultimately by his father who was exalted into Gardenville Lodge No. 655 in 1975. That same year he became Master Councilor.

DeMolay introduced him to Yvette Relich, a Rainbow Girl, whom he married in 1985. They will celebrate 37 years in just a couple of weeks. They had their daughter Cassidy in 1992 who is now an LMSW. In 2020 they added their rescue kitten Laney.

DeMolay set the stage for leadership for the rest of his life. He found himself in a management position at every job he's held. Very successful in sales positions, he ultimately landed in the entrepreneurial world.

He and his brother Gene had a side business as mobile disc jockeys for weddings and parties. He and his wife opened a shoe store in 1987, but ultimately his calling came in 1998 when his eldest brother Joseph, introduced him to the world of Voice Broadcasting: taking one pre-recorded message and calling an unlimited number of recipients.

In 2002, they launched their own business called GroupCast with an emphasis on school communications and soon were assisting schools in all fifty states with mass communications. They designed an anti-bully tip-line to assist schools in eliminating bullying. They were also responsible for product recalls from America's largest companies like Costco, so if you received a call recalling bad peanut butter about 15 years ago, that was Kyle's voice telling you not to eat it!

Your Grand High Priest's hobby for most of his life has been entertaining as a singer in numerous rock and roll bands culminating with a magazine cover in 2000 about musicians that work in IT and play clubs at night. He also has recordings available for the asking.

Currently, his life revolves around his five-point starfish – his family, his work, his Masonic life, his music and his alma mater, Affton High School, where he was inducted into their Hall of Fame in 2014 and shares that honor with the likes of Actor John Goodman. He is now serving as Vice President of the Affton Education Foundation, and they hold fund raisers to provide college scholarships to students and teacher grants to assist the faculty in the Affton School District.

In 1999, Kyle was raised to the sublime degree of Master Mason at the first Chance to Advance Class held by MWB Wilfred G. Soutiea, Jr. Over 500 new Masons were raised that day. MEC José Palacios, then the Grand King of the Grand Chapter raised him, also present were MEC James Miller and MEC Harry Maenner. A premonition of future endeavors?

A member of Gardenville Lodge which a few months later merged with Cache Lodge to form Gardenville-Cache No. 455, he served as Master in 2002-2003 and again in 2009.

A member of Keystone Chapter No. 146 Royal Arch Masons, he served as High Priest in 2009-2010. He is also a member of Jeremiah Council No. 48 and Ascalon Commandery No. 16.

His Masonic career is punctuated with being a Past Excellent Chief of Limmerick Council No. 88 Knight Masons; Past Sovereign Master of Ray V. Denslow Council No. 102 Allied Masonic Degrees; Past Puissant Sovereign of St. Louis Conclave of Red Cross of Constantine; a member of Court of Discovery No. 80, Masonic Order of Athelstan; a member of Bruce Harmon Hunt York Rite College No. 162; the Missouri Ambassador for the General Grand Royal Arch Masons International, 2017-2020; the Grand Sword Bearer for MWB David Haywood in 2015; and various appointments to committees.

In 2015 he was elected to the Grand Line of the Grand Chapter of Royal Arch Masons of the State of Missouri, which eventually led to this published bio!

His time in the Grand Chapter has been the jewel of his Masonic career...so far.

We mourn the passing of our Companion York Rite Masons across this great state whom our Lord has called to their eternal home. They have been our friends and brothers. We offer our prayers for the comfort of their families—the comfort that only our God can provide. In our meetings we will keep our memory of them alive. We give thanks to our God for their friendship, fellowship, companionship, and their brotherhood with us.

In the year since our last Grand York Rite sessions, we have lost 112 York Rite Masons across the state. All of these companions and Sir Knights deserve our heartfelt tribute if time would permit. In noting the passing of the following leaders, we also honor all of them.

Most Excellent Grand High Priest, during your time of leadership, we have lost three of those who have served before you as Grand High Priests:

MEC Frank P. Wilfley who led this Grand Chapter in 1990-1991. He was one of our senior Past Grand High Priests.

MEC Christopher Columbus "C.C," McLemore Grand High Priest, 2010-2011

MEC Ronald L. Barrett our Grand High Priest in 2017-2018.

We are deeply saddened at the passing of Lady Margaret Bean, the wife of our Grand Scribe Mark Bean. It is the love and support of our wives that make what we do as Freemasons possible. Their love encourages us. Their love and good counsel help to guide us. Behind those who have led in Masonry, there have been our wives who have been our strength.

It was during your tenure, Most Excellent Grand High Priest, that Rev. Louis C. Odneal was called home to be with his Lord. He was a four-star Grand Chaplain having served as Grand Chaplain of the Grand Lodge of Missouri and as Grand Chaplain of all three York Rite bodies of Missouri.

We also note the passing of Rev. Ronald E. Wood, Jr. who also held the distinction of being a four-star Grand Chaplain. He was a Mason of national and international renown.

This year we lost the Senior Past Grand Master of Cryptic Masons of Missouri, Most Illustrious Companion Everette L. Gloyd, Grand Master of Cryptic Masons of Missouri, 1978-1979.

We also lost Former First Lady of Cryptic Masons of Missouri, Lady Johnnie Brown, wife of MIC Stanton T. Brown, 2004-2005 and mother of MWB Stanton T. Brown II, Past Grand Master of the Grand Lodge of Freemasons AF & AM of Missouri.

We also note the passing of two Grand Commanders of Knights Templar of Missouri since our last necrology report: RE Sir Knight Jerry F. Ward, Grand Commander in 1990-1991 and RE Sir Knight James E. Snavely, Grand Commander in 2005-2006. At the time if his passing, RE Sir Knight Ward was our senior Past Grand Commander.

WHEREAS, that opportunity is comprised of an Invitation from the Grand Master to all Master Masons within his jurisdiction to receive the Mark Master and Past Master Degrees under the supervision of the Grand Chapter of Royal Arch Masons of the State of Missouri;

THEREFORE, the Grand High Priest shall designate Chapters within his jurisdiction, including any Chapters determined by the Grand High Priest to be deemed to be under the auspices of Missouri Chapter No. 0, consistent with Section 159K of the By-Laws of the Grand Chapter of Missouri, with the authority to undertake the Special Conferral of these Degrees at no initial cost to any invited Master Mason; and,

FURTHER, that any invited Master Mason who receives the Mark Master and Past Master Degrees as part of the Special Conferral shall be eligible to receive the Most Excellent Master and Royal Arch Degrees in due course, upon tendering of all of the requisite fees and a completed petition to the designated Chapter.

In addition, if the Chapter that holds the award cannot officially open, the visiting Chapter cannot claim the Keystone. In order to claim the points on the Distinguished Chapter Award application, a document signed by the High Priest and Secretary attesting that the trophy was retrieved shall be given. This receipt shall include the name of the visiting Chapter, date the visit was made,

REPORTS OF THE GRAND SECRETARY

To the Grand Chapter of Royal Arch Masons of the State of Missouri,

Companions, following this narrative you will find the statistical reports of the Grand Secretary's office. Although the same recommendations are made every year, again, it would be of great benefit to the grand officers and committees to actually review and study these reports as they provide much institutional information as to the overall financial and physical health of the subordinate Chapters of the Grand Chapter of Missouri.

Annual Returns – Late: As of the time of this report, the following Chapters filed late returns and were assessed penalties: Bolivar Chapter No. 5; Bellefontaine Chapter No. 25; Kansas City Chapter No. 28; Rolla Chapter No. 32; Jefferson City Chapter No. 34; Lebanon Chapter No. 64; Triune Chapter No. 93; Orient Chapter No. 102; Poplar Bluff Chapter No. 114; and Keystone Chapter No. 146.

Annual Returns - No Return: None

Annual Returns – Not Received thirty days prior to Annual Convocation: As of the date of this report, the following Chapter filed an annual return, but not later than thirty (30) days prior to the Annual Convocation, has forfeited all rights and privileges to representation and voting at the Annual Convocation, and will be assessed penalties: None.

Annual Returns – Financial Statements: The following Chapters either failed to submit or filed an incomplete Financial Statement, and in one case was completely unintelligible: Greenfield Chapter No. 38; and Putnam Chapter No. 123.

Annual Returns – RARA Donations (according to the annual returns): The following Chapters reported no contributions to RARA. It is suspected they are not adhering to the Grand Chapter By-Laws, Article IX, Revenues of the Grand Chapter, Section 40. Annual Dues, Paragraph B, or they are receiving donations and not forwarding them to the Grand Chapter, or they are forwarding them to the Grand Chapter but not keeping accurate financial records of income and disbursements as detailed in the Annual Financial Reports included with the Annual Return, all of which I refer to the Grand Officers to address: Bolivar Chapter No. 5; Hannibal Chapter No. 7; Lexington Chapter No. 10; Bellefontaine Chapter No. 25; Kansas City Chapter No. 28; Greenfield Chapter No. 38; Meridian Sun Chapter No. 61; Wilson Chapter No. 75; Bethany Chapter No. 80, and Uel Chapter No. 129.

In contrast, St. Charles Chapter No. 1 was able to contribute \$5.33 per member for each of their members; Independence Chapter No. 12 contributed \$4.35 per member; Lebanon Chapter No. 64 contributed #3.38 per member; and Triune Chapter No. 93 once again had the largest contribution of \$6.25 per member for each of their members and had the largest total contribution from all the Chapters.

One item of importance to mention -2021 RARA donations according to Annual Return Financial Reports show total contributions for the reporting year of \$2,496.64. However total contributions received through our office in the 2021 fiscal year were actually \$3,049.52. Secretaries need to try to report more accurately and examiners need to pay closer attention to what they are looking at.

Annual Returns – Bonding: The following Chapters reported that the Treasurer and Secretary are NOT bonded: Columbia Chapter No. 17; Bellefontaine Chapter No. 25; Rolla Chapter No. 32; Jefferson City Chapter No. 34; Greenfield Chapter No. 38; Wyoming Chapter No. 43; Tyrian Chapter No. 52; Caldwell Chapter No. 53; Nevada Chapter No. 56; Meridian Sun Chapter No. 61; Lebanon Chapter No. 64; Wilson Chapter No. 75; Oriental-Rabboni Chapter No. 78; Bethany Chapter No. 80; Joplin Chapter No. 91; Triune Chapter No. 93; Shelbina Chapter No. 99; Orient Chapter No. 102; Poplar Bluff Chapter No. 114; Putnam Chapter No. 123; and Keystone Chapter No. 146. Although there is no requirement by law that bonds be established, there is a necessity of ensuring the organizational officers who are responsible for your financial health are bonded.

Annual Returns – Inquiries and Examination of Accounts (*Financial Reviews*): The following Chapters did not file an Inquiry and Examination of Accounts as part of their Annual Return or if they did file an Inquiry and Examination of Accounts, it was incomplete: Lexington Chapter No. 10 – not dated; Greenfield Chapter No. 38 – incomplete; Lebanon Chapter No. 64 – missing HP signature; Keystone Chapter No. 146 – only one committeeman name/signature.

Many reports did not have the seal applied – it is a requirement of this document to provide evidentiary proof that the Chapter Secretary is in possession of the Chapter seal.

I refer all of the above to the Grand Officers to address.

Annual Returns - Signatories: The following Chapters report that there is <u>not</u> more than one signatory on the accounts of the Chapter: Greenfield Chapter No. 38; Oriental-Rabboni Chapter No. 78; Bethany Chapter No. 80; and Keystone Chapter No. 146. **This failure is an extremely high risk to the Chapter.** I refer these to the Grand Officers to address.

Annual Returns – Dues: The following Chapters reported dues charged each member to be less than that required by Grand Chapter (\$35.60): None.

Annual Returns – 990 Status: The following Chapters did not file evidence of a completed 990 filing: Hannibal Chapter No. 7; Jefferson City Chapter No. 34; Bethany Chapter No. 80 –Shelbina Chapter No. 99. I refer these to the Grand Officers to address.

Annual Returns – Chapter Indebtedness: The following Chapters reported a negative cash on hand as of December 31, 2021: Oriental-Rabboni Chapter No. 78. I refer this to the Grand Officers to address.

Annual Returns – Summary: Repeating from previous years, again, (nothing has changed). I would direct the Grand Officers' (as well as appropriate committees') attention to the several items in the written reports above and the statistical reports below – Chapters who report little to no Cash on Hand; no Paraphernalia value; and Chapters who show an indebtedness. DDGHP's should take notice of those Chapters who failed to record any RARA donations and provide education. Any Chapter having only one signature on Chapter accounts is a critical failure of local leadership and audit committees. Finally, I would refer to the Grand High Priest and appropriate committees the list of Treasurers and Secretaries who are not bonded, and whose Chapters failed to submit an annual audit. We must start reviewing and addressing these statistical reports and what appears to be failures on the part of the Chapters, although we are sure most of these items could be remediated through training, education, and accurate reporting of the subordinate officers by the appropriate Grand Chapter officers.

Growth Awards: There were only 36 Exaltations during the 2021 reporting year after things started to pick up after the reactivations of the Chapters following the pandemic. A Grand Chapter Growth Award will be presented to Hannibal Chapter No. 7 (9%), the smallest Chapter in the state who gained one Affiliation during the year increasing their membership from 11 to 12; Lebanon Chapter No. 64 (8%) who Exalted 8 new members; and the highest growth award goes to Kansas City Chapter No. 28 (12%) who Exalted 5 new members and reinstated 1. No other Chapter met the 5% growth minimum, consolidations excluded.

MMS: We feel all of the Chapters are fully engaged and using MMS, either by the Chapter Secretary or the IT Representative designated for that purpose.

Secretaries and IT Representatives: Although the above narrative highlights many opportunities for improvement, the operations of the Subordinate Chapters in Missouri would not exist, nor, I dare say, this Grand Chapter, without the ultimate devotion and hard work of all of the Secretaries and IT Representatives of each and every Chapter around this great state. They have helped improve the business processes of this office, moved us forward in managing membership records, and are even the lifeblood of their Chapters. There is a very fine line between dedication and insanity, and it takes a special kind of crazy to be a fraternal Secretary. We owe each one of them our gratitude and appreciation for keeping us alive. Thank you!

Search for new Grand Secretary: See Report of Search Committee.

Final Report: Companions, this will be my final report as your Grand Secretary. In 2001, being in the Grand Council line and having advanced to Grand Captain of the Guard at that point in time, I realized something about myself that I hope all can learn from. Not all of us are cut out to be local presiding officers, or regional officers, or even presiding grand officers, let alone be good at any of them. Not all of us are ritualists or good with managing money. It is incumbent upon each of us in this fraternity to recognize our strengths and weaknesses as servants of and to the craft. I knew early on that I could be a good Secretary – I very much enjoyed the work, and there was much to be done. I will go so far to say that as an advancing grand officer, I was critical of the lack of information available to grand line officers – there was this sort of need-to-know mentality that I found most unproductive and unfortunate, especially for someone in training to preside over a state grand body and expected to know what was going on. There was an historical attitude that the Grand Secretary/Grand Recorder's office only shared with grand line officers and even presiding grand officers what they felt was needed to know at any point in time. There appeared to be a lack of transparency with regard to the exercise and implementation of the laws of the grand bodies and there was even a same lack of transparency with regard to the financial health of the bodies. This was unacceptable to me, and I fought for change for several years.

Finally, through the support of past and present Grand York Rite leadership, names like MEC Jose R. Palacios, MEC Robert W. Schlichter, MIC William J. Bowser, MIC Stanton T. Brown, SK Thomas C. Yunick and many others, I was elected Grand Secretary/Recorder of all three Grand York Rite bodies in Missouri.

Actually, that was the easy part.

Now came the call to action – now that I caught this truck, what was I going to do with it. Through hard work and dedication and with the help of my Lady Joyce and many like REC Russell S. Hanson and his Lady Debbie, and some really awesome presiding grand officers, "we" started in small bites, improving those things we felt needed attention. Remember, in those days we barely used email, had no membership database, no web site, no forms and templates, scripts or agendas, the list goes on and on.

I am only the 12th in succession of Grand Secretaries since the formation of the Grand Chapter of Missouri, following:

Fred L. Billon who served from 1846-1848 and died in office

George Myers who served one term in 1849

John D. Taylor who served from 1850-1853 and died in office

Anthony O'Sullivan who served from 1853-1866 and died in office

George Frank Gouley who served from 1866-1876 and died in office

John W. Luke who served from 1876-1877 and died in office

William H. Mayo who served from 1877-1904

Robert F. Stevenson who served from 1905-1922 and died in office

Ray V. Denslow who served from 1922-1960 and died in office

Bruce H. Hunt who served from 1960-1995 and died in office

Ronald E. Wood, Jr. who served from 1995-2001

In 2009 I resigned from office due to personal challenges which could not be resolved. REC Frederick A. Troxel, Jr. graciously took over and served from 2009-2010, REC Russell S. Hanson served from 2010-2014, until I was requested to resume my service in 2014, through to this very day. It was my sincere intent and personal goal to not die in office. If I have made it to this Annual Convocation, then I have met that singular achievement.

The list of improvements I feel we have made over the past 21 years is actually quite long and impressive, even if I am the only one who believes it, but not worth mentioning here. Suffice it to say, Russell and I continue, and will continue as long as we are able, to work towards making the Grand York Rite of Missouri the best possible version of itself.

As was reported last year, and I feel worth reporting again, this does not mean that I am going to fade away. Russell and I are willing to serve in background administrative support of the new Grand Secretary. Moving forward, if acceptable to our officers and membership. Our hope is that five (counting Debbie) can do more and better work than two or three. There is much to be done that remains incomplete: historical records, research projects, proceedings, grand representatives, membership cleanup, archival projects, process improvements, electronic and internet advancements, etc., that Russell and I can and are willing to work on in the background, while helping tutor and support our replacements should they desire such support.

As was additionally reported last year, there is no official process for vetting new candidates for Grand Secretary and Grand Treasurer. The process we had, albeit flawed, was removed from our laws in 2014. Now there is nothing. I feel this was a grievous error on our part and should be corrected.

Again, and worth repeating, there are no words to adequately express my sincere appreciation to Russell and Debbie Hanson, they have stood me up where I have been deficient and I could not and would not be capable of performing the duties and responsibilities of Grand Secretary without each of them, they are priceless.

Although I cannot hold a candle to the likes of many, if not all of my predecessors, I hope and pray that I have served our Grand Chapter well and have made a positive difference in Missouri Capitular Freemasonry.

REPORT OF COMMITTEE ON INVESTMENTS

To the Grand Chapter Royal Arch Masons of the State of Missouri,

Companions, the Investment Committee evolved out of work as part of the Finance Committee. Instead of reviewing the returns in general, the Investment Committee is charged with examining the management of surplus assets, and to offer recommendations to improve the process, and overall returns.

This year's findings focus on three components: Preliminary/Final reporting; responsibility for allocations; and actual fund allocations.

PRLIMINARY/FINAL REPORTS ANALYSIS

Based on the timing of the Grand Session versus our actual fiscal year, preliminary Grand Treasurer reports are presented at the Grand Session and included in the Preliminary Proceedings. These reports contain only 10 months of financial information. A final report covering all 12 months should be provided once the fiscal year closes.

The investment committee has not received any final annual reports. Any analysis done using the "preliminary report" is incomplete and makes it difficult, if not impossible to determine actual annual returns and results.

Recommendation: A final Grand Treasurer's report be made available to the Finance and Investment Committees within 45 days of the close of the Fiscal year.

ALOCATION OF SURPLUS FUNDS

Article IX, Section 44 of our bylaws give guidelines for investment allocations. Historically, most masonic bodies were restricted to investing funds in traditional interest-bearing investments such as Certificates of Deposits (CDs) or bonds backed by the Federal Government. While these rates of returns had at one time been significant, they were no longer at the high levels seen in the 1980s. As a result, at the turn of the last century, Chapter bylaws were revised to allow moving from 100 percent of surplus funds in CDs and Bonds, to now permit up to 50 percent of surplus funds to be used to create a long-term growth strategy to maximize overall returns by investing in "highly rated stocks and mutual funds."

This year, 49% of the surplus funds (General Fund and Endowment Fund) have been placed in mutual funds. This is good. However, an opportunity may lie with the types of funds chosen. Mutual funds selected ideally would be primarily comprised of growth investments. Some of the mutual funds currently selected are heavily weighted towards the fixed income objective. Remember that over 50% of surplus funds are already in these types of investments, by way of CDs and bonds. This defeats the earlier purpose of the bylaws change to take advantage of growth opportunities.

Recommendation: Those charged with investing the surplus funds meet with the Financial Advisor managing the surplus funds to determine and develop a strategy that will effectively maximize growth while also preserving principal.

RESPONSIBILITY FOR ALLOCATING SURPLUS FUNDS

Section 44 states that "the Grand Treasurer, Grand Secretary, and the Committee on Finance" are authorized to invest any surplus funds. That is eight people elected to manage the financial affairs of the Chapter. Besides being too large of a number charged with making the allocation decision, what is important to remember is that these eight may be sound leaders, administrators, and ritualists, but they may have NO experience in the field of finance and investments.

Section 44 also does not state who has final decision-making authority on investing surplus funds. Over the years, this responsibility has fallen to the Grand Treasurer alone to make these decisions. This is an undue amount of responsibility for one person.

Recommendation: Section 44 needs revision as to who has FINAL decision-making authority, and this authority needs to lie with those who have expertise in this field, much like the Jurisprudence Committee is structured.

The task of determining a suitable long-term strategy for fund management is complicated and much different than managing an individual portfolio. Our Chapter has talented companions who have spent decades in this field, including Financial Advisors and others who have managed hundreds of millions of dollars. Legislation should be put forward that an Investment Policy Committee of three members be created, who working through a FINRA licensed Financial Analyst, will determine the investment strategy for the three bodies of the York Rite

The Grand Chapter was very well represented – there were more "red coats" than any other in the building that day. VEC Riepe gave a rousing talk as part of the education of the day. The Region 7 meeting was held on the 20th Anniversary of 9-11. M:E:C: Kyle Palacios gave a heartfelt and passionate remembrance of that day in his life as did others over the course of the Chapter portion of the meeting. This meeting will be remembered not only for the anniversary, but also because the Region 7 organizers, along with M:E:C: Palacios, arranged for the introduction of the Grand Chapter officers to be made like they were the starting lineup of a major league baseball team while Sammy Hagar played "Red" in the background. It was well received, and the remainder of the meeting was lively and entertaining. The Region 1 and 4 Conference gave me the opportunity to exemplify parts of ritual, mainly the grips and signs and it was an honor to learn from and to teach the Companions in attendance.

The Grand Master's Breakfast and Interfaith Service was very well attended by members from across the state and I had the privilege of attending, accompanied by VEC Kevin Ritter. The guest speaker presented information on Missouri's contribution to the building and maintenance of the George Washington Memorial. Later that day VEC Ritter and I attended the official reception of MEC Palacios at his home Chapter in St. Louis. The meal was lovely and the speaker very informative on the life of Abraham Lincoln.

In November masonic life became even more crazy with the fruition of the Bicentennial Offer for all Master Masons to take the Mark Master and Past Master degrees. This joint effort between the Grand Lodge of Missouri and the Grand Chapter of Royal Arch Masons of Missouri saw immediate success. Within the first two weeks of invites going out, 54 Master Masons had signed up to receive the Mark Master degree. Region 3, 5, and 7 set off to work almost immediately conferring the degrees using their regional degree teams.

In December the Bicentennial Offer kicked off at two Chapters simultaneously – Springfield Chapter No. 15 in Springfield and Oriental-Rabboni Chapter No. 78 in St. Louis. The degree of Mark Master was conferred in Springfield and the degrees of Mark Master and Past Master were conferred in St. Louis. In the spirit of friendly competition, Springfield can boast the fact they were the first to confer the degree of Mark Master in this special year, while St. Louis can boast the fact they were the first to confer the Past Master degree. Springfield holds tight to that crown, but Oriental-Rabboni did have the Grand High Priest and the Grand Master of the Grand Lodge of Ancient Free and Accepted Masons of the State of Missouri, M:W:B: Ty G. Treutelaar, in attendance so it is considered a wash!

Later that month I was able to make a two-day circuit to Liberty Chapter No. 3 and Lebanon Chapter No. 64 to watch the conferral of the Mark Master and Past Master degrees. It was a lot of travel, but well worth the trip. The degree work was proficient and pleasant to watch.

In January I was invited to Columbia Chapter No. 17 for their Stated Convocation and a Mark Master degree practice. The membership there is well-versed, and I had a great time working with Companions from a different part of the State. Many of the members are experienced and incoming Companions are in good hands with this Chapter.

In February, regions 3, 5, and 7 continued to confer the degrees for Brethren across the state. I had the privilege of attending Tyrian Chapter No. 52 in Neosho for the purpose of conferring the Mark Master and Past Master degrees. VEC Bill Sherman, EC Matt Routh, EC "Kip" Davis, and many others were well prepared. I must say here that the amount of time and practice they put in for this one night of degrees is admirable and shows the passion they have for the Craft. Ten Brethren were Inducted into the Oriental Chair that night and the degree work was superb! On a side note, Tyrian Chapter had secured four different backdrops from the old Joplin York Rite building that was going to be sold. They constructed a false wall in their Lodge room, in the East, and installed tracks that allow the backdrops to be moved in and out for different degrees in Chapter, Council and Commandery. The backdrops are from the 1950's, if my memory serves me correctly, and are a thing of beauty. They add a nice touch to the degrees, along with the special care and attention to all of the furniture used in the conferring of the Chapter degrees. It was a wonderful visit and one that will stand out as most memorable during this historic year.

Since February, the work continued around the state culminating in the largest Grand Masters Royal Arch class in the history of Royal Arch Masonry in Missouri. Sixty Past Masters were Received and Acknowledged Most Excellent Masters and more than 60 were Exalted to the Most Sublime Degree of the Royal Arch. The class was attentive and interested and due to the amazing cast of ritualists, they were enthralled with the work. I would like to personally thank everyone who gave of their time and volunteered to serve a roll in one or both of those degrees. I would also like to thank Oriental-Rabboni Chapter No. 78, including VEC Nick Young, VEC John Caraker and Companion Miles Lansing, and all of the help they received from their Chapter members, for hosting and providing us with a wonderful venue for this historic event. Of course, I would be remiss if I didn't mention MEC Kevin Sample in his diligent and fervent efforts to organize and compile all of the data received on all of these prospective members and have it all in place and ready to go on March 5. And all of this was the brainchild of M:E:C: Palacios in accordance with MWB Treutelaar, without whom it would not have been possible.

From there, we moved on to discuss the remainder of the Masonic year and the need to reach the candidates who could not attend the Grand Master's Royal Arch day festivities. Regional festivals and one-day conferrals

were scheduled around the state. Needless to say, even these efforts did not accommodate the schedules of all the prospective candidates. This, in itself, is a lesson for all to reflect on: our work is rarely, ever done. The diligence with which the Companions across the state worked to make March 5 and this whole endeavor a success, is the same diligence we need to apply day after day – in all aspects of our lives (remember the Twenty-four inch gauge?? 8-8-8). I am still very humbled by this appointment and am grateful for the opportunity not only to serve the state but to get to work with the amazing people I have met over the course of this year.

There are a couple of thoughts to share as we start gearing up for grand session.

Companions are reminded that all legislative proposals must be in the hands of the Grand Secretary no later than March 11, 2022.

The Grand High Priest has authorized me to notify you that this will be my last year as your Grand Secretary, I will not be standing for re-election at the annual convocation in June. As we do not have any official way to recruit potential candidates for the office of Grand Secretary, the Grand High Priest has appointed a Search Committee consisting of Kevin B. Sample, Kyle R. Palacios and Donald MacCormick, and authorized the committee to send this communication requesting anyone interested in presenting themselves as a potential candidate for the office of Grand Secretary to send their resume to the Search Committee no later than April 1, 2022.

Companions, I can honestly say that allowing me to serve as your Grand Secretary has been the highest honor that you could bestow on me. A man must know his strengths, and likewise, his limitations. I truly love being your grand secretary and I think I was good at it, at least for a time. However, it is time for new blood and new ideas. I will continue to make myself available to the Grand Chapter, its officers, and members for as long as you deem me worthy and competent. I will assist whomever you select as my replacement to the extent of his needs and my ability for as long as I live. I have had a good run. I believe we have advanced most all aspects of our processes, procedures and communications.

One final note. No man is an island. I could not have done this job for almost 20 years without the help, aide and assistance from a great many people, namely R.:.E.:.C.:. Russell S. Hanson, Past Grand Secretary, Debbie Hanson, Executive Assistant, E.:.C.:. Donald MacCormick, Webmaster, M.:.E.:.C.:. Donald L. Trabue, Grand Treasurer, and each and every Chapter Secretary and IT Representative.

For all those who believed in me, even in spite of myself, Thank You!

Companions, as was addressed in the Reports of the Grand Secretary, there is no process for the recruitment and vetting of a new Grand Secretary or Grand Treasurer should those offices become vacant for any reason.

History: Following the untimely death of Grand Secretary Bruce Harmon Hunt and the effort to find his replacement, Grand Secretary Ronald E. Wood, Jr., it was determined that our by-laws were deficient in that process. On May 3, 1996, the following proposal was presented, to lie over until the 1997 Annual Convocation: *ARTICLE III, Powers and Duties of the Grand High Priest*, to add *Section 19A.*, to wit:

In the event of the Death or Resignation of the Grand Treasurer or Grand Secretary or both, the Grand High Priest, shall appoint, with the approval of the Grand King and Grand Prelate (known typographical error) vacancy or vacancies until such time as the Grand Chapter may elect their successor or successors. In the event the officer because of physical disability, shall be unable to fulfill the duties of his office, the Grand High Priest shall have the authority to make such Emergency Appointments as shall be necessary to expedite the business of the Grand Chapter. Such appointments shall not extend beyond the period of the Disability or the succeeding Grand Chapter session. (Adopted May 3, 1997, Repealed May 9, 1998)

Also presented, to lie over until the 1997 Annual Convocation: *ARTICLE IV, Grand Officers, Section* **26.** *Grand Officers.*, to add the following sections, which were approved on May 3, 1997 and further amended on May 9, 1998, to wit:

- A. Any Office of the Grand Chapter becomes vacant upon death, by the resignation of the incumbent, or by any case which permanently incapacitates him from the discharge of his duties.
- B. The Grand High Priest fills all vacancies in the appointive offices by appointment and subsequent installation. But the Grand High Priest may not fill vacancies in the elective offices except the offices of the Grand Treasurer or Grand Secretary.
- C. In the case of a vacancy in the office of the Grand High Priest, from any cause, the Grand King and Grand Scribe shall in succession assume his prerogatives, powers, and duties for all purposes. Vacancies in the offices of Grand King and Grand Scribe shall be filled at the next annual convocation.
- D. In case of a vacancy in the Offices of Grand Treasurer or Grand Secretary, the Grand High Priest may make such necessary appointment as necessary to expedite the business of the Grand Chapter until in unison with the Grand Master and Grand Commander, he shall appoint a Special Committee to search for and recommend to the respective Presiding Grand Officers qualified York Rite Masons for the Office of Grand Treasurer and Grand Secretary/Recorder. The Search Committee shall be composed of three Capitular Masons, three Cryptic Masons, and three Chivalric Masons named by the Grand High Priest, the Grand Master, and the Grand Commander on a geographical basis.
- E. At the first meeting the members of the Search Committee, as a union, shall review the duties of the vacant office and discuss the professional qualifications, as well as the personal characteristics held to be desirable. Further, the search should include the desirability of seeking qualified York Rite Masons who would be prepared to serve for several years.
- F. In the spirit of Fraternal Unity, the Grand High Priest and the Grand Master, and the Grand Commander shall make official notification of the vacancy in the Office of the Grand Treasurer or Grand Secretary/Recorder by one (1) combined OFFICIAL COMMUNICATION together with the appropriate invitation for the submission of resumes by Companions and Fraters who might be interested in serving as the Grand Treasurer or Grand Secretary/Recorder to all Chapters, all Councils, all Commanderies, District Deputy Grand High Priests, Regional Grand Masters, Regional Grand Commanders, Grand Officers of the Three York Rite Bodies, and Past Presiding Grand Officers of said Grand Bodies.
- G. Candidates for the vacant offices shall forward their written resumes in sealed envelopes to the Special Search Committee by first class U.S. Mail, addressed as follows:

Special Search Committee c/o Grand York Rite Office Other appropriate lines of address information

- H. Personnel of the Grand York Rite Office shall transmit the sealed correspondence, identified by way of the specified envelope address as prescribed to the Search Committee for consideration at an agreed upon PLACE and TIME. Each member of the Special Committee shall review all as may be deemed appropriate toward the goal of SELECTION of three (3) individuals to be invited to meet the Committee for personal interviews. Following the interviews the Committee will communicate their recommendations to the Grand High Priest, the Grand Master, the Grand Commander, who in UNITY, will select one to fill the vacancy, make the appointment, and subsequently to duly install one whom the COMMITTEE had endorsed to serve as Grand Treasurer or Grand Secretary/Recorder until the next Annual Convention, Assembly, and Conclave when the Grand Chapter, Grand Council, and Grand Commandery will hold election of officers respectively. The Companion and Frater who has been recommended and endorsed by the members of the Search Committee, appointed by the Presiding Grand Officers, and duly installed by them must know and understand that there is no assurance or promise of his being elected by the vote of the membership present at the Grand Chapter Convocation, the Grand Council Assembly, and the Grand Commandery Conclave.
- I. Finally, the Companions and Fraters who constitute the Special Search Committee must know and understand that their service is ADVISORY ONLY. (Amended May 3, 1997, Amended May 9, 1998)

On May 9, 1998, for some good and bad reasons, in my opinion, the entire sections of paragraphs D. through I. were repealed, leaving no process in place to fill the vacancy of the Grand Secretary of the Grand Chapter and the Grand Recorder of the Grand Council, who made known in 2021 that he would not stand for reelection in 2022.

This being the case, and for the health and welfare of the Grand Chapter, the Grand High Priest, in unity with the Grand Master of the Grand Council, did appoint a Search Committee who was charged requesting anyone interested in presenting themselves as a potential candidate for the office of Grand Secretary to send their resume to the Search Committee no later than April 1, 2022. Said communication was forwarded to all Grand Chapter Officers, Past Grand High Priests, and Chapter Secretaries and IT Representatives on February 18, 2022. Additionally, said communication was also sent out to known membership with email addresses.

The committee reports that there was only one respondent, EC Donald MacCormick. Donald's qualifications for the role of Grand Secretary of the Grand Chapter of Royal Arch Masons and Grand Recorder of the Grand Council of Cryptic Masons can be seen from both his professional experience and his Masonic secretarial experience. Masonically, he was the Secretary of Mt. Washington Lodge No. 614 for 5 years, Secretary/Recorder of the Kansas City York Rite Bodies for 6 years and Secretary of Santa Fe AMD Council No. 417 for 6 years. Additionally, he has been the Webmaster for the Grand York Rite for 6 years, overseen the Grand York Rite Social Media Platform for several years, provided technical services to the Grand York Rite, maintained and built our Grand York Rite outbound Email efforts using Mailchimp, and assisted the current Grand Secretary/Recorder in those efforts. His professional career in Management, Sales & Marketing, Engineering, eCommerce and Technology, Database Design, Implementation and more has developed the skills over the last couple of decades necessary for the role as Grand Secretary / Grand Recorder such as Communication – orally, electronically, and written; Organizational and detail-orientation from running a business and departments within business, Technical from running successful growth-oriented commercial eCommerce solutions.

REPORT OF SPECIAL COMMITTEE ON THE CONDITION OF THE GRAND CHAPTER OFFICER LINE

To the Grand Chapter Royal Arch Masons of the State of Missouri,

Companions, this year has been most difficult for many of our Grand Chapter line officers. On November 9, 2021, Lady Margaret Bean, wife of Grand Scribe Mark A. Bean, passed away. On February 6, 2022, the Grand High Priest accepted the resignation of REC Clifton W. Wofford, Grand King, due to ongoing health issues. On April 12, 2022, the Grand High Priest accepted the resignation of VEC Dennis N. Vogel, Grand Master of the 3rd Veil, due to ongoing health reasons. Additionally, as if this was not enough, the pending vacancy in office of the Grand Secretary has been known for over a year. All of these things have combined to form a perfect storm and cause great concern for the Grand High Priest, the grand line officers, and of course all Missouri Royal Arch Masons. For this reason, the Grand High Priest has formed a special committee to review options and make recommendations.

The committee consulted with the Grand High Priest and took note of his concerns. The committee consulted with the Grand Scribe, REC Mark A. Bean, and recognize and respect his determination that he is not of a healthy mindset to potentially advance two stations at this time and has requested another year to recover from his tragic loss and to adequately prepare for his future potential advancement to the office of Grand High Priest. The committee additionally consulted with the Jurisprudence Committee and even with past Jurisprudence Committee Chairman, MEC Robert W. Schlichter. Finally, the committee consulted with all the Grand Chapter line officers to get their input and recommendations, most of whom were concerned with advancing too rapidly without time to properly prepare for unexpected offices and responsibilities.

The committee has determined that considering the lack of procedure as defined in our laws and even precedence to cover our specific unforeseen circumstances, in accordance with ARTICLE VIII, Powers of the Grand Chapter, Section 1. The Grand Chapter of Royal Arch Masons of the State of Missouri (meaning when convened)... "may consider and do whatever it may regard as necessary or appertaining to the wellbeing and perpetuity of Royal Arch Masonry in the State of Missouri." that the Grand Chapter could in fact receive and accept this report and the recommendations contained therein.

The Grand Chapter (here convened this day) could decide to receive and approve the report of this special committee appointed by the Grand High Priest. And, the Grand Chapter, for the benefit of the craft, could additionally approve a proposed slate of grand officers for the 2022-2023 Grand Chapter capitular year by acceptance of this report.

The committee therefore respectfully submits the following recommendations: To retain MEC Kyle R. Palacios for another year as Grand High Priest; move the Grand Scribe (Mark A. Bean) and the Grand Captain of the Host (John S. Lambros) up one position to Grand King and Grand Scribe respectively; retain the Grand Treasurer; that EC Donald MacCormick be selected to the office of Grand Secretary; move the Grand Principal Sojourner (Michael L. Dodd) and the Grand Royal Arch Captain (Kevin M. Ritter) up one position to Grand Captain of the Host and Grand Principal Sojourner respectively; that James E. McManigle be selected to the office of Grand Royal Arch Captain; move the Grand Master of the 2nd Veil (W. Larry Wilson), Grand Master of the 1st Veil (Donald E. Gilkerson) up one position to Grand Master of the 3rd Veil and Grand Master of the 2nd Veil respectively; and that Grand Master of the 1st Veil be elected in accordance with *ARTICLE VI*, *Officers*, *Section 1. B.*, to wit: *Nominations for Grand Master of the First Veil shall be entertained at the time called for the election of officers. Past Grand High Priests may collectively select a single individual and introduce that individual to the Grand Chapter by means of a brief, verbally presented biography. Each Chartered Chapter, legally represented and registered with the Credentials Committee, may select and introduce one Companion by means of a brief, verbally presented biography. (Amended May 14, 2009), and*
