BIOGRAPHY OF THE GRAND HIGH PRIEST

M:.E:.C:. Mark Allen Bean was born on June 20, 1963 in Los Gatos, California, the only child of Richard D. Bean and H. Diane (Pasetta) Bean. Following his parents divorce, he came to live with his maternal Grandfather; Nicholas J. Pasetta who raised him and taught him many of life's lessons, especially Integrity, Loyalty, and Honor. Lessons that he would continue to live by his whole life.

He is a graduate of Blackford High School. Following High School, he attended West Valley College where he took drafting and general education classes. He worked for Santa Clara Land Title Company as a Title Officer, which became Financial Title Company, before transferring to the IT department, where after many years he retired as the Network Administrator for Northern California. It was while working at Santa Clara Land Title Co. that he met, and married, his best friend, the love of his life, and his wife of 28 years, Lady Margaret Catherine (Burns) Bean (Deceased). It was Lady Margaret who first asked him if he ever considered becoming a Mason.

M:.E:.C:. Bean did not come from a Masonic family. However, Lady Margaret did, her grandfather was a Mark Master Mason from Scotland and a Past Worthy Patron of the Eastern Star and her Father was a Master Mason; her Grandmother, and Aunts were all Past Worthy Matrons of Eastern Star. For a time, she was a member of the Rainbow Girls. Such was her favorable impression of what the Masons were composed of, she asked M:.E:.C:. Bean to think about joining them. Not knowing any Masons, (that he was aware of) he was surprised when visiting the home of a coworker to set up remote office access, to see a Trestle Board from a local Lodge. He asked about it and how one could become a Mason, the response he received was "you just did it." WB Robert Christiansen then became his top line signer and proficiency coach, guiding him in his first steps in Freemasonry. But it was his Lady Margaret who became his biggest supporter in all his Masonic activities.

PRELIMINARY REPORT OF THE GRAND TREASURER

June 1, 2023 through April 30, 2024

Our first year with your new Grand Treasurer has been very challenging. I refer you to the Missouri Grand York Rite Financial Report and the three Missouri Grand York Rite Financial Accounts Detail Reports for the record of where we started and where we are now. These documents are hereby incorporated into this report by reference. We still have more work to do in this next year in order to resolve all of the remaining issues.

Grand Chapter Clerical Assistant

This year I moved paying Lady Debbie Hanson from monthly to quarterly in order to better align with the demands of reporting our Employee to the State and Federal Governments as well as making the requisite deposits/contributions.

I have established my credentials as the Grand Treasurer of the Grand York Rite of Missouri and authorized employer representative with the IRS. I have gained access to the Federal EFTPS.gov web portal.

The IRS 941 Employer's Quarterly Federal Tax Return forms for the four quarters of calendar year 2023 have been filed and all deposits made for Social Security, Medicare, and Federal Withholding Tax using the EFTPS portal. Included in those deposits were both the Employee and Employer monetary portions. In addition, the IRS 940 Employer's Annual Federal Unemployment (FUTA) Tax Return form for calendar year 2023 has been filed and the deposit made.

The IRS 941 Employer's Quarterly Federal Tax Return forms for the first calendar quarter of 2024 has been filed and the deposit made for Social Security, Medicare, and Federal Withholding Tax using the EFTPS portal. Included in that deposit was both the Employee and Employer monetary portions.

I have established my credentials with several State agencies as the Grand Treasurer of the Grand York Rite of Missouri and authorized employer representative.

In June 2023, I reactivated our account with the Missouri Division of Employment Security (DES) and gained access to the DES uinteract.labor.mo.gov web portal. I have been filing the required quarterly unemployment insurance reports and paid the required contributions using the web portal.

I have also gained access to the Missouri Department of Revenue's (DOR) mytax.mo.gov web portal. I have filed the DOR MO-941 Employer's Return of Income Taxes Withheld for calendar year 2023 and paid the withholding tax, additions, interest, and processing fee using the web portal.

The 2023 W-2 Wage and Tax Statement for Lady Hanson and the 2023 W-3 Transmittal of Wage and Tax Statements were filed and accepted by the IRS.

Grand Chapter IRS Tax Status

I have established my credentials with the IRS as the Grand Treasurer of the Grand Chapter and the Grand Treasurer of the Missouri Grand York Rite. I applied for and received a verification letter from the IRS confirming the Grand Chapter Employer Identification Number (EIN). I applied for and received a verification letter from the IRS confirming the Missouri Grand York Rite Employer Identification Number (EIN). These letters are required in order to establish business bank accounts in Missouri.

During the process of obtaining the verification letters, I was informed by the IRS that the Grand Chapter tax exempt status had been revoked due to failure to file IRS 990 Return of Organization Exempt From Income Tax forms for more than three years. I was told that we would need to complete and file an IRS 1024 Application for Recognition of Exemption form. I was informed that the processing cost was \$600.00 and that processing took six months. I began the process of completing the 42 page form, but ran into issues when I got to the Part V - Financial Data. I will not be able to proceed further until the financial state of the Grand Chapter is determined.

The Grand York Rite of Missouri IRS Form 990-N (e-Postcard) for the tax year ending March 31, 2024, was successfully filed and accepted by the IRS. In addition, the Grand Chapter Palmyra Chapter No. 2 IRS Form 990-N (e-Postcard) for the tax year ending March 31, 2024, was successfully filed and accepted by the IRS.

Grand Chapter Missouri Certificate of Incorporation

The Grand Chapter has a Certificate of Incorporation with the Missouri Office of the Secretary of State, which Articles, in all respects, comply with the requirements of Missouri Nonprofit Corporation Law. In addition, the Missouri Grand York Rite has a Certificate of Incorporation with the Missouri Office of the Secretary of State, which Articles, in all respects, comply with the requirements of Missouri Nonprofit Corporation Law. These certificates are required in order to establish business bank accounts in Missouri.

I filed the 2023 Annual Registration Reports for a Domestic Nonprofit Corporation for the Grand Chapter and the Missouri Grand York Rite, and paid the required registration and processing fees. The reports were accepted by the Missouri Secretary of State's Office.

Grand Treasurer's Office

Your Grand Treasurer has worked diligently to bring transparency to the office. I attended all of the Grand Chapter Grand Officer Zoom meetings. During those meetings, I provided requested financial review briefings to the Grand Officers and answered questions that the Grand Officers asked concerning the finances of the Grand Chapter. In addition, I provided the Grand High Priest and the Chairman of Finance and Accounts with weekly reports on the work of the Grand Treasurer. Beginning in December 2023, I provided detailed reports on the financial status of the Missouri Grand York Rite to the Grand High Priest, the Chairman of Finance and Accounts, and the Chairman of Investments. Many of the recommendations and actions concerning changes to the financial plan of the Missouri Grand York Rite are documented in the separate Missouri Grand York Rite Financial Report incorporated herein by reference.


The Grand Treasurer's Office has received thirteen banker boxes of historical paper records from the office of the previous Grand Treasurer through the efforts of Companion and Sir Knight Harold F. Coots, PGC. I cannot adequately express my appreciation for the extraordinary patience and perseverance exhibited by Harold in wading through the process of providing these records. REPORTS OF THE GRAND SECRETARY

To the Grand Chapter of Royal Arch Masons of the State of Missouri,

Companions, following this narrative you will find the statistical reports of the Grand Secretary's office. The statistical reports provide much institutional information as to the overall financial and physical health of the subordinate Chapters of the Grand Chapter of Missouri.

- **Annual Returns Late:** As of the time of this report, the following Chapters filed late returns and were assessed penalties: Poplar Bluff Chapter No. 114; and Keystone Chapter No. 146.
- **Annual Returns No Return:** The following Chapters have not filed an annual return as of the date of May 18, 2024 Bellefontaine Chapter No. 25 and Greenfield Chapter No. 38. As such, they have forfeited all rights and privileges to representation and voting at the Annual Convocation and will be assessed penalties. Given the extraordinary circumstances the Grand High Priest has granted special dispensation of Bellefontaine Chapter No. 25 to representation and vote at the Annual Convocation.
- Annual Returns Not Received thirty days prior to Annual Convocation: As of the date of this report, the following Chapter filed an annual return, but not later than thirty (30) days prior to the Annual Convocation, has forfeited all rights and privileges to representation and voting at the Annual Convocation, and will be assessed penalties: None.
- **Annual Returns Financial Statements:** The following Chapters either failed to submit or filed an incomplete Financial Statement: None.
- Annual Returns RARA Donations (according to the annual returns): The following Chapters reported no contributions to RARA: Bolivar Chapter No. 5, Hannibal Chapter No. 7, Lexington Chapter No. 10, Bellefontaine Chapter No. 25, Greenfield Chapter No. 38, Lebanon Chapter No. 64, and UEL Chapter No. 129. In contrast Oriental-Rabboni Chapter No. 78 contributed \$4,046.50 \$46.51 per member; Triune Chapter No. 93 contributed \$19.62 per member; Independence Chapter No. 12 contributed \$6.06 per member; Springfield Chapter No. 15 contributed \$4.04 per member; Wyoming Chapter No. 43 contributed \$3.99 per member; and Rolla Chapter No. 43 contributed \$3.73 per member.
- Annual Returns Bonding: Only 5 Chapters reported that the Treasurer and Secretary are bonded: St. Charles Missouri Chapter No. 1; Liberty Chapter No. 3; Bolivar Chapter No. 5; Hannibal Chapter No. 7; UEL Chapter No. 129. Although there is no requirement by law that bonds be established, there is a necessity of ensuring the organizational officers who are responsible for your financial health are bonded.
- Annual Returns Inquiries and Examination of Accounts (Financial Reviews): The following Chapters did not file an Inquiry and Examination of Accounts as part of their Annual Return or if they did file an Inquiry and Examination of Accounts, it was incomplete: Caldwell Chapter No. 53.

- **Annual Return Seal Impressions**: Article XII, Section 69. Seal. States that "Every chartered chapter shall have a seal, and all official papers shall be attested by an impression of the same." The following Chapters did not provide a Seal Impression on their Annual Return. Hannibal Chapter No. 7 and Oriental-Rabboni Chapter No. 78;
- **Annual Returns Signatories**: The following Chapters report that there is not more than one signatory on the accounts of the Chapter: Oriental-Rabboni Chapter No. 78; and Keystone Chapter No. 146. This failure is an extremely high risk to the Chapter. I refer these to the Grand Officers to address.
- **Annual Returns Dues**: The following Chapters reported dues charged each member to be less than that required by Grand Chapter (\$35.60): None.
- Annual Returns 990 Status: The following Chapters did not file evidence of a completed 990 filing: St. Charles Missouri No. 1; Hannibal Chapter No. 7; and Keystone Chapter No. 146. Approximately 20% of Chapters did not include confirmation that their 990N filing was accepted, rather the IRS notice that the filing is required. Once your 990N filing is submitted, wait 7 minutes, then take a screenshot that shows your filing was accepted. I refer these to the Grand Officers to address.
- **Annual Returns Chapter Indebtedness**: The following Chapters reported a negative cash on hand as of December 31, 2022: None.

I refer all of the above to the Grand Officers to address.

Growth Awards: There were 157 Exaltations during the 2022 calendar year, another amazing year!

10% Growth Awards will be presented to Kansas City Chapter No. 28 (10%) who Exalted 4 and Affiliated 2.

15% Growth Awards will be presented to Poplar Buff Chapter 114 (24%) who Exalted 5, Affiliated 3, and Reinstated 1; and Hannibal Chapter No. 7 (27%) with the highest % growth (27%) who Exalted 2, and Affiliated 3.

MMS: We feel that all Chapters are fully engaged and using MMS, either by the Chapter Secretary or the IT Representative designated for that purpose.

Summary: Companions, First, allow me to thank those who work with diligence and efficiency to make the Grand York Rite work, with attentiveness and thoughtfulness in all that they do. Please see the report of the Grand Treasurer for an in-depth report of the Grand Chapter Finances. New proposals are being presented this year to adjust investment strategies moving forward and with a new Grand Treasurer, we feel these adjustments in policy and procedure will advance the financial health of the Grand Chapter.

2024-2025 BUDGET

The budget and finance committees have monitored the income and expenses through the office of the Grand Secretary on a regular basis throughout the year. PRELIMINARY REPORT OF JURISPRUDENCE COMMITTEE

To the Grand Chapter of Royal Arch Masons of the State of Missouri:

Greetings: The Jurisprudence Committee has reviewed the Dispensations granted and By-Laws changes approved for subordinate Chapters and all other relevant matters pertaining to the business of the Craft acted upon by the Grand High Priest.

Upon review of all timely submitted proposals for this Annual Convocation, and pursuant to Art. IX, section 1 of the Constitution of this Grand Chapter, Layover Proposal No. 3 shall be proposed in writing at this Annual Convocation, be published in the proceedings, and lay over until the next Annual Convocation. Adoption of any amendment to the Grand Chapter Constitution requires an affirmative vote of not less than two-thirds vote of the eligible members present.

In our opinion, the Grand High Priest has complied with the statutory duties, responsibilities, and inherent powers of his office. Our Grand High Priest is to be commended for his specific interest and attention to the Craft over the past year.

Statement of purpose

The Investment Committee is a specialized committee. There is no merit having a member of this committee based on the Grand Chapter office position they hold. All members of the Investment Committee should possess a knowledge of or acumen in financial matters. It must be assumed that the Grand High Priest will consider these qualifications when choosing these members. By his chair responsibilities, the chairman of the Finance Committee Finance should be knowledgeable in this area as well.

This does not mean the Grand Treasurer, Grand Secretary, or for that matter any other companion can't be a member of this committee. It just means that there is no merit for making a blanket, standing appointment based on a Grand Chapter office held.

In addition, the added language regarding the amount of assets placed in a specific investment is not necessary. The old language chose an arbitrary percentage of the surplus funds and locks the committee into taking a position REGARDLESS OF WHAT PREVAILING MARKET CONDITION AND CLIMATE may call for. A committee that is qualified will make the proper allocations based on what is appropriate at the given time.

This has been a challenging year for the Grand Chapter with the untimely passing of our Grand King, REC John S. Lambros. But John would want us to carry on and carry on we shall.

The Grand Treasurer has been diligently working on our account to identify and balance the accounts. He has confirmed the accounts held at various financial institutions and recently reported that we now have accurate statements that are in total agreement with our banking institutions. This has been a very lengthy process, and the Grand Treasurer has regularly kept the Line Officers aware of the progress. He reports monthly on the status of the accounts with a quarterly in-depth review. Moving forward systems are in place to track and verify each transaction that will occur in our financial records. After an extensive review of the records we, the Examination Committee, feel that our cash account procedures are in keeping with sound accounting practices and the detailed records that have been developed will alleviate concerns in the future.

The Grand Treasurer has set in motion further steps so that there is more than one signer on the various accounts to allow for an easier transition should it be needed.

The Investment accounts are still under the direct control of the Grand Treasurer. These accounts need the same painstaking attention that has been given to the cash accounts. In that various accounts have deposits from more than one source, i.e. General Funds mixed with Endowment Funds and Charity Funds. The Grand Treasurer has successfully segregated these cash accounts and is now ready to proceed and apply the same policies to the Investment Accounts. But with pending legislation this is on hold till after the Grand Session.

All the work that has been done is a direct result of the dedication and attention to detail of the Grand Treasurer and working relationship between the Grand Secretary and the Grand Treasurer and the Grand York Rite Office.

One note of recommendation is that since the fiscal year ends after our Grand Session that a final report of the year be published as an addendum to the Preliminary Treasure's Report presented at the Grand Session.

REPORT OF COMMITTEE ON INVESTMENTS

To the Grand Chapter Royal Arch Masons of the State of Missouri,

PRELIMINARY/FINAL REPORTS ANALYSIS

Since the formation of the Investment Committee, its' previous year's reports put forth recommendations regarding: the Report of the Treasurer; legislation surrounding the allocation of surplus funds; and who has that responsibility to allocate said funds; and modernization of the current investment practice. Many of these recommendations have been acted on by the presiding body, and this year we again submit six pieces of legislation for action.

We are pleased to say that for the first time in the history of the York Rite, there has been a stand-alone Investment Policy created to allow the ability to allocate funds as the financial markets may warrant, not by a preconceived cookie cutter approach.

Also, for the first time, we have had the opportunity to speak with the Financial Advisor managing our funds. The good news is (with one small exception), all our mutual funds were placed in one fund family which

provides us not only with discounted sales charges (if any), but also allows us the ability to move from one fund to another without any additional charges. Additionally, since we are so close to being able to take steps to balance our portfolio the decision was made to temporarily "pause" the automatic renewal of Certificates of Deposits. That is not to say the money may not end up there. It just made no sense to auto renew into a CD and be locked in for multiple years when we may have to take a liquidation penalty a few weeks later to allocate somewhere else. The great news is this money is currently sitting in Money Market accounts, whose rates currently are particularly good.

Several years ago, issues were identified with all our funds and their account placement in respect to the three York Rite bodies. Russell Hanson and several other companions have done an incredible job of tracing our funds to their original sources and placing them where they belong. This time consuming, tedious, and challenging work was done with excruciating detail (which is what was needed). Once the Finance and Account committee identifies the surplus funds, fixes the restricted bases, and turns the funds over to the Investment Committee for action, we can begin work.

It has been a pleasure for the Membership and Retention Committee to serve Most Excellent Companion Mark Alan Bean, Most Illustrious Companion Dr. Paul Lee Daniels, and Sir Knight Kevin Brian Sample, Right Eminent Grand Commander, and the Companions and Sir Knights of the Grand York Rite of the State of Missouri.

The Grand York Rite bodies saw a change in the Constitution and Bylaws and Laws and Regulations of the respective bodies. Membership continues to be a struggle within our fraternity and most organizations. Freemasonry is still viable and has what men are looking for in benevolence, brotherhood, purpose, spiritual growth, ritual, and a rich history.

However, the number of men seeking us out is declining and some do not know that we exist. We are no longer as prevalent as we used to be. So now it is up to us to carry our message to them. How do we do this? By getting out of our chapters, councils, and commanderies. Bring York Rite Masonry to them. Have open houses, present York Rite in Blue Lodges, get involved with your local chambers of commerce, participate in parades and other community functions, and invite Craft Masons and non-masons to your events.

There are York Rite bodies around the state that are taking the initiative and creating ways to keep and recruit members. This is an ongoing process and not a one-and-done approach. The ones taking the necessary steps are the ones who are seeing growth and/or engagement of their members. The ones that aren't, are the ones struggling for quorums, and eventually closing their doors.

Special acknowledgments need to go out to The York Rite bodies of Rolla, Kansas City, 903 Harrison Street KC, Kirksville, and Cape Girardeau. These York Rite bodies are seeing an increase in growth and activity. Special recognition for Cape Girardeau for conferring the Templar Orders for the first time in over 30 years with a healthy class of members.

Your membership committee is here to assist you, but we cannot do the work for you. Please feel free to contact me at any time or contact one of the above-mentioned York Rite bodies to see what is working for them. The same approach will not work for everyone. Find what will work for your organization. Keep in mind that doing nothing has a guaranteed result.

REPORT OF COMMITTEE ON RITUAL AND REPORT OF THE GRAND LECTURER

To the Grand Chapter of Royal Arch Masons of the State of Missouri,

My third year as Grand Lecturer started off like all of the others: with excitement and anticipation and a little anxiety on how to continuously improve the ritual around the state and build upon the success of years past.

My first task was a little unusual as I was asked about a rededication ceremony for Chapter halls. I would imagine just about all of us have seen a Lodge rededication by the Grand Lodge officers. I, for one, had never seen or heard of such a ceremony for a Chapter hall. I contacted the General Grand Chapter Secretary who was more than eager to assist me. I was able to take the ceremony from the General Grand Chapter and conform it to the Grand Chapter level and specifically the State of Missouri. Having passed the rough draft to the Grand Line officers, I then gave it to our experts in the state; our DDGL's and Regional Grand Lecturers. Once the feedback was received and changes made, the Grand Line was given the final version for their review and study.

REPORT OF THE ORDER OF HIGH PRESTHOOD

The Order of High Priesthood is an association for past and current High Priests of local Chapters of Royal Arch Masons, sometimes referred to as the Anointed Order of High Priesthood. In antiquity, this degree was known as the Order of Melchizedek. The Holy Order of High Priesthood degree tells the story of Abraham returning from the slaughter of the kings, and his encounter with Melchizedek, High Priest of Salem. The candidate is then solemnly anointed, consecrated, and set apart to the Holy Order of High Priesthood. If you were, or currently are, the High Priest of your chapter, you should consider receiving this degree. It furthers your knowledge and understanding of the Royal Arch Degrees.

We now have a strong leadership line, and the utilization of a special ceremonial cast has made this arguably the best of the chair degrees. Last year we conferred the degree on a total of 9 candidates.

Since then, much time has been spent by Kevin Ritter and Greg Walker updating and clarifying our ritual, and it greatly surpasses what we used to use, assuring continued quality work for years to come.

Management of our finances (including raising the membership fee) has allowed us to continue to do benevolent activities, including the purchase and presentation of the Past Grand High Priest apron.

Of note, this year we began scanning and forwarding copies of our historical records to the Grand York Rite office to provide a permanent, safe location that is easy to access. All records will be updated in MMS.

STATEMENT OF INVESTMENT POLICY, OBJECTIVES, AND GUIDELINES FOR THE GRAND CHAPTER OF ROYAL ARCH MASONS OF THE STATE OF MISSOURI

SCOPE OF THIS INVESTMENT POLICY

This statement of investment policy reflects the investment policy, objectives, and constraints of the Grand Chapter of Royal Arch Masons of the State of Missouri, also referred to as the Grand Chapter.

PURPOSE OF THIS INVESTMENT POLICY STATEMENT

To outline a philosophy and attitude which will guide the investment management of the assets toward the desired results. It is intended to be sufficiently specific to be meaningful, yet flexible enough to be practical.

This statement of investment policy is set in order to:

- 1. Define and assign the responsibilities of all involved parties.
- 2. Establish a clear understanding of the investment goals and objectives of Fund assets.
- 3. Offer guidance and limitations to all *Investment Managers* regarding the investment of Fund assets.
- 4. Establish a basis for evaluating investment results.
- 5. Manage Fund assets according to prudent standards.
- 6. Establish the relevant investment horizon for which the Fund assets will be managed.

DELEGATION OF AUTHORITY

The Grand Chapter is a fiduciary and is responsible for directing and monitoring the investment management of assets. As such, the Grand Chapter is authorized to delegate certain responsibilities to professional experts in various fields. These include, but are not limited to:

- 1. **The Investment Committee**, as defined in the Grand Chapter Constitution and By-Laws, is charged with establishing investment policy, objectives, and guidelines; selecting investment managers; reviewing such managers over time; measuring and evaluating investment performance; and other tasks as deemed appropriate by the Grand High Priest.
- 2. **The Investment Manager** is a licensed Financial Advisor or company who will advise, and at the Investment Committees direction, purchase, sell, or hold the specific securities that will be used to meet the Fund's investment objectives. They may also perform regular accounting of all assets owned, purchased, or sold, as well as movement of assets into and out of the Fund accounts.
- 3. Additional specialists such as attorneys, accountants, auditors, actuaries, consultants, and others may be employed by the Grand Chapter to assist in meeting its responsibilities and obligations to administer Fund assets prudently. All expenses for such experts must be customary and reasonable and will be borne by the Fund as deemed appropriate and necessary.

The Grand Chapter will not reserve any control over investment decisions, with the exception of specific limitations described in these statements and in the Grand Chapter Constitution and By-Laws. Investment Managers will be held responsible and accountable to achieve the objectives herein stated. While it is not believed that the limitations will hamper investment managers, each manager should request modifications, which they deem appropriate.

DEFINITION OF RISK

The Grand Chapter realizes that there are many ways to define risk. It believes that any person or organization involved in the process of managing the Fund's assets understands how it defines risk so that the assets are managed in a manner consistent with the Fund's objectives and investment strategy as designed in this statement of investment policy. The Grand Chapter defines risk as:

High volatility (fluctuation) of investment returns and or loss of principal

LIQUIDITY

To minimize the possibility of a loss occasioned by the sale of a security forced by the need to meet a required payment, the Grand Chapter will periodically provide the Investment Committee an estimate of expected net cash flow. The Grand Chapter will notify the Investment Committee in a timely manner, to allow sufficient time to build up necessary liquid reserves.

FURTHER RESPONSIBILITIES OF THE INVESTMENT COMMITTEE

- 1. Assisting in the development and periodic review of investment policy.
- 2. Conducting investment manager searches.
- 3. Providing "due diligence", or research, on the Investment Manager(s).
- 4. Monitoring the performance of the Investment Manager(s) to provide the Grand Chapter with the ability to determine the progress toward the investment objectives.
- 5. Communicating matters of policy, manager research, and manager performance to the Grand Chapter.
- 6. Reviewing Fund investment history, historical capital markets performance and the contents of this investment policy statement to the Grand Chapter on a regular basis, at a minimum of once per year.

GENERAL INVESTMENT PRINCIPLES

- 1. Investments shall be made solely in the interest of the beneficiaries of the Fund.
- 2. The Fund shall be invested with the care, skill, prudence, and diligence under the circumstances then prevailing that a prudent man acting in like capacity and familiar with such matters would use in the investment of a fund of like character and with like aims.
- 3. Investment of the Fund shall be so diversified as to minimize the risk of large losses, unless under the circumstances it is clearly prudent not to do so.

INVESTMENT MANAGEMENT POLICY

- 1. Conservative Consistent with their respective investment styles and philosophies, investment managers should make reasonable efforts towards long term conservative growth while limiting volatility, understanding that losses may occur in individual securities.
- 2. Risk Aversion Understanding that risk is present in all types of securities and investment styles, the Grand Chapter recognizes that some risk is necessary to produce long-term investment results that are sufficient to meet the Fund's objectives. However, the investment managers are to make reasonable efforts to control risk and will be evaluated regularly to ensure that the risk assumed is commensurate with the given investment style and objectives.
- 3. Adherence to Investment Discipline Investment managers are expected to adhere to the investment management styles for which they were hired. Managers will be evaluated regularly for adherence to investment discipline.

GOAL OF THE GRAND CHAPTER

The goal of the Grand Chapter is to achieve a total rate of return sufficient to provide current distribution potential and to allow for the growth necessary to increase future distribution potential. The Grand Chapter recognizes that its funds exist to provide a perpetual resource of funds, and that its investment decisions should support that aim.

SPECIFIC INVESTMENT GOALS

Over the investment horizon established in this statement, it is the goal of the aggregate Fund assets to exceed:

An absolute rate of return after all distributions and expenses, equal to or greater than the rate of inflation as measured by the Consumer Price Index (CPI) plus 2%.

The investment goals above are the objectives of the aggregate Fund and are not meant to be imposed on each investment account arbitrarily. The goal of the investment manager, over the investment horizon, shall be to:

- 1. Meet or exceed the market index, selected, and agreed upon by the Investment Committee that most closely corresponds to the particular Fund.
- 2. Display an overall level of risk in the portfolio which is consistent with the risk associated with the benchmark specified

SPENDING POLICY

This Grand Chapter places the highest emphasis on meeting its obligations. As such, the Grand Chapter regards spending in dollar terms from year to year unpredictable. As spending is unpredictable, expected investment returns from "riskier" portfolios are not consistent and predictable. Therefore, in order to reduce the likelihood of underperformance and excessive deterioration of real principal during such periods an unexpected large expense may occur, some Funds may tend toward a more "conservative to moderate" investment strategy than might be the case if periodic large expenditures were not possible.

INVESTMENT OBJECTIVES

To meet its needs, the investment strategy of the Grand Chapter is to emphasize total return; that is, the aggregate return from capital appreciation and dividend and interest income.

Specifically, the primary objective in the investment management for Fund assets shall be:

Long-Term Growth of Capital -To emphasize long-term growth of principal while avoiding excessive risk. Short-term volatility may be tolerated in as much as it is consistent with the volatility of a comparable market index.

INVESTMENT GUIDELINES

Allowable Assets Assets chosen should be selected in such ways as such the Investment Committee, in its judgment, considers prudent, and adheres to sound business principles, while balancing the total return in accordance with the specific Chapter fund needs.

Prohibited Assets Prohibited Assets investments include, but are not limited to the following:

- 1. Annuities or Other Guaranteed Return Strategies
- 2. Commodities and Futures Contracts
- 3. Private Placements
- 4. Options
- 5. Limited Partnerships
- 6. Venture-Capital Investments
- 7. Real Estate Properties
- 8. Interest-Only (IO), Principal-Only (PO), and Residual Tranche CMOs
- 9. Cryptocurrency

Prohibited Transactions Prohibited transactions include, but are not limited to the following:

- 1. Short Selling
- 2. Margin Transactions

DEFINITIONS

- 1. "Fund" shall mean the investable assets of the Grand Chapter of Missouri deemed surplus. The term "Fund" is inclusive of the aggregation of all separate accounts under the control of the Investment Committee.
- 2. "Grand Chapter" shall refer to the governing board established to administer the Fund as specified by applicable ordinance.
- 3. "Fiduciary" shall mean any individual or group of individuals that exercise discretionary authority or control over fund management or any authority or control over management, disposition, or administration of the Fund assets.
- 4. "Investment Manager" shall mean any individual or group of individuals, employed to manage the investments of all or part of the Fund assets.
- 5. "Securities" shall refer to the marketable investment securities, which are defined as acceptable in this statement.
- 6. "Investment Horizon" shall be the time period over which the investment objectives, as set forth in this statement, are expected to be met. The investment horizon for the Fund is 10 plus years.
