BIOGRAPHY OF THE GRAND MASTER

Dr. Paul L. Daniels was born in Ft. Scott, Kansas and raised in Moundville, MO on his family's farm. He was the 6th born child to N.B. "Doc" and Wanda Daniels. Many believe that being the "baby" of the family is a preferred position, but this was not the case as two older brothers and three older sisters definitely did not allow for much pampering or spoiling. The older brothers did their best to toughen me up and the older sisters were like having three extra mothers. I remember being old enough to not desire staying in the house with the sisters but when I chose to hang out with my father and brothers, they always put me to work which set into motion a pattern of me accomplishing a lot of things at a young age. I remember doing things like driving trucks and tractors at a very young age and pushing hay off the truck to my brothers. One experience I will never forget is pestering my brothers to teach me how to ride a horse. They put me up on a horse (no saddle), put a bridle on it and told me to hold the reins. Then, after a good slap on the rump, I was off. Luckily the horse ran up to a barn and, having stayed on, I decided that I knew how to ride a horse at the age of 6.

As you might deduct from the information above, I was raised on a 1200 acre farm which included row crops, hogs, chickens, beef and a dairy. Having been through the ups and downs of farming, my parents stayed very diversified. I helped on the farm from a young age but became focused on the dairy around the age of 11.

From that point on I took care of all evening milkings and chores for the diary. My parents were so relieved after 20 years of dairying that they decided to pay me. Yes, I was an 11-year old with a checkbook, buying most of my own clothes and treating myself to a go-kart. Some of my older siblings thought I was being spoiled until my parents told them that I purchased those items with my own money. At the age of 13, I purchased my first herd of cattle which has continued to this day. From that point on I became quite independent, purchasing my own first truck and customizing it like a real Cowboy Cadillac. The cattle herd has progressed to the point where my wife Sherrie and I have many cows. She raises black white face (Angus/Hereford cross) cows and I still raise Angus. How many do we have? Too many to count. In 1995, I purchased the family farm from my mother and have continued with that tradition.

Growing up on a farm, particularly a dairy, gave me a different perspective on work. On the farm in general, whenever there was work to be done, we did it. Even if that meant working into the night. A dairy is 5 and 5 every day with no days off. The weather didn't matter. If it was storming or if there was a blizzard, we still had to go get the cows and milk. There was no TGIF, weekends, or holidays. Pretty much every day was the same. That is why now I will get up in the morning, do my chores, go to the office, and then come home and do more work on the ranch. A friend once asked me if I always worked on weekends and I said "yes, I do because it's just another day to me". Work ethic is one thing but having integrity and being a man of your word is another. In a farming community I saw what happened to people that didn't keep their word with others. They were criticized, rejected, and lost respect. I learned early on that I did not want that to happen to me, so I will always try to be a man of my word.

Speaking of Sherrie, we met at a local hangout called the White Grill. She was only one grade ahead of me, but I never remembered seeing her during all our school years. I still don't know how that happened as we went to the same grade school, middle school and high school. When I first saw her, I thought maybe she was a new girl or just visiting a friend but no, she had been around the whole time. How was it I had missed this beautiful girl? Being raised a cowboy, she thought at first that I was "too cocky" for her, but I guess I grew on her, and we started to date for almost 6 years and eventually wed in 1986. We have 2 adult children, Spenser and Audrey.

I am often asked how I became interested in psychology. Here's the story. While I began farming at an early age and was fairly certain that is what I wanted to do, several things changed along the way. First, the great farm crisis of the late 70s occurred which made farming less profitable and then, after having a dairy for 26 years, my parents decided to sale out and focus on row crops and beef cattle. So, that sent me looking for work. Being a small town that I grew up in, the first thing you do is tell everyone you know you are looking for a job. It wasn't long before I received a call from a friend of mine who knew that I had grown up around horses and asked if I would be interested in working with the Equestrian Therapy program at Heartland Hospital which is a child and adolescent psychiatric hospital in Nevada, MO. I said" yes" thinking I would be working mostly with horses which was the case, but it also placed me in direct interactions with patients. My interest in psychiatric work grew and then, when one day faced with budget cuts in the horse barn, I was invited to work on the residential unit in the hospital where my interest really grew in psychology. After working with psychiatrists, psychologists, and social workers for some time, I decided that psychology was the field for me. I admired the work psychologists did in individual and group therapy, but I also was intrigued by their ability to evaluate with psychological testing and their superiority in diagnosis. I started attending college and graduated from Park College in Parksville, MO with a Bachelor's Degree with Distinction in Social Psychology in 1992. I was then accepted and began attending a private clinical psychology program at Forest Institute of Professional Psychology in Springfield where I graduated with a Master's Degree in Clinical Psychology in 1995 and a Doctorate in Clinical Psychology (Psy.D.) in 1998. Before this, at the age of 24 I began my first administrative position and directed various in-patient hospital-based programs and out-patient clinics. I also did consultation and specialized in program development and revitalization. In the industry I became known as a build it and fix it man. While attending college, my work was more in administration. Actually, a little bit before graduation in March 1998, I opened my own private practice in Fort Scott, KS and named the clinic Choices Psychological Services. I presently employ 4 other therapists in the clinic and have been blessed with a continuously full schedule and a regional presence for 26 years.

My Masonic career began in 1993 when I was initiated as an Entered Apprentice. This was still a time where I had to give back my proficiency. Since I was still attending college and had entered graduate school during this time, it took me until 1995 to complete my Master Mason proficiency. Like many, instead of being seated among the Brethren after being raised, I was escorted to the Senior Steward's chair where I began my ascension through the chairs, becoming Worshipful Master in 2000. Shortly after being raised in Osage Lodge No. 303, I joined Scottish Rite Valley of Fort Scott, Mirza Shrine Temple in Pittsburg, KS, Nevada Chapter No. 56, Carthage Council No. 41, and O'Sullivan Commandery No. 15. I now also belong to Nevada Council No. 65 and Scottish Rite Valley of Joplin. Other Masonic memberships include St. Andrew's Conclave Knights of the Red Cross of Constatine, Memorial Council No. 420 Allied Masonic Degrees, Missouri Priory No. 17 Knights of the York Cross of Honour, Cell Airne No. 76 Council of Knight Masons, Ray V. Denslow York Rite College No. 180, Order of the Easter Star Nevada Chapter No. 53 dual with Jerico Springs Chapter No. 456, House of Lords Tabernacle No. 72 Holy Royal Arch Knight Templar Priest, Royal Order of Scotland, Commerative Order of St. Thomas of Acon William R. Probst Chapel No. 106, Ye Antiente Order of Corks, Masonic Order of Bath, Sword of Bunker Hill, Masonic Order of Athelstan - Court of Discovery No. 80, Masonic Societas Rosicruciana in Civitatibus Foederatis - Missouri College, Royal Order - Masonic Knights of the Scarlet Cord, Sovereign Order of Knights of the Preceptors, Grand College of Rites, and Missouri Lodge of Research. I am a past Regional Grand Commander, Past Deputy District Grand High Priest, Past Regional Deputy Grand Master, and Past Distict Deputy Grand Master. Recipient of Grand Chapter of Royal Arch Masons Lewis and Clark Award and Grand Commandery of Knights Templar Lewis and Clark Award.

I attended all seven of the York Rite Conferences. I found them helpful for staying in touch with members and a good way to share information. There are some really good ideas floating around out there that we need to learn how to share in a timelier manner.

I had the distinct pleasure of being invited to the Joe B. Lewis Grand Cryptic Council Annual Assembly Prince Hall Affiliates in St. Louis. I found the hospitality there to be unrivaled. I really enjoyed meeting many new Companions and learning about Prince Hall Masonry. I had the honor of receiving a handmade stained glass Cryptic Mason emblem from MIC Dr. Lee Hill. I will always cherish this one-of-a-kind gift from a fellow Companion and Grand Master.

The 2023-2024 York Rite Masonic Year started with a newly elected Grand Treasurer. That Companion was PGC Russell Hanson. I am convinced that PGC Hanson was the only Companion that could have reconstructed and restructured the Grand York Rite finances. Russell has worked many long hours over the past

year on this mission. Many of you might not know it but actually, Russell, PGC Harold Coots, and PGC Michael Rohman had been working on the finances even prior to the Grand Sessions last year. Not only Russell's expertise but also his relationship with our previous Grand Treasurer Donald Trabue was essential to getting our finances back in order. Thank you to these Companions for their efforts in rehabilitating our finances. We certainly owe them a debt of gratitude, especially PGC Russell Hanson. We now have a sound, well-grounded budget going into the 2024-2025 year and are in a place where we can plan for our future. Now that our finances are very close to being solidified, we can begin financial planning for the future. Companion Terry Coppotelli has developed our new investment policy that will hopefully be approved during this year's Grand Sessions and we can become even more financially secure in the future.

The highlight of the year was definitely the Triennial in Branson. It was an honor and a privilege to open for the General Grand Council during the Triennial. That was a once in a lifetime opportunity that is not likely to occur again. Thank you to Most Puissant Grand Master William G. Snyder for that opportunity. I was proud of the Grand Council Officers who attended and assisted in opening the General Grand Council. I can now say that I opened for the World! Shortly after the Triennial, I attended the South Central Conference also in Branson and networked with other States in our Conference. Subsequently, I attended all of the Grand Sessions in our South Central York Rite Conference including Texas, Louisiana, Arkansas, Oklahoma, and Kansas. I would recommend that all future Grand Masters also attend these conferences and maintain relationships with these states. There were always things to be learned by visiting other jurisdictions.

The Three Amigos began working together long before our years started. One of our projects we developed was the new Retention by-law. I came up with the idea after observing suspensions being made in various Masonic bodies without contacting the member. Thanks to my other two Amigos, we developed and refined the new by-law which I am very proud of. As of April 15, there have been only 4 suspensions this year in the Council versus 62 last year which is a significant reduction. What is more important is the spirit of the new Retention by-law. That spirit is making personal contact and having a relationship with our Companions whom we have not seen for a while and encouraging them to attend again. It is also a process where each Council might find out more about themselves and the relationships they have with their members. For example, we all need to work on quality improvement if we expect members to desire attending our Councils. There is always room for improvement. We need to engage our members and get them involved in our Councils. Historically, the York Rite was sought after by some but now we must move to a program of promotion and solicitation in order to stay viable. I attended one Council this year that two members who usually attend were not there and the rest of the members knew where they were at and exactly why they were not there. I attended another Council and two officers were not present and the other members did not know where they were or why they did not attend. I realize this can be a two-way street but we need to have a much more personal relationship with our members, especially our new members.

Membership this year has stabilized due to the reduction of suspensions by 94% but also by the 72 new members who were greeted this year. Membership should continue to be a priority for all Councils. Rolla Council No. 39 led the pack this year with 15 new members! Rolla has developed a very successful membership campaign that continues to yield new members. I would recommend this program being shared with the rest of the state this next year, preferably via video that can be shared in the future as well. Other Councils at the top of the list for new members include John F. Houston Council No. 42 with 8, Zabud Council No. 25 with 7, Neosho Council No. 46 with 6, and Independence Council No. 49 and Nevada Council No. 65 both with 5 new members. Congratulations to these Councils on their gains! I would recommend to next year's Membership Committees that they work together in all three York Rite Bodies but also build on what Rolla and others have done and develop a standardized membership program. The Grand Master's Invitational program has proven to be successful, but this remains a passive program as it relies on attraction. We can however utilize this program as part of a membership promotion for the York Rite.

Brand new for this year was the development of a digital magazine named the Missouri York Rite Beacon. This year's Publications Committee has done an excellent job of producing a quality publication. We should all be proud of their work! Special mention VEC Larry Wilson for his hard work and dedication which has been very appreciated. Thank you to the rest of the Publications Committee and all who contributed articles for the Beacon.

Cryptic Masons Medical Research Foundation (CMMRF) has continued to flourish. CMMRF has been an interest of mine since being appointed to the Grand Council line. In 2017, I initiated CMMRF month annually in March that has proven to be beneficial for raising awareness and overall donations. In 2020, Missouri rose to the level of 12th in the nation and we have been in the top ten in the nation for donations since 2021. Thank you to all of the Companions statewide for their donations to this amazing charity. I am proud to be a part of an organization that has adopted such a great cause as CMMRF. A special thanks goes out to VIC Corey B. Huntsucker who started the very successful Purple Gala in Kansas City in 2023. The 2nd Annual Purple Gala was held this year in March, again with much success. Several Companions in the Springfield area also held their first Purple Gala, also with success. VIC Huntsucker was able to arrange for the Endowed Chair at Indiana Center for Vascular Biology and Medicine Dr. Michael P. Murphy to present his research findings at the Kansas City Purple Gala again this year which was simulcasted to Springfield during their Purple Gala. I am issuing a challenge to the rest of the Councils in the State to organize their own Purple Gala, particularly those Councils in the eastern and central part of the State. At minimum, all Councils should at least hold a Table Council during CMMRF month to further increase our donations. Table Councils have also been proven to be successful.

Another exciting thing that happened this year was the opening of a new Council which had not happened for several years. The new Council was Nevada Council No. 65 which just so happens to be my Council. I was able to preside over that Council while at the same time serving as Grand Master. Yes, this was despite the best efforts of the Grand Commander Kevin B. Sample who searched long and hard for a by-law that prevented this from happening. Nevertheless, I was honored to not only be a charter member for Nevada Council No. 65 but also the very first Illustrious Master. Thank you to MIC Michael S. Smith for approving our new Council during his year but also presiding over the consecration of it.

Of great importance is our Youth Programs including DeMolay, Jobs Daughters, and Rainbow. There is much room for improvement with supporting our Missouri Youth Programs. We need to increase our financial contributions, but I am encouraging all Companions to seek out and get involved in their local Youth Programs. Our donation of time would be much recommended and appreciated. I have heard many Companions say that they did not have a Youth Program in their respective area. In this case, I would recommend reaching out to programs close to you, developing a new program in your area, and/or getting involved with other Youth Programs in your area such as Boy Scouts, FFA, 4-H, and others. We could all benefit from assisting youth and becoming more involved in our communities.

Recommendations:

- 1. Membership should continue to be a priority. I would recommend that the Membership Committees from all 3 York Rite bodies meet monthly and develop programs to enhance our membership. The Grand Master's Invitational has been successful and should continue. This program has also seemed to strengthen our connections with the Grand Lodge. Of course, our candidates for York Rite can be found in our Blue Lodges but we must go further than this and assist in recruiting members to our Blue Lodges as well.
- 2. In healthcare, we always have quality assurance goals which are designed to promote constant improvement. When I think about membership, I automatically think about how to retain that membership. We must provide a quality product for our members in order to retain them, increase their involvement, and encourage them in turn to bring in other new members.
- 3. I recommend that we continue to increase our charitable donations to CMMRF. Much progress has been made in this area. I would like to see other areas such as the eastern and central parts of the State initiate Purple Galas. I would recommend that all Councils that are not participating in a Purple Gala, at minimum, hold a Table Council to raise funds for CMMRF. I thoroughly enjoy the fraternal aspect of our organization, but I am very proud of our Charity. In accordance with this recommendation, I am hereby issuing a challenge to all Grand Masters who follow to donate a minimum of \$1000.00 to CMMRF during their year.
- 4. We are very close to having a clear picture of our financial situation. Next year's budget is well founded and based on actual financial principles. It will be important to approve the new investment policy, identify excess funds, and ensure those funds are invested post-haste.

- 5. The Three Amigos theme and goal for this year was Unity. Unity is not only reserved for the three York Rite bodies but also for other Masonic bodies as well. Unity should also be extended to our Companions in the South Central Conference and other neighboring States. We need to acknowledge that we are much more interdependent that what we may realize.
- 6. I would recommend that all future Grand Masters continue to attend the South Central Conference Grand Sessions. Along those lines, when the Triennial occurs, the Grand Master at the time should attend and participate in that as well. It is important to continue networking and maintaining those relationships that have been established.
- 7. Finally, to anyone considering making themselves available for election to the Grand Council line, I would recommend having a fresh horse and a saddle bag full of gold.

PRELIMINARY REPORT OF THE GRAND TREASURER

June 1, 2023 through April 30, 2024

Our first year with your new Grand Treasurer has been very challenging. I refer you to the Missouri Grand York Rite Financial Report and the three Missouri Grand York Rite Financial Accounts Detail Reports for the record of where we started and where we are now. These documents are hereby incorporated into this report by reference. We still have more work to do in this next year in order to resolve all of the remaining issues.

Grand Council Clerical Assistant

This year I moved paying Lady Debbie Hanson from monthly to quarterly in order to better align with the demands of reporting our Employee to the State and Federal Governments as well as making the requisite deposits/contributions.

I have established my credentials as the Grand Treasurer of the Grand York Rite of Missouri and authorized employer representative with the IRS. I have gained access to the Federal EFTPS.gov web portal.

The IRS 941 Employer's Quarterly Federal Tax Return forms for the four quarters of calendar year 2023 have been filed and all deposits made for Social Security, Medicare, and Federal Withholding Tax using the EFTPS portal. Included in those deposits were both the Employee and Employer monetary portions. In addition, the IRS 940 Employer's Annual Federal Unemployment (FUTA) Tax Return form for calendar year 2023 has been filed and the deposit made.

The IRS 941 Employer's Quarterly Federal Tax Return forms for the first calendar quarter of 2024 has been filed and the deposit made for Social Security, Medicare, and Federal Withholding Tax using the EFTPS portal. Included in that deposit was both the Employee and Employer monetary portions.

I have established my credentials with several State agencies as the Grand Treasurer of the Grand York Rite of Missouri and authorized employer representative.

In June 2023, I reactivated our account with the Missouri Division of Employment Security (DES) and gained access to the DES uinteract.labor.mo.gov web portal. I have been filing the required quarterly unemployment insurance reports and paid the required contributions using the web portal.

I have also gained access to the Missouri Department of Revenue's (DOR) mytax.mo.gov web portal. I have filed the DOR MO-941 Employer's Return of Income Taxes Withheld for calendar year 2023 and paid the withholding tax, additions, interest, and processing fee using the web portal.

The 2023 W-2 Wage and Tax Statement for Lady Hanson and the 2023 W-3 Transmittal of Wage and Tax Statements were filed and accepted by the IRS.

Grand Council IRS Tax Status

I have established my credentials with the IRS as the Grand Treasurer of the Grand Council and the Grand Treasurer of the Missouri Grand York Rite. I applied for and received a verification letter from the IRS confirming the Grand Council Employer Identification Number (EIN). I applied for and received a verification letter from the IRS confirming the Missouri Grand York Rite Employer Identification Number (EIN). These letters are required in order to establish business bank accounts in Missouri.

During the process of obtaining the verification letters, I was informed by the IRS that the Grand Council tax exempt status had been revoked due to failure to file IRS 990 Return of Organization Exempt From Income Tax forms for more than three years. I was told that we would need to complete and file an IRS 1024 Application for Recognition of Exemption form. I was informed that the processing cost was \$600.00 and that processing took six months. I am working on the IRS 1024 form for the Grand Chapter to learn how to complete the form. However, the financial state of the Grand Council will need to be determined before get to Part V - Financial Data.

The Grand York Rite of Missouri IRS Form 990-N (e-Postcard) for the tax year ending March 31, 2024, was successfully filed and accepted by the IRS.

Grand Council Missouri Certificate of Incorporation

The Grand Council has a Certificate of Incorporation with the Missouri Office of the Secretary of State, which Articles, in all respects, comply with the requirements of Missouri Nonprofit Corporation Law. In addition, the Missouri Grand York Rite has a Certificate of Incorporation with the Missouri Office of the Secretary of State, which Articles, in all respects, comply with the requirements of Missouri Nonprofit Corporation Law. These certificates are required in oder to establish business bank accounts in Missouri.

I filed the 2023 Annual Registration Reports for a Domestic Nonprofit Corporation for the Grand Council and the Missouri Grand York Rite, and paid the required registration and processing fees. The reports were accepted by the Missouri Secretary of State's Office.

Grand Treasurer's Office


Your Grand Treasurer has worked diligently to bring transparency to the office. I attended all of the Grand Council Grand Officer Zoom meetings. During those meetings, I provided requested financial review briefings to the Grand Officers and answered questions that the Grand Officers asked concerning the finances of the Grand Council. In addition, I provided the Grand Master and the Chairman of Finance and Accounts with weekly reports on the work of the Grand Treasurer. Beginning in December 2023, I provided detailed reports on the financial status of the Missouri Grand York Rite to the Grand Master, the Chairman of Finance and Accounts, and the Chairman of Investments. Many of the recommendations and actions concerning changes to the financial plan of the Missouri Grand York Rite are documented in the separate Missouri Grand York Rite Financial Report incorporated herein by reference.

The Grand Treasurer's Office has received thirteen banker boxes of historical paper records from the office of the previous Grand Treasurer through the efforts of Companion and Sir Knight Harold F. Coots, PGC. I cannot adequately express my appreciation for the extraordinary patience and perseverance exhibited by Harold in wading through the process of providing these records. I also thank Lady Elsie Trabue for working with Harold to sort out the previous Grand Treasurer's office. In addition, the efforts of Harold, Elsie, and Tom Trabue (one of Don's sons) have provided approximately 290 GB of historical electronic records.

In addition, the Grand Council and Missouri Grand York Rite check books were transferred to the office. The task of reviewing the mountain of documents is daunting. However, I hope to begin the process of scanning the important documents into electronic files for storage and future reference during the coming year.

REPORT OF THE GRAND RECORDER

To the Grand Council of Cryptic Masons of the State of Missouri,

Companions, following this narrative you will find the statistical reports of the Grand Secretary's office. The statistical reports provide much institutional information as to the overall financial and physical health of the subordinate Councils of the Grand Council of Missouri

- **Annual Returns Late**: As of the time of this report, the following Councils filed late returns and were assessed penalties: Poplar Bluff Council No. 27.
- **Annual Returns No Return**: As of the date of this report, the following Councils have not filed a return and will be assessed penalties: Bert S. Lee Council No. 58.
- Annual Returns Not Received thirty days prior to Annual Assembly: As of the date of this report, the following Councils filed an annual return, but not later than thirty (30) days prior to the Annual Convocation, has forfeited all rights and privileges to representation and voting at the Annual Convocation, and will be assessed penalties: York Council No, 40; and Bert S. Lee Council No. 58. Given extraordinary circumstances the Grand Master has issued a Dispensation to allow York Council No. 40 to allow their representation and voting privileges to be restored.
- **Annual Returns Financial Statements**: The following Councils either failed to submit or filed an incomplete Financial Statement: None.
- Annual Returns CMMR and CEF Donations (according to the annual returns): The following Councils reported no contributions to CMMR: John F. Houston Council No. 42; Bonne Terre Council No. 43; Neosho Council No. 46; Trinity Council No. 47; Lebanon Council No. 56; In contrast, for CMMR, the following Councils were able to meet the goal of at least \$3.65 per member: Hiram Council No. 1; Cape Council No. 20; York Council No. 40; Kirksville Council No. 44; Jeremiah Council No. 48; and Independence Council No. 49; Nevada Council No. 65 got close with \$3.50 per member. Hiram Council No. 1 exceeded the goal with \$5.77 per member; Cape Council No. 20 with \$4.91 per member; Independence Council No. 49 with \$10.75 per member and Jeremiah Council No. 48 knocked it out of the park with \$66.54 per member. No other Council met the \$3.65 per member goal. For the Grand Council Charity Endowment Fund (CEF), the following Councils reported no contributions to CEF: Cape Council No. 20; Shekinah Council No. 24; Jasper Council No. 30; Ezra Council No. 32; John F. Houston Council No. 42; Bonne Terre Council No. 43; Kirksville Council No. 44; Neosho Council No. 46; Trinity Council No. 47; Liberty Council No. 50; Lebanon Council No. 56; Bert S. Lee No. 58; Shelby Council No. 59; and Nevada Council No. 65. Only one Council was able to meet the goal of at least \$3.65 per member: York Council No. 40 with \$5.69 per member; and Hiram Council No. 1 coming really close at \$3.62 per member. Other Councils reported contributions: St. Joseph Council No. 9; Zabud Council No. 25, Poplar Bluff Council No. 27, Centralia Council No. 34, Rolla Council No. 39, Carthage Council No. 41; Kansas City Council No. 45; Jeremiah Council No. 48, and Independence Council No. 49.
- Annual Returns Bonding: The following Councils reported that the Treasurer and Recorder ARE bonded: St. Joseph Council No. 9; Zabud Council No. 25; Centralia Council No. 34; Bonne Terre Council No. 43; Trinity Council No. 47; Independence Council No. 49; and Liberty Council No. 50; Although there is no requirement by law that bonds be established, there is a necessity of ensuring the organizational officers who are responsible for your financial health are bonded.
- Annual Returns Inquiries and Examination of Accounts (Financial Reviews): The following Councils did not file an Inquiry and Examination of Accounts as part of their Annual Return or if they did file an Inquiry and Examination of Accounts, it was incomplete: Kirksville Council No. 44.
- **Annual Return Seal Impressions** Article VI, Section 46. Council, Seal of. states "Every chartered Council must have a seal, and all official papers issued by the Council must be attested by impression of the same." St. Joseph Council No. 9 did not provide seal impression.
- **Annual Returns Signatories**: The following Councils report that there is not more than one signatory on the accounts of the Council: None.

- **Annual Returns Dues**: The following Councils reported dues charged each member to be less than that required by Grand Council (\$37.60): None.
- **Annual Returns 990 Status**: The following Councils did not file evidence of a completed 990 filing: Hiram Council No. 1; Trinity Council No. 47; Jeremiah Council No. 48; and Nevada Council No. 65.
- **Annual Returns** Council Indebtedness: The following Councils reported a negative cash on hand as of December 31, 2022: None.
- **Annual Returns Summary**: I recommend these reports be reviewed by both Grand Officers and Regional Officers for additional action.
- **Growth Awards**: There were a whopping 87 Greetings during the 2023 calendar year, with an additional 23 reinstatements what an amazing year! Grand Council Growth Awards for 5% will be presented to Neosho Council No. 46 (5%); Nevada Council No. 65 (5%); Kansas City Council No. 45 (7%); and the largest growth goes to Poplar Bluff Council No. 27 (10%). In the calendar year the Grand Council started out with 1,518 members and closed on December 31, 2023 with 1,431 members. With 110 gains in new members and reinstatements, we lost 62 to demits; 75 suspended; and 60 to death.

Companions, First, allow me to thank those who work with diligence and efficiency to make the Grand York Rite work, with attentiveness and thoughtfulness in all that they do. I thank Debbie for her patience and hard work throughout the year, to Kevin for his guidance and input, to Roger for his collaboration, and to Russell to whom the three Grand Bodies owe a debt of gratitude in his work in deciphering and re-architecting the finances of all three Grand York Rite Bodies.

The amount of work that goes into planning a Grand Session can be daunting but the tireless combined efforts of the Three Amigos, Debbie, Kevin, Roger, Tina, Tara, the first ladies Tina, Sherrie, and Chris have pulled together an outstanding Grand Session this year - thank you!

This is our 2nd year meeting in Springfield and it is our goal not to hold the Grand Sessions more than two consecutive years in the same location. We will continue to scout new locations around the State and continue to present the Grand York Rite Sessions as a celebration of the Missouri York Rite. There is a distinct possibility that the future may bring the need for a registration fee to help defray the costs of the Annual Assembly. We hope it does not become necessary, but we should all be aware that it may be needed.

I recommend to all to review the statistical reports of our Chapters, they provide an accurate overview on the overview health of the Royal Arch in Missouri.

As the need to offer more and integrated digital service the need to add additional talent is necessary. If there are those who are professionally experienced in WordPress, design, and social media please reach out to me, we will put your skills and experience to work.

To the Grand Council of Cryptic Masons of the State of Missouri,

Companions, the Committee on Finance and Accounts has reviewed the Grand Council budgets and actuals from recent years and used that to inform the creation of the working budget for the 2024-2025 Cryptic year. The committee has reviewed each line item, and asked many questions of the Grand Recorder, Grand Treasurer, etc. The committee acknowledges that the Grand Officers and Grand Office does have to spend money in order to continue to operate in support of Cryptic Masonry in our jurisdiction.

Key notes to be aware of, due to the realignment of accounts/funds with the new Grand Treasurer and the pending Investment Policy acceptance, we are unable to estimate investment income – we have left these at zero however, we understand they will not be zero in the year's recapitulation which will be reported next year. Additionally, the cost of the annual assembly continues to increase – we have adjusted the anticipated cost to cover that expense. Even though the proposed budget below shows a deficit, we anticipate it will be closer to zero at the end of the year.

After reviewing our investments, income, and expenses it is clear that it is again time for us to increase our per capita to stay ahead of the effects of decreasing membership and inflation.

REPORTS OF SPECIAL COMMITTEES REPORT OF THE FINANCIAL EXAMINERS COMMITTEE

To the Grand Council Cryptic Masons of the State of Missouri,

The past several years have been challenging ones for the Financial Review committee. In the past, the committee had requested certain reports concerning the reconciliation and copies of various account statements to try to verify and confirm balances in checking accounts, money markets, investments held at various financial institutions and any other assets and investments held in the name of the Grand Council of Cryptic Masons of the State of Missouri but were not able to receive them. Therefore, last years report stated that we could not determine if the balances and activity of those financial reports were accurate. Since that time, a new Grand Treasurer has been appointed/elected and numerous individuals have been instrumental in investigating, locating and identifying funds for which there were confusing or insufficient records available. The committee has been given access to the dropbox account where all financial transactions of the Cryptic Council are archived and recorded.

The process developed by the previous Grand Recorder and Grand Treasurer is extremely detailed and still is in use today. All warrants issued, invoices received, monies received, and invoices paid are scanned and made a part of the record. The budgets and proceedings appear to have been checked by the office staff and the heads of the bodies to make sure they were properly authorized. Bank statements are regularly reconciled. Outstanding checks and monies received but not yet deposited are shown on the reconciliation of the General Ledger, Income and Expense statements and the bank statements. The committee finds that the York Rite office staff properly notated receipt of checks and properly notated on their records the sources and gave credit to the various bodies, issued warrants when payables were due to be paid and in all other respects did their job in a professional and efficient way. They are to be commended for their continued dedication and loyalty.

The Grand Council officers who compose this committee have been given unfettered access to the records and attendance at the regular Zoom financial meetings conducted by the Grand Recorder, Grand Treasurer and Assistant Grand Recorder on a monthly basis. Opportunity to ask questions concerning the detailed financial transactions are given to all participants to discussed in these meetings and any concerns or questions may be expressed by anyone on this meeting. Based on this and the results of the sample transactions traced during the examination of the records in the Dropbox account where these records are archived, the committee can express confidence that the Income and Expense as well as the budget and balance sheets reflect the financial position of the Grand Council of Cryptic Masons for the current year as far as known balances are revealed.

As has been mentioned in previous reports by this committee and by previous reports of other committees along with committee reports in this preliminary proceedings report, there have been recommendations made to try to strengthen the safety and security of our recordkeeping and ensure the proper management of the recordkeeping and accounting integrity. Some previous recommendations are "in progress" or in other ways being addressed. Others are not.

Recommendations:

- 1. That a "final" Treasures financial report be issued as of the close of the fiscal year and distributed to appropriate individuals and committees. Since the preliminary report published for the Grand York Rite session usually is an interim report due to the timing of statements and reconciliation, there is a gap between what was shown as ending balances in the interim report and the previous years beginning balance. It can be difficult to account for the difference in the preliminary report ending balance and the beginning balance for the next year.
- 2. Part of the Grand Treasurer's responsibility should be to make regular reports concerning annual registrations and filings for State and Federal authorities to the Grand Master, the Financial Review Committee and the Grand Recorder and also be included in his annual report.

- 3. That no monies be comingled. Great strides have been made in correcting this deficiency. "Restricted use" funds are properly segregated and are separately counted.
- 4. In light of a recent (within the last year) transfer of responsibilities, we recommend that an outside audit be performed by an auditing company. This would be for the sake of transparency, protection of the outgoing Treasurer, protection of the Incoming Treasurer, protection of staff personnel and to review any other weaknesses in our accounting system.

In conclusion, in conversations with the heads of the bodies and the Grand Recorder and Grand Treasurer, the committee is satisfied with the progress made in developing internal controls and, when approved, an investment policy that will greatly enhance the safety and transparency of our accounting system. We are optimistic that continued improvements will be accomplished shortly.

The committee would like to thank our Most Illustrious Grand Master for the opportunity to serve in this capacity for his year. There are several other individuals that should be commended for their assistance in gathering information to advance the progress of improving our procedures and identifying assets. It has been a pleasure to serve Most Illustrious Companion Dr. Paul Lee Daniels, and the Companions of the Grand Council of Cryptic Masons of the State of Missouri.

The Cryptic Masons Medical Research Foundation donations are growing in the state of Missouri. 2023 saw an increase in Missouri's contributions by over \$7,000, \$6,500 of that coming from the 2023 Purple Gala hosted by Shekinah Council No. 24 in Kansas City. This increase moved our place in Cryptic Masons International donations from tenth to eighth place. Only \$243 out of seventh place. We'll top that this year.

In 2024, the Purple Gala was held in Kansas City by Shekinah Council No. 24, and Springfield, MO by Zabud Council No. 25. Zabud Council had a successful inaugural event. This researcher did her research in an area that is being funded by CMMRF at the Indiana

Center for Vascular Biology and Medicine on the effects of chemotherapy on the heart muscles. A connection was made because a chance was taken to invite someone we did not know. A connection like this can prove to be beneficial for contributions to CMMRF, ICVBM's research, and increasing awareness of their work.

Table Councils are beginning to spread their impact around the state and have seen an increase in attendance and donations. Again, invitations to the table councils need to go out to surrounding physicians, researchers, family, friends, and philanthropists. If you need ideas on who to invite please contact the committee. REPORT OF THE COMMITTEE ON CRYPTIC EDUCATION

To the Grand Council of Cryptic Masons of the State of Missouri,

The Education Committee has been actively engaged in second Phase of the three (3) Phase program (Phase I) Year one – Critically and deliberately review and re-define the Committee's purpose and identify potential programs of interest for development, retention and restoration.

- 1. (Phase II) Year two Outline, draft and propose the newly developed, retained and restored programs of interest and present an execution plan of action to the Grand Master, Grand Council Officers and Grand York Rite leaders.
- 2. (Phase III) Year three Roll out, promote and execute the programs selected and developed by the Education Committee in accordance with the proposed plan of action and the execution timeline and model.

Emphasis has been placed on two (2) Programs in particular: (1) Grand Council Merit Award & (2) the York Rite Regional and Leadership Conference(s)

Grand Council Merit Award

This Committee reviewed the previous version(s) of the annual merit award and compared the current version against various Masonic organizations. As a result, the Committee presented for consideration a completely updated and revamped Grand Council Merit Award. The content, substance and format of the award has been presented for consideration.

York Rite Conference Purpose, Structure and Content

This Committee has taken upon itself the responsibility of chairing and championing a revision to the current York Rite Conference structure. Over the course of this year, the Committee has examined the intended, perceived and actual purpose of the Regional York Rite Conferences and has identified a clear misalignment between these three presented purpose constructs. Further, the Committee has examined the attendance of the Regional York

Rite Conferences (both numerical attendance and participation and the substantive attendance (Officers, Grand Officers, new members, etc.)). Through this examination, the Committee has determined that both the numerical and substantive attendance at the Regional York Rite Conferences, under their current structure, are failing to meet their intended, perceived and actual purpose constructs. Finally, the Committee has examined the content and consistency of the presentation material provided during the several Regional York Rite Conferences held throughout the year. From this review, the Committee has determined: (1) a lack of consistency and uniformity in the presentation materials and Conference structure; (2) a lack of substantive familiarity with the required/recommended presentation material and (3) a lack of training and guidance of the Regional representatives concerning their responsibility to plan, host and execute a regional conference.

Because of this, the Committee has chosen to: (1) re-examine the viability and purpose of the current Regional York Rite Conference program; (2) determine alternatives for the Regional York Rite Conference program and assess whether these alternatives better align its intended, perceived and actual purposes and (3) present its findings, alternatives and recommendations to each of the Grand York Rite bodies and Officers, as well as a timeline and a proposed plan of action to implement the proposed findings, alternatives and recommendations.

Virtual Education Program – Masonic & Leadership Education

The Education Committee has taken inventory of some of the most successful, well attended and well-received virtual education programs and we have identified the opportunity to leverage a similar framework within the Grand Council and Grand York Rite of Missouri. The virtual education program will be presented on a consistent basis throughout the year (monthly, bimonthly or quarterly). The structure of the virtual education series will be sessions featuring a live interactive format, but will be recorded for subsequent on-demand viewership. The content of the virtual education series will contain both Masonic Education and Leadership and Development material. This dual-layered program is intended to provide Missouri Freemasons the opportunity to learn and develop both within the sphere of traditional and esoteric Freemasonry and within the operational and leadership sphere. This wholistic approach to education will, within our estimation, distinguish us from any other program currently offered and will provide Missouri Freemasons with a first-class educational opportunity on an accessible and convenient virtual platform.

Conclusion

The Education Committee is excited about the opportunity to serve this Grand Council, The Grand York Rite of Missouri and Missouri Freemasonry and is actively engaging in the review of potential programs of interest to support the purpose of this Committee and the growth and development of this Committee.

REPORT OF COMMITTEE ON INVESTMENTS

To the Grand Council of Cryptic Masons of the State of Missouri,

PRELIMINARY/FINAL REPORTS ANALYSIS

Since the formation of the Investment Committee, its' previous year's reports put forth recommendations regarding: the Report of the Treasurer; legislation surrounding the allocation of surplus funds; and who has that responsibility to allocate said funds; and modernization of the current investment practice. Many of these recommendations have been acted on by the presiding body, and this year we again submit four pieces of legislation for action.

We are pleased to say that for the first time in the history of the York Rite, there has been a stand-alone Investment Policy created to allow the ability to allocate funds as the financial markets may warrant, not by a preconceived cookie cutter approach.

Also, for the first time, we have had the opportunity to speak with the Financial Advisor managing our funds. The good news is (with one small exception), all our mutual funds were placed in one fund family which provides us not only with discounted sales charges (if any), but also allows us the ability to move from one fund to another without any additional charges. Additionally, since we are so close to being able to take steps to balance our portfolio the decision was made to temporarily "pause" the automatic renewal of Certificates of Deposits. That is not to say the money may not end up there. It just made no sense to auto renew into a CD and be locked in for multiple years when we may have to take a liquidation penalty a few weeks later to allocate somewhere else. The great news is this money is currently sitting in Money Market accounts, whose rates currently are particularly good.

Several years ago, issues were identified with all our funds and their account placement in respect to the three York Rite bodies. Russell Hanson and several other companions have done an incredible job of tracing our funds to their original sources and placing them where they belong. This time consuming, tedious, and challenging work was done with excruciating detail (which is what was needed). Once the Finance and Account committee identifies the surplus funds, fixes the restricted bases, and turns the funds over to the Investment Committee for action, we can begin work.

It has been a pleasure for the Membership and Retention Committee to serve Most Excellent Companion Mark Alan Bean, Most Illustrious Companion Dr. Paul Lee Daniels, and Sir Knight Kevin Brian Sample, Right Eminent Grand Commander, and the Companions and Sir Knights of the Grand York Rite of the State of Missouri.

The Grand York Rite bodies saw a change in the Constitution and Bylaws and Laws and Regulations of the respective bodies. These changes mandate that each local and constituent York Rite body form a committee to investigate the reason for a member's delinquency and see if there is a way that we can retain them as members. The following determinations were made for the Council of Cryptic Masons during the 2023-2024 Year. These determinations are solely based on what I saw and are my own opinions. Any questions about this report should be brought to my attention.

On September 12th I conducted my official visit to Bonne Terre Council No. 43. With 7 Cryptic Mason's in attendance, we were able to open on the short form. The senior leadership made several recommendations on wanting to merge with Cape Council No. 20. I could tell there was no active recruiting being done and knew this was a problem. During this year they voted to merge with Cape Girardeau and Cape voted to accept them.

My recommendation is to rebuild Bonne Terre starting with the Chapter, and then move on rebuilding the Council and Commandery. New and younger leadership is needed in the area that are eager to learn and recruit. I have had several conversations with some of the Masons in the area. We will start that process on May 21st, 2024.

On October 12th I conducted my official visit to Poplar Bluff Council No. 27. With a total of 8 Cryptic Masons in attendance we were able to open on the short form. The attitude in Poplar Bluff was different than Farmington. They are eager to build and to learn the ritual. With the assistance of Bill Humble and Doug Rose, I see Poplar Bluff growing. It may take a while, but they are moving in the right direction. In the past 16 months we will have put on two festivals.

STATEMENT OF INVESTMENT POLICY, OBJECTIVES, AND GUIDELINES FOR THE GRAND COUNCIL OF CRYPTIC MASONS OF THE STATE OF MISSOURI

SCOPE OF THIS INVESTMENT POLICY

This statement of investment policy reflects the investment policy, objectives, and constraints of the Grand Council of Cryptic Masons of the State of Missouri, also referred to as the Grand Council.

PURPOSE OF THIS INVESTMENT POLICY STATEMENT

To outline a philosophy and attitude which will guide the investment management of the assets toward the desired results. It is intended to be sufficiently specific to be meaningful, yet flexible enough to be practical.

This statement of investment policy is set in order to:

- 1. Define and assign the responsibilities of all involved parties.
- 2. Establish a clear understanding of the investment goals and objectives of Fund assets.
- 3. Offer guidance and limitations to all *Investment Managers* regarding the investment of Fund assets.
- 4. Establish a basis for evaluating investment results.
- 5. Manage Fund assets according to prudent standards.
- 6. Establish the relevant investment horizon for which the Fund assets will be managed.

DELEGATION OF AUTHORITY

The Grand Council is a fiduciary and is responsible for directing and monitoring the investment management of assets. As such, the Grand Council is authorized to delegate certain responsibilities to professional experts in various fields. These include, but are not limited to:

- 1. **The Investment Committee**, as defined in the Grand Council Constitution and By-Laws, is charged with establishing investment policy, objectives, and guidelines; selecting investment managers; reviewing such managers over time; measuring and evaluating investment performance; and other tasks as deemed appropriate by the Grand Master.
- 2. **The Investment Manager** is a licensed Financial Advisor or company who will advise, and at the Investment Committees direction, purchase, sell, or hold the specific securities that will be used to meet the Fund's investment objectives. They may also perform regular accounting of all assets owned, purchased, or sold, as well as movement of assets into and out of the Fund accounts.
- 3. Additional specialists such as attorneys, accountants, auditors, actuaries, consultants, and others may be employed by the Grand Council to assist in meeting its responsibilities and obligations to administer Fund assets prudently. All expenses for such experts must be customary and reasonable and will be borne by the Fund as deemed appropriate and necessary.

The Grand Council will not reserve any control over investment decisions, with the exception of specific limitations described in these statements and in the Grand Council Constitution and By-Laws. Investment Managers will be held responsible and accountable to achieve the objectives herein stated. While it is not believed that the limitations will hamper investment managers, each manager should request modifications, which they deem appropriate.

DEFINITION OF RISK

The Grand Council realizes that there are many ways to define risk. It believes that any person or organization involved in the process of managing the Fund's assets understands how it defines risk so that the assets are managed in a manner consistent with the Fund's objectives and investment strategy as designed in this statement of investment policy. The Grand Council defines risk as:

High volatility (fluctuation) of investment returns and or loss of principal

LIQUIDITY

To minimize the possibility of a loss occasioned by the sale of a security forced by the need to meet a required payment, the Grand Council will periodically provide the Investment Committee an estimate of expected net cash flow. The Grand Council will notify the Investment Committee in a timely manner, to allow sufficient time to build up necessary liquid reserves.

FURTHER RESPONSIBILITIES OF THE INVESTMENT COMMITTEE

- 1. Assisting in the development and periodic review of investment policy.
- 2. Conducting investment manager searches.
- 3. Providing "due diligence", or research, on the Investment Manager(s).
- 4. Monitoring the performance of the Investment Manager(s) to provide the Grand Council with the ability to determine the progress toward the investment objectives.
- 5. Communicating matters of policy, manager research, and manager performance to the Grand Council.
- 6. Reviewing Fund investment history, historical capital markets performance and the contents of this investment policy statement to the Grand Council on a regular basis, at a minimum of once per year.

GENERAL INVESTMENT PRINCIPLES

- 1. Investments shall be made solely in the interest of the beneficiaries of the Fund.
- 2. The Fund shall be invested with the care, skill, prudence, and diligence under the circumstances then prevailing that a prudent man acting in like capacity and familiar with such matters would use in the investment of a fund of like character and with like aims.
- 3. Investment of the Fund shall be so diversified as to minimize the risk of large losses, unless under the circumstances it is clearly prudent not to do so.

INVESTMENT MANAGEMENT POLICY

- 1. Conservative Consistent with their respective investment styles and philosophies, investment managers should make reasonable efforts towards long term conservative growth while limiting volatility, understanding that losses may occur in individual securities.
- 2. Risk Aversion Understanding that risk is present in all types of securities and investment styles, the Grand Council recognizes that some risk is necessary to produce long-term investment results that are sufficient to meet the Fund's objectives. However, the investment managers are to make reasonable efforts to control risk and will be evaluated regularly to ensure that the risk assumed is commensurate with the given investment style and objectives.
- 3. Adherence to Investment Discipline Investment managers are expected to adhere to the investment management styles for which they were hired. Managers will be evaluated regularly for adherence to investment discipline.

GOAL OF THE GRAND COUNCIL

The goal of the Grand Council is to achieve a total rate of return sufficient to provide current distribution potential and to allow for the growth necessary to increase future distribution potential. The Grand Council recognizes that its funds exist to provide a perpetual resource of funds, and that its investment decisions should support that aim.

SPECIFIC INVESTMENT GOALS

Over the investment horizon established in this statement, it is the goal of the aggregate Fund assets to exceed:

An absolute rate of return after all distributions and expenses, equal to or greater than the rate of inflation as measured by the Consumer Price Index (CPI) plus 2%.

The investment goals above are the objectives of the aggregate Fund and are not meant to be imposed on each investment account arbitrarily. The goal of the investment manager, over the investment horizon, shall be to:

- 1. Meet or exceed the market index, selected and agreed upon by the Investment Committee that most closely corresponds to the particular Fund.
- 2. Display an overall level of risk in the portfolio which is consistent with the risk associated with the benchmark specified.

SPENDING POLICY

This Grand Council places the highest emphasis on meeting its obligations. As such, the Grand Council regards spending in dollar terms from year to year unpredictable. As spending is unpredictable, expected investment returns from "riskier" portfolios are not consistent and predictable. Therefore, in order to reduce the likelihood of underperformance and excessive deterioration of real principal during such periods an unexpected large expense may occur, some Funds may tend toward a more "conservative to moderate" investment strategy than might be the case if periodic large expenditures were not possible.

INVESTMENT OBJECTIVES

To meet its needs, the investment strategy of the Grand Council is to emphasize total return; that is, the aggregate return from capital appreciation and dividend and interest income.

Specifically, the primary objective in the investment management for Fund assets shall be:

Long-Term Growth of Capital -To emphasize long-term growth of principal while avoiding excessive risk. Short-term volatility may be tolerated in as much as it is consistent with the volatility of a comparable market index.

INVESTMENT GUIDELINES

Allowable Assets Assets chosen should be selected in such ways as such the Investment Committee, in its judgment, considers prudent, and adheres to sound business principles, while balancing the total return in accordance with the specific Council fund needs.

Prohibited Assets Prohibited Assets investments include, but are not limited to the following:

- 1. Annuities or Other Guaranteed Return Strategies
- 2. Commodities and Futures Contracts
- 3. Private Placements
- 4. Options
- 5. Limited Partnerships
- 6. Venture-Capital Investments
- 7. Real Estate Properties
- 8. Interest-Only (IO), Principal-Only (PO), and Residual Tranche CMOs
- 9. Cryptocurrency

Prohibited Transactions Prohibited transactions include, but are not limited to the following:

- 1. Short Selling
- 2. Margin Transactions

DEFINITIONS

- 1. "Fund" shall mean the investable assets of the Grand Council of Missouri deemed surplus. The term "Fund" is inclusive of the aggregation of all separate accounts under the control of the Investment Committee.
- 2. "Grand Council" shall refer to the governing board established to administer the Fund as specified by applicable ordinance.
- 3. "Fiduciary" shall mean any individual or group of individuals that exercise discretionary authority or control over fund management or any authority or control over management, disposition or administration of the Fund assets.
- 4. "Investment Manager" shall mean any individual or group of individuals, employed to manage the investments of all or part of the Fund assets.
- 5. "Securities" shall refer to the marketable investment securities, which are defined as acceptable in this statement.
- 6. "Investment Horizon" shall be the time period over which the investment objectives, as set forth in this statement, are expected to be met. The investment horizon for the Fund is 10 plus years.
